

## Notes to Financial Statements

For the Years Ended December 31, 2024 and 2023

### 1. DESCRIPTION OF THE PLAN

The following description of Stewart Stainless Supply, Inc., (the “Company”) 401(k) & Profit Sharing Plan (the “Plan”), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

- A. *General.* The Plan is a defined contribution plan covering all eligible employees of the Company. Employees must be 21 years of age with a minimum of 12 months service to be eligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).
- B. *Contributions.* Each year, participants may contribute up to 100% of pretax annual compensation as defined by the Plan, except that no employee may make annual tax-deferred contributions in excess of amounts provided by the Internal Revenue Code. Participants may also contribute amounts representing rollover distributions from other qualified plans. The Company may match a percentage of each participant’s current pretax contribution at its discretion.
- C. *Participant Accounts.* Each participant’s account is credited with the participant’s deferral contribution and allocations of (a) the Company’s contribution (if any) and (b) plan earnings including administrative expenses. Allocations are based on participant compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- D. *Vesting.* Participants are immediately vested in their salary deferral contribution plus actual earnings thereon. Vesting in the Company’s contribution portion, if any, of their account plus actual earnings thereon is based on years of continuous service; a participant is 100% vested after five years of credited service with the vesting percentage accruing ratably each year of the period.
- E. *Payment of Benefits.* Distributions from the Plan are made in the form of a lump sum of a Participant’s entire vested account balance or a single sum distribution of a portion of the Participant’s vested account balance. 

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following describes the valuation methodologies used for assets measured at fair value on a recurring basis. The techniques utilized in estimating the fair values of financial instruments are reliant on the assumptions used. Care should be exercised in deriving conclusions based on the fair value information of financial instruments presented below. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Fair value estimates are made as of a specific point in time, based on available market information and judgments about the financial instrument. Such estimates do not consider the tax impact of the realization of unrealized gains or losses. In addition, the disclosed fair values may not be realized in the immediate settlement of the financial instrument.

*Mutual Funds* – The mutual funds are held as individual plan assets. The mutual funds have publicly available prices that are quoted daily in active markets. Lifecycle funds are managed based on a target date. Due to similar valuation techniques, they are classified as mutual funds. These are all considered Level 1 assets.

*Fixed Annuities* – The reported values for fixed annuity options are reported daily based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider. These are considered Level 2 assets.

The preceding described methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Accordingly, Empower Retirement, the trustee of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the schedule of assets (held at end of year).

#### 8. RELATED-PARTY TRANSACTIONS

Certain plan investments are money market and mutual funds managed by an affiliate of Empower, the trustee of the Plan, and, therefore, these are considered party-in-interest transactions.

The Plan also pays administrative fees to Empower. These fees are considered exempt party-in-interest transactions. Other administrative expenses of the Plan are absorbed by the Plan sponsor. Therefore, those expenses are not reflected in these statements.

#### 9. TAX STATUS

The Plan utilized a service provider to handle administrative matters including plan design. An opinion letter from the Internal Revenue Service has been obtained by the service provider accepting the Plan as a prototype qualifying under the appropriate Internal Revenue Code Sections. The Plan has been amended since receiving the letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress and the plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

#### 10. RISK AND UNCERTAINTIES

The Plan provides various investment options. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.

#### 11. SUBSEQUENT EVENTS REVIEW

Management evaluated events and transactions that occurred after the balance sheet date for potential recognition and disclosure through September 23, 2025, the date on which the financial statements were available to be issued.
