## **INDEPENDENT AUDITOR'S REPORT**

To the Advisory Committee and Participants of  
DSI Distributing, Inc. Defined Contribution Plan and Trust

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of DSI Distributing, Inc. Defined Contribution Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. **NOTE 1 — PLAN DESCRIPTION**

The following description of the DSI Distributing, Inc. Defined Contribution Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

**General**

The Plan is a participant-directed defined contribution 401(k) plan. Eligible employees include substantially all employees of DSI Distributing, Inc. (the Plan Sponsor) who have completed one (1) year of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Administration**

The Plan is administered by the Advisory Committee of the Plan Sponsor. Empower Retirement Solutions has been the designated recordkeeper of the Plan, Empower Trust Company, LLC and Empower Annuity Company of America (collectively, Empower) have been designated custodians and Trustees of the Plan and RetireRight LLC (RetireRight) has been designated as investment advisors of the Plan.

**Contributions**

Each year, participants may contribute up to 90% of their pre-tax annual compensation up to limits established by the Internal Revenue Service (IRS). Participants are automatically enrolled in the Plan with a 2% elected deferral. The Plan Sponsor may make a discretionary matching contribution, which, for 2024 and 2023, are equal to 50% of the participant's contribution, up to a maximum of 6% of pre-tax annual compensation. In addition, the Plan Sponsor may make discretionary profit sharing contributions. For the years ended December 31, 2024 and 2023, the Plan Sponsor made no discretionary contributions.

**Participant Accounts**

Individual accounts are maintained for each Plan participant. Each participant's account includes the participant's contributions, employer matching contributions, withdrawals, and allocations of (a) the Plan Sponsor's discretionary contributions, (b) Plan earnings (losses), and (c) administrative expenses not paid by Plan forfeitures or the Plan Sponsor. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings (losses) thereon. Vesting in the Plan Sponsor contribution portion of participants' accounts plus actual earnings (losses) thereon occurs at 20% per year beginning in the second year of service, based on years of credited service. A participant is 100% vested in Plan Sponsor contributions and earnings thereon after six (6) years of credited service. A participant is also 100% vested on the date of early or normal retirement.

**Payment of Plan Benefits**

On termination of service due to retirement, death, or disability, the vested portion of the participant's benefit is distributed, as requested, by the participant or participant's beneficiaries. Benefit payments are based upon Plan assets at the valuation date preceding the distribution of benefits. For those account balances less than \$5,000, only lump sum cash payments are available. For balances exceeding \$5,000, payment will be made either in a lump sum or in a series of substantially equal installments. Active employees may also receive a distribution of all or a portion of their account balance upon reaching age 59 1/2 or for specific hardship circumstances.

**Notes Receivable from Participants**

Participants are permitted to borrow from their fund accounts a minimum of \$1,000 up to a maximum of 50% of their vested account balance or \$50,000, whichever is less. The loans are secured by the balance in the participant's account and bear interest at one percent over prime, as determined by the Plan Sponsor. Principal and interest are paid ratably through payroll deductions.

**Forfeited Accounts**

Forfeitures may be used to reduce matching contributions or to pay Plan expenses. Total forfeitures for the years ended December 31, 2024 and 2023 were approximately \$48,200 and \$80,000, respectively. Forfeitures were used to reduce employer matching contributions by \$68,300 and \$93,900 for the years ended December 31, 2024 and 2023, respectively. As of December 31, 2024 and 2023, forfeited nonvested accounts are approximately \$39,200 and \$60,300, respectively.

**NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Presentation**

The accompanying financial statements have been prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Risks and Uncertainties**

The Plan utilizes various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the amounts reported in the financial statements.

**Investment Valuation and Income Recognition**

The Plan's investments in mutual funds and collective trust funds are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of the valuation methods and inputs used to determine fair value.

The Plan holds an investment contract with Empower, which is maintained in the general account of Empower. The guaranteed interest account is a fully benefit-responsive investment contract. Investment contracts held by a defined contribution plan are required to be reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes are recorded as distributions based on the terms in the Plan document.

**Contributions**

Contributions from the Plan participants and the discretionary matching contributions from the Plan Sponsor are recorded in the year in which the participant contributions are withheld from compensation.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Costs**

Certain administrative costs of the Plan are paid by the Plan Sponsor, and are not reported by the Plan. Participants are responsible for certain transaction-related expenses, asset based recordkeeping fees and investment advisory fees. Certain investment-related expenses are deducted from income earned on a daily basis and are not separately reflected.

**Plan Termination**

Although it has not expressed any intention to do so, the Plan Sponsor has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event that the Plan is terminated, participants would become 100% vested in their account.

**NOTE 3 — INFORMATION CERTIFIED BY EMPOWER**

The following is a summary of the information regarding the Plan as of and for the years ended December 31, 2024 and 2023, included in the Plan's financial statements and supplemental schedule, that was prepared by or derived from information prepared by Empower and furnished to the Plan Sponsor. The Plan Sponsor has obtained certifications from Empower that such information is complete and accurate.

**NOTE 4 — TAX STATUS**

The Plan uses a prototype plan document sponsored by Empower. Empower has received an opinion letter from the IRS dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter; however, the Plan Sponsor believes that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan Sponsor has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

**NOTE 5 — PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Empower and, therefore, these transactions qualify as party-in-interest transactions. Fees paid to Empower for administrative and custodial services were \$38,399 and \$30,679 for the years ended December 31, 2024 and 2023, respectively. Fees paid to RetireRight for investment advisory services were \$31,000 and \$23,542 for the years ended December 31, 2024 and 2023, respectively.

**NOTE 6 — FAIR VALUE MEASUREMENTS**

GAAP establishes a three-tier fair value hierarchy, which categorizes the inputs used in measuring fair value. These categories include (in descending order of priority): Level 1, defined as unadjusted quoted prices in active markets accessible at the measurement date for identical, unrestricted assets or liabilities; Level 2, defined as inputs other than quoted prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore requiring an entity to develop its own assumptions. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds*: Valued based on quoted prices in active markets.
- *Collective trust funds*: The fair value of units is valued based on quoted redemption values, also known as net asset values (NAV), determined using available market information of the underlying securities including quoted prices for identical or similar securities in active or nonactive markets. These redemption values are the values at which a participant would transact daily. There are no restrictions on the ability to transact with the funds at net asset value.

**NOTE 7 — INVESTMENT CONTRACT WITH INSURANCE COMPANY**

As of December 31, 2024 and 2023, the Plan had an investment in the guaranteed interest account. The contract underlying this investment option is considered to be fully benefit responsive. As of December 31, 2024 and 2023, the contract value of the investment in insurance contracts was \$1,314,517 and \$1,368,543, respectively.

Contributions to the guaranteed interest account are maintained in a general account that is credited with earnings on the underlying investment and charged for participant withdrawals and administrative expenses. The contracts are included in the financial statements at contract value as reported to the Plan by Empower. Contract value represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all, or a portion, of their investment at contract value. There are no reserves against contract value for credit risk.

The average crediting interest rates to participants for the guaranteed interest account for the years ended December 31, 2024 and 2023 was 1.66% and 1.48%, respectively.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exempt under ERISA. No events are probably of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with participants.

**NOTE 8 — SUBSEQUENT EVENTS**

Management has evaluated all subsequent events through October 9, 2025, the date the financial statements were available to be issued.
