Report on the Audit of the Financial Statements

Opinion on the 2024 Financial Statements

NOTE 1 DESCRIPTION OF PLAN

The following description of ChamberHealth Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established on January 1, 2023, to provide medical benefits to eligible employees of participating employers. ChamberHealth Consortium of Minnesota (the Consortium) is the Plan Sponsor. Certain Plan assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the provisions of ERISA, as amended.

Eligibility

Each participating employer determines eligibility for its employees by selecting from the available options provided by Plan provisions. Based on the selections made by their employer, employees that work the selected number of hours per month, receive coverage the day after a waiting period of up to 90 days, or on the first day of the month following a waiting period of up to 60 days, of employment.

Funding Policy

Each month, premiums are collected from the participating employers. Premiums are based upon various criteria such as participant age, coverage type, deductible amount, and based on amounts needed to pay plan expenses. Premiums are billed the month prior to the coverage month and then paid during the coverage month. The participating employers pay premiums via ACH to the insurance company. There is a cost sharing provision where the premium is allocated between the employee and the employer. Each participating employer determines the allocation. Based on how the Plan is administered, it is not feasible to segregate the premiums by source.

Benefits

The Plan provides medical benefits to eligible members and to their beneficiaries and dependents. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA). The Plan offers various plans and networks for participating employers to select as options for participants. Participants elect the plan and network upon enrollment. The Plan fully insures the medical benefits.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Concentration of Credit Risk

The Plan maintains its cash balances in high credit quality financial institutions in Minnesota. Accounts at each institution are insured by the Federal Deposit Insurance Corporation up to \$250,000. At times, such cash balances may be in excess of the insurance limit.

Administration Fees from Employers

Participating employers pay a monthly administration fee with their monthly premium payment to the insurance carrier. A portion of the administration fee is paid to the Plan and recognized as revenue in the period the administration fee pertains to.

Payment of Benefits

Premiums paid to the insurance company are recorded as premium payments in the accompanying the statement of changes in net assets available for benefits.

Administrative Expenses

The Plan pays administrative expenses incurred by the Plan.

Unearned Premium Revenue

Unearned premium revenue is premiums received during the plan year for future coverage.

Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

NOTE 3 BENEFIT OBLIGATIONS

The Plan insures all benefits. Insurance premiums due at year-end are due to newly enrolled participating employers the last month of the Plan year.

NOTE 4 TAX STATUS

The VEBA trust funding certain benefits of the Plan received an exemption letter from the Internal Revenue Service (IRS) dated February 3, 2025, stating that the trust is tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code (IRC). However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded in 2024 or 2023 for unrelated business taxable income.

In addition, the Plan and trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 PLAN TERMINATION

Although it has not expressed any intention to do so, the Consortium has the right under the Plan to modify the benefits provided to, and contributions required of participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits or for on account of the participants. No assets of the Plan may revert to the Consortium or be used for purposes other than for the exclusive benefit of the Plan's participants.

NOTE 6 PREMIUM ARRANGEMENTS

The Plan has entered into an arrangement with Medica Insurance Company, which is fully insured and requires the payment of premiums based on the number and ages of employees of participating employers covered, and the specific risks insured.
