(1) Description of Plan

The following description of the Cary Oil Co., Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is sponsored by Cary Oil Co., Inc. (the "Company").

(a) Organization and Administration

The Plan is a defined contribution plan adopted January 1, 1971 covering substantially all full-time employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Members of management of the Company administer the Plan and among other duties, appoint the Plan trustee. Effective April 5, 2024, the assets of the Plan were no longer held by the previous trustee, Ascensus Trust Company, and are now held by the new trustee, Lincoln Retirement Services Company LLC (the "Trustee"). Certain transaction-based fees, such as participant loan and benefits distribution processing fees, are paid from participants' accounts. Trustees' fees are also deducted from participants' accounts and are included in administrative expenses of the Plan. Certain other administrative costs of the Plan are absorbed by the Company.

(b) Participation

Employees are eligible to participate in the Plan upon attaining thirty days of employment. Employees are eligible to receive discretionary profit-sharing contributions after one year of employment. An employee can join the Plan on the first day of the month following satisfaction of eligibility requirements.

(c) Contributions

Plan participants may make pre-tax contributions up to 100% of their regular compensation as defined in the Plan agreement. Participants who have attained age 50 may also make pre-tax catch-up contributions to the Plan by completing special election forms. All participant contributions are subject to Internal Revenue Code 401(k) limitations. Effective January 1, 2021, the Plan was amended and the Company elected to make a non-elective safe harbor employer contribution equal to 100% of participant contributions, not to exceed 4% of each participant's salary and 50% of deferrals between 4% and 6% of each participant's salary. The Company may also make discretionary profit-sharing contributions. During 2024 and 2023, the Company elected not to make a profit sharing contribution.

In addition, participants may make rollover contributions from other qualified plans to their account at any time during the Plan year.

(d) Participant Accounts

Participants' accounts are credited with their pre-tax contributions, Company discretionary matching and profit-sharing contributions and allocations of Plan earnings (losses). Allocations are based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested balance.

(1) Description of Plan, Continued

(e) Vesting

Participants are immediately vested in their pre-tax contributions and the safe harbor matching contributions. Vesting in the Company's discretionary profit-sharing contribution portion of their accounts is based on their years of continuous service. Vesting for discretionary contributions begins in the second year of service and vests at the rate of 20% per year so that participants are 100% vested in such contributions after six years of service.

(f) Investments

The Plan provides that contributions and related earnings will be invested in the Plan's investment options as directed by each participant. As of December 31, 2024 and 2023, the Plan's funds were invested in a stable value fund and a series of varied risk mutual funds. Certain investment management fees are charged to the individual funds in the Plan and are included in net appreciation (depreciation) in the fair value of investments.

(g) Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. Notes receivable from participants are collateralized by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates at the date of issuance of the note. Generally, the term of the note may not exceed five years, and principal and interest are paid ratably through payroll deductions. Interest income on notes receivable from participants totaled \$10,747 and \$10,705 during 2024 and 2023, respectively.

(h) Distributions

A participant is entitled to distributions under the Plan upon reaching 59 ½ years of age; in the event of the death of the participant before retirement or other termination of employment; in the event of the participant's total or permanent disability; in the event that a participant's employment is terminated for any reason other than those stated above, or in the event of employee hardship, which must be proved satisfactorily to the Plan Committee. Participants are entitled to the value of their account determined on the valuation date coincident with or following retirement, death, disability, or termination. All distributions from the Plan are made in one lump sum payment, or installments for required minimum distributions only.

(i) Forfeitures

Forfeitures relating to the non-vested portion of a terminated participant's employer contributions are retained by the Plan and used to first pay administrative expenses and second to reduce future employer contributions. Forfeitures of \$10,192 and \$5,196 were used to offset administrative fees of the Plan in 2024 and 2023, respectively. Forfeitures available to pay Plan expenses and future employer contributions as of December 31, 2024 and 2023 totaled \$17,594 and \$657, respectively.

(2) Summary of Significant Accounting Policies

(a) Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting.

(b) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for plan benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for plan benefits during the reporting period. Actual results could differ from those estimates.

(c) Fair Value Measurements

For determining fair value measurements, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. Management follows an established framework for measuring fair value. That framework provides a fair value hierarchy, which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The three levels of inputs that may be used to measure fair value are described below:

Level 1: quoted prices (unadjusted) in active markets for identical assets or liabilities.

Level 2: inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly.

Level 3: one or more significant inputs or significant value drivers that are unobservable or based on market assumptions.

(d) Investments

Investments in mutual funds managed by the Plan's trustee are valued on the last business day of the year based on the current market values (quoted prices in active markets) of the funds. Redemptions from the fund may be made each business day, subject to certain restrictions by the fund.

Through April 4, 2024, the stable value fund (the "Fund") was primarily invested in conventional and synthetic Guaranteed Investment Contracts ("GICs") and a money market fund. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. The Fund was valued daily based on its net asset value for the Plan's account type, with such net asset value determined at the contract value of the Fund, based on the value of the underlying investments, as described below.

Conventional GICs are typically issued by insurance companies or banks and are essentially nonmarketable deposits with the issuing entity. The issuer is contractually obligated to repay the principal and stated interest. The repayment of a conventional contract is the sole responsibility of the issuing entity. In the case of a synthetic GIC, the Fund purchases high quality debt obligations and enters into contractual arrangements (wrapper contracts) with third parties related to these debt obligations to provide a guarantee of contract value and specified interest.

The fair value of conventional investment contracts is determined using a discounted cash flow methodology where the individual contract cash flows are discounted at the prevailing interpolated yield curve rate as of year-end.

Individual assets of the synthetic investment contract were generally valued at representative quoted market prices. Short-term securities, if any, are stated at amortized cost, which approximates market value. Debt securities are valued on the basis of valuations furnished by a pricing service approved by the fund trustee, which determines valuations using methods based on market transactions for comparable securities and various relationships between securities which are generally recognized by institutional traders. Accrued interest, if any, on the underlying investments is added to the fair value of the investments for presentation purposes.

There are several specific risks to investment contracts. One of the primary risks involved is credit risk of the contract issuer. Credit risk for security-backed contracts includes risks arising from the potential inability of the issuer to meet the terms of the contract wrapper and the potential default of the underlying fixed-income securities. Secondly, liquidity is limited because of the unique characteristics of investment contracts and the absence of an actively traded secondary market. Interest rate risk is also present because rates may be fixed with these products.

Market value events may limit the ability of the Fund to transact at contract value with the issuer. Market value events are events or conditions that occur which are outside of the normal operation of the Fund and lead to any Fund disbursements which have or will have a material adverse effect on the operations of the Fund and a financial effect on the investment contract or wrap issuer's interest hereunder. In the normal course of business, such events or conditions would not limit the ability of the Fund to transact at contract value with the participants in the Fund. The Fund is managed to maintain a certain amount of liquidity to provide for the day-to-day liquidity needs of participants as well as the occasional market value event.

On April 5, 2024, the stable value fund was transferred to the Lincoln Stable Value Separate Account which is a fixed annuity contract issued by The Lincoln National Life Insurance Company. Assets backing this contract are held in a separate account that's segregated from the general assets of the issuing company. Assets in the Lincoln Stable Value Separate Account are held for the exclusive benefit of contract owners and aren't subject to the claims of insurance company creditors or other general account contract owners. All Lincoln Stable Value Separate Account contracts are in the same pooled separate account. Lincoln contracts are group fixed annuity contracts, not synthetic contracts.

As of December 31, 2024 and 2023, the contract value of the investment in stable value funds was \$1,639,734 and \$2,060,848, respectively.

The Plan presents in the statements of changes in net assets available for plan benefits the net appreciation (depreciation) in the market value of its investments which consists of realized gains or losses and the unrealized appreciation (depreciation) on investments held at year-end. Purchases and sales of securities are recorded on a trade-date basis. Investment income is recognized when earned. There are no unfunded commitments as of December 31, 2024.

(e) Notes Receivable from Participants

Notes receivable from participants are valued at their unpaid principal balance plus any accrued but unpaid interest.

(f) Benefit Payments

Benefits are recorded when paid.

(5) Risks and Uncertainties

Financial instruments which potentially subject the Plan to concentrations of credit risk consist of investments in mutual funds and a stable value fund. The Plan has no formal policy regarding collateral to support the financial instruments subject to credit risk. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

(6) Federal Income Taxes

The Plan trustee received a letter dated June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the form of the prototype plan which the Company has adopted is acceptable under the applicable requirements of the Internal Revenue Code (the "Code") for use by employers for the benefit of their employees. The Plan has been amended since receiving the determination letter. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. No provision for income taxes has been included in the Plan's financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

(7) Related Party Transactions

As of December 31, 2024 and 2023, the Plan had contributions receivable from the Company of \$86,197 and \$2,388, respectively. Amounts were paid to the Plan in the following year.

(9) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants would become 100 percent vested in their employer contributions.

(10) Nonexempt Party-in-Interest Transactions

In 2024, it was discovered that during 2024, the Company did not timely remit participant contributions in accordance with Plan provisions. These amounts totaled \$115,947 for 2024. At issuance date, delinquent contributions had not yet been reported to the trustee to determine potential cumulative estimated lost earnings.

During 2024, the Company transitioned its Plan trustee from Ascensus Trust Company to Lincoln Retirement Services Company, LLC. During the transition, the Company experienced a blackout period from April 5, 2024 through May 3, 2024. Subsequent to the blackout period, the Company's third-party payroll processor, Automatic Data Processing, Inc. (ADP), implemented a payroll integration with the new trustee. This integration was completed on August 15, 2024. Contributions during the transition and implementation, and certain contributions post-implementation that were processed by ADP with exceptions, were not made in line with historical Plan contribution periods. These impacted contributions were made as soon as administratively possible, which occurred 13 to 17 days subsequent to payroll dates, but in no situation did these contributions occur later than the 15th day of the following month. The Company has completed its transition, and contributions are now consistent with historical contribution timing.

At this time, management of the Company lacks sufficient information to determine an estimate of any potential taxes or penalties that may be levied by the IRS or Department of Labor as a result of the matter noted above.

(11) Subsequent Events

The date to which events occurring after December 31, 2024, the date of the most recent statement of net assets available for plan benefits, have been evaluated for possible adjustment to the financial statements or disclosure is October 15, 2025, the date the financial statements were available to be issued.
