## **Independent Auditors' Report**

**1. Description of Plan**

The following description of the Credit Agricole Corporate and Investment Bank Money Purchase Pension Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

***General and Eligibility***

The Plan is a defined contribution plan established on January 1, 1972. The Plan covers only eligible employees who were participants on February 29, 1996. No employee shall become eligible to participate in the Plan after such date whether or not they meet the eligibility requirements for participating employees of Credit Agricole Corporate and Investment Bank (the "Company" or "Bank"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

***Contributions***

Effective March 1, 1996, the Company ceased contributions to the Plan.

***Participant Accounts***

Each participant's account is credited with investment earnings thereon. Allocations are based on participant earnings, account balances, or specific participant accounts transactions. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the amount accumulated in the participant's vested account.

***Vesting***

Prior to March 1, 1996, participants became fully vested after five years of credited service as defined in the Plan document. All participants in the Plan were fully vested as of December 31, 2024 and 2023.

***Forfeitures***

Forfeitures of terminated non-vested accounts will be used first to pay administrative expenses or reallocated to participants. At December 31, 2024 and 2023, unapplied forfeitures totaled \$130 and \$9. During 2024, no amounts were used to pay administrative expenses or reallocate to participants from forfeited non-vested accounts.

***Payment of Benefits***

Benefits are paid upon retirement, death, disability or termination of employment. A participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account. Participants may elect to receive benefits from several options available as set forth in the Plan document.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Fair Value of Financial Instruments***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable inputs and are used to the extent that observable inputs do not exist. At December 31, 2024 and 2023, the Plan’s investments, that were valued at fair value, were valued using level 1 inputs.

***Investment Valuation and Income Recognition***

Investments in mutual funds and the money market fund are valued at the net asset value of shares held by the Plan at year end as determined by quoted market prices. Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefits are recorded when paid.

***Expenses***

Certain expenses for maintaining the Plan are paid by the Company and are excluded from these financial statements. Administrative fees for certain transaction charges are paid by the Plan. Investment related expenses are included in net appreciation in fair value of investments.

***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 14, 2025

**3. Information Certified (Unaudited)**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and dividend income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank, a qualified institution.

**4. Transfers Out of Plan Assets**

The Company sponsors various other retirement plans. During the Plan year ended December 31, 2024, there were transfers of \$3,161,736 to the Credit Agricole Corporate and Investment Bank Retirement Plan.

**5. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

**6. Tax Status**

The Internal Revenue Service has determined and informed the Company by a letter dated July 25, 2016, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

**7. Party-in-Interest Transactions**

The money market investment is managed by Charles Schwab Trust Bank, the custodian of the Plan, as defined by the Plan document. Accordingly, these transactions are considered exempt party-in-interest transactions.

Certain employees of the Company, who may also be participants in the Plan, perform administrative services for the Plan at no cost to the Plan.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
