NOTE 1 • DESCRIPTION OF THE PLAN

The following description of Community Eldercare Services, LLC 401(k) Plan (hereafter referred to as the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Community Eldercare Services, LLC (hereafter referred to as the "Company") who are twenty-one (21) years of age and have completed three months of service. An employee may begin participation in the Plan on the first day of the month following the date on which the employee meets the requirements for eligibility. The Company's sole owner and the Plan Administrator control and manage the operation and administration of the Plan. Ascensus Trust Company served as the Custodian of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Company is a limited liability company pursuant to the provisions of the Mississippi Limited Liability Company Act. Its primary business activity is to provide living facilities and care for elderly residents.

Contributions

Participants may contribute up to \$23,000 and \$22,500 for 2024 and 2023 respectively, as adjusted annually by the Secretary of the Treasury. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age fifty (50) and older can elect to make additional catch-up deferrals (limited to \$7,500 for 2024 and 2023).

The Plan Sponsor may elect to make employer match and profit sharing contributions, which are subject to certain limitations. The Plan Sponsor did not make a discretionary contribution for the 2024 or 2023 Plan years.

Participant Accounts

Each participant's account is credited with the participant's contribution and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Forfeited balances of terminated participant's non-vested accounts are used to reduce employer contributions for the year. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Participants' interests in the Plan Sponsor's discretionary contributions and allocated earnings thereon are vested as follows:

Investment Options

Upon enrollment in the Plan, a participant may direct contributions in any investment options allowed by the Plan. Participants may change their investment options daily.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account and bear interest at a rate of 5.25 percent to 10.50 percent, which is commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest is paid ratably through monthly payroll deductions.

Payment of Benefits

Upon termination of service due to termination, death, disability, or retirement, a participant may elect to receive either a lump-sum amount or installments equal to the value of the participant's vested interest in his or her account.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts, including employer discretionary contributions.

Forfeitures

Forfeitures result from employees withdrawing from the Plan prior to fully vesting. Forfeitures not applied to Plan expenses are generally used to offset future matching contributions. Unallocated forfeitures, as of December 31, 2024 and 2023, totaled \$0 and \$11,730 respectively. Forfeited amounts of \$12,330 and \$0 were applied to Plan expenses and reduction of employer contributions during 2024 or 2023, respectively.

Administrative Expenses

During 2024 and 2023, administrative and loan fees payable to the Trustee of the investments were paid by the Plan and all other expenses related to the administration of the Plan were absorbed by the Company.

NOTE 2 • SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Significant Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates. Significant estimates include the fair value measurement of investments. It is at least reasonably possible that the significant estimates used will change within the next year.

Employee and Employer Contributions

Employee deferrals contributions are recognized as additions to net assets on the date on which such employee deferrals would otherwise have been payable to the participant. Employee rollover contributions are recognized as additions to net assets on the date transferred from other qualified plans. Employer discretionary contributions are recognized as additions to net assets upon formal approval by the Plan Sponsor.

Investment Valuation and Income Recognition

Investments are reported at fair value and any unrealized appreciation or depreciation for the year is reflected in the statements of changes in net assets available for benefits. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Participant loans are measured at their unpaid principal balance, plus any accrued, but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. Interest income is recorded on the accrual basis.

Concentration of Market Risk

The Plan assets include a significant amount of registered investment companies, which invest primarily in marketable equity securities and fixed income securities. Accordingly, the performance of the investments is dependent on the equity and debt securities markets which involve price volatility. Additionally, the registered investment companies may invest in securities with contractual cash flows, such as asset backed securities, collateralized mortgage obligations and commercial mortgage-backed securities, including securities backed by subprime mortgage loans. The value, liquidity and related income of these securities are sensitive to changes in economic conditions, including real estate value, delinquencies or defaults, or both, and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Subsequent Events

Subsequent events were evaluated by the Plan through October 13, 2025, which is the date the financial statements were available to be issued.

NOTE 3 • INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

Certain information related to investments disclosed in the accompanying financial statements and ERISA-related supplemental schedules, including investments held and notes receivable from participants at December 31, 2024 and 2023, net appreciation in fair value of investments, interest and dividends and interest income on notes receivable for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus Trust Company, the trustee of the Plan.

NOTE 4 • FAIR VALUE MEASUREMENTS

Accounting Standards Codification Topic 820, Fair Value Measurements, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods may produce a fair value calculation that may not be indicative of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 • RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

During the years ended December 31, 2024 and 2023, certain Plan investments were shares of mutual funds managed by the custodian. Additionally, the Plan pays third parties for investment advisory services and auditing services. These transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan to these parties totaled \$43,876 and \$15,037 during 2024 and 2023, respectively.

NOTE 6 • INCOME TAX STATUS

The Plan adopted a non-standardized form of a prototype plan sponsored by Ascensus, LLC. The prototype plan has received an opinion letter from the Internal Revenue Service, dated June 30, 2020, as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan.

Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

There were no uncertain tax positions identified related to the current year and the Plan has no unrecognized tax benefits at December 31, 2024 and 2023, for which liabilities have been established. The Plan recognizes interest and penalties, if any, related to unrecognized tax benefits as a component of income tax expense.

NOTE 7 • NON-EXEMPT TRANSACTIONS

Defined contribution plans are required to remit employee contributions and loan payments to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions and loan payments are withheld by the employer.

While the Plan remitted all contributions and loan payments to the Plan, contributions and loan payments totaling \$46,929, \$57,086, \$58,415, \$19,705, and \$10,091 were not remitted within the required time period for the years ended December 31, 2024, 2023, 2022, 2021, and 2020, respectively. Subsequently during 2025, the Plan corrected these matters through the Voluntary Fiduciary Correction Program and made the participant accounts whole for the years ended December 31, 2024, 2023, 2022, 2021, and 2020. The total remaining amount yet to be corrected is \$863. The Plan is continuing to work with its Trustee to determine the impact of any and all further matters of noncompliance.

NOTE 8 • NONCOMPLIANCE - ELIGIBILITY AND CONTRIBUTION AMOUNTS

The Plan determined that a number of operational failures occurred related to the enrollment of eligible participants and the amount of employee contributions remitted to the plan. Accordingly, the Plan will perform an analysis to determine the full scope and impact of the operational failures and file an application for one of the voluntary correction programs available with the IRS under the Employee Plans Compliance Resolution System. The correction process may have a material effect on the financial statements and a plan receivable from the Company may be recorded to compensate

and make participant accounts whole. However, the effect of such a correction is currently not known. Therefore, no Plan receivable has been recorded for the years ended December 31, 2024 and 2023. These operational failures could jeopardize the Plan's tax-qualified status. The Plan has committed to completing any corrective actions necessary to be in compliance with IRS regulations.

NOTE 9 • SECURE 2.0 ACT

On December 29, 2022, the Securing a Strong Retirement Act of 2022 ("SECURE 2.0") was signed into law. SECURE 2.0 has key effective dates which vary by provision. The plan has adopted and implemented all mandatory provisions to date with other provisions to be phased in over the next few years in accordance with applicable law and IRS guidance. Written amendments to the Plan to reflect these operational changes will be adopted at a later date.
