INDEPENDENT AUDITOR'S REPORT

To the Trustees of
Education Loan Finance, Inc.:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Education Loan Finance, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTE A--DESCRIPTION OF THE PLAN

The following description of the Education Loan Finance, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution employee benefit plan providing retirement benefits to eligible participants. All employees except union employees, nonresident aliens, and leased employees are immediately eligible to participate in the Plan upon employment commencement date. The employer, as defined by the Plan, is Education Loan Finance, Inc. and its wholly-owned subsidiaries. The Plan is subject to the Employee Income Retirement Security Act of 1974 (ERISA), as amended.

Contributions: The Plan is a contributory plan whereby an employee who elects to participate can contribute a percentage of the employee's compensation, subject to limitations as defined by the Internal Revenue Code (IRC). Effective March 16, 2020, the Plan was amended to include an auto-enrollment provision whereby participants are automatically enrolled in the Plan upon date of hire unless they affirmatively elect not to participate. The Plan was also amended to include an auto-escalation provision whereby automatically enrolled participants have their deferral rate increased by 1% every January 1, up to a maximum of 15% of compensation, subject to limitations as defined by the IRC.

The employer will make a safe harbor matching contribution equal to 100% of the employee's contribution, not to exceed 5% of eligible compensation. Further, the employer may make additional discretionary matching and profit-sharing contributions. No discretionary matching or profit-sharing contributions were made to the Plan during 2024. Participants direct the investment of all contributions into various investment options offered by the Plan.

Participant Accounts: Each participant's account is credited with the participant's contributions, the employer's contributions, an allocation of Plan earnings, and charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their elective contributions and all employer contributions plus actual earnings thereon.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance of the participant's account and bear interest at rates between 4.25% and 9.50% at December 31, 2024, which were commensurate with local prevailing rates at the time the loans were initiated. Principal and interest are paid ratably through bi-monthly payroll

deductions. The term of a loan is no longer than five years, unless the loan is used to purchase a principal residence.

Payment of Benefits: The Plan provides that a participant may begin receiving normal retirement benefits upon attaining age 59^{1/2}. Early retirement benefits are not permitted.

Administration: The Plan administrator is the Plan sponsor, Education Loan Finance, Inc. The administrator supervises the operation of the Plan, interprets the meaning of provisions in the Plan, determines eligibility for participation and benefits, and decides when benefits are to be paid in accordance with the terms of the Plan.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Advisory Committee determines the Plan's valuation policies utilizing information provided by the custodian. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recognized as benefits paid to participants based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Benefit Payments: Benefit payments are recorded when paid.

Administrative Expenses: Certain administrative expenses of maintaining the Plan are paid directly by the employer and are excluded from these financial statements. Fees related to the

administration of notes receivable from participants and benefit payments to participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

NOTE C--INFORMATION CERTIFIED BY THE CUSTODIAN

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following investment information was certified by American Trust Company (American Trust), the custodian of the Plan, and was not subjected to any auditing procedures performed by the Plan's independent public accountants:

- The investments and notes receivable from participants, as shown in the accompanying Statements of Net Assets Available for Benefits of \$23,320,512 and \$239,512 as of December 31, 2024, and \$19,321,080 and \$244,042, respectively, as of December 31, 2023.
- Net appreciation in fair value of investments of \$1,727,460 and interest and dividends of \$654,246 as shown in the accompanying Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- All investment-related information, in the accompanying supplemental Schedule H, Line 4i - Schedule of Assets Held at Year End as of December 31, 2024.

NOTE D--FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy based on valuation inputs. The three levels of the fair value hierarchy are described as follows:

- *Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- *Level 2:* Inputs to the valuation methodology include:
 - Quoted prices for similar assets and liabilities in active markets;
 - Quoted prices for identical or similar assets and liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and
 - Inputs that are derived principally from or are corroborated by observable market data by correlation or other means.
- *Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Cash and cash equivalents: Reported at cost, which equals fair value.

Registered Investment Companies: Valued at the daily closing price as reported by the fund. Shares of registered investment companies held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The shares of registered investment companies held by the Plan are deemed to be actively traded.

Collective Trust Fund: A stable value trust that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions could result in a different fair value measurement at the reporting date.

Investments Measured Using the Net Asset Value as a Practical Expedient: The Plan offers a collective trust investment option to participants through the MetLife UTC Stable Value Fund (the Fund). The Fund's investment objectives are to seek income while preserving principal and provide daily liquidity at contract value for participant withdrawals and transfers. The Fund invests primarily in fully benefit-responsive investment contracts. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

NOTE E--RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are units of interest in a collective trust fund managed by American Trust. American Trust, the custodian as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions and are denoted as such on the supplemental schedule of assets held at year end. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments and administrative expenses. Fees paid by the Plan to American Trust totaled \$8,040 for the year ended December 31, 2024.

NOTE F--PLAN TERMINATION

Although it has not expressed any intent to do so, the employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE G--INCOME TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Plan administrator by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently

being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan administrator has evaluated the tax positions taken by the Plan and determined there are no uncertain tax positions as of December 31, 2024, that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H--RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE I--SUBSEQUENT EVENTS

Subsequent events have been evaluated through the date of the Independent Auditor's Report, which is the date the financial statements were available to be issued. During this period, management did not note any material recognizable subsequent events that required recognition or disclosure in the financial statements.

NOTE J--RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

The Plan records employer and employee receivables on the Form 5500 based on a cutoff period related to IRS Form W-2 wages. The audited financial statements present the employer and employee receivables based on a pay period accrual basis.
