### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements***

We have performed an audit of the financial statements of SEEC Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (2024 Financial Statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of SEEC Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about SEEC Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matters — Supplemental Schedule Required by ERISA***

The supplemental schedule of assets (held at end of year) December 31, 2024 – schedule H, part IV, item 4i, is presented for purposes of additional analysis and are not a required part of the financial statements but is supplementary information required by the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA.

*Auditor's Report on the 2023 Financial Statements*

Predecessor auditors performed an audit of the 2023 financial statements of SEEC Retirement Plan. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the plan that were certified by qualified institutions. Their report dated October 15, 2024, indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agreed to or is derived from the certified investment information, was presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedule related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determines meets the requirements of ERISA Section 103(a)(3)(C).

**NOTE A – PLAN DESCRIPTION**

The following description of the SEEC Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**1. General**

The Plan is a defined contribution covering all employees of SEEC, Inc. (the Sponsor) and was established on July 1, 2001. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan administrator is responsible for oversight of the Plan. The Sponsor's management determines the appropriateness of the Plan's investment offerings and monitors investment performance and reports to the Plan administrator.

**2. Eligibility**

The Plan covers substantially all employees of the Sponsor. Employees excluded are nonresident aliens (as defined) and employees who normally work less than 20 hours per week. Employees may enter the Plan on their first day of employment.

**3. Contributions**

Each year, participants may contribute up to the maximum allowed by the applicable laws. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Pretax and Roth (after-tax) contributions are allowed under the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

Effective January 1, 2024, the Plan was amended to include an eligible automatic contribution arrangement. Under the provision, a pre-tax contribution of 5% of compensation will automatically be elected for new employees hired after the effective date, unless otherwise directed by the employee.

The Sponsor may contribute a discretionary matching contribution, as determined by the Sponsor, to participants deferring into the Plan based on their years of service. During the year ending December 31, 2024, the Sponsor provided matching contributions totaling \$274,616. The employee must have at least 12-months of service, worked at least 1,000 hours during the year, and be employed at the end of the year to be eligible for a discretionary matching contribution.

### **3. Contributions - Continued**

The Sponsor may also contribute a discretionary non-elective contribution, however, there were no discretionary non-elective contributions made for the year ending December 31, 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

### **4. Participant Accounts**

Each participant's account is credited with the participant's contributions and Sponsor matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **5. Vesting**

Participants are immediately vested in their contributions, the Sponsor's matching contributions and QNECs plus earnings thereon. Vesting in the Sponsor's discretionary non-elective contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after one year of credited service. Regardless of the vesting schedule, participants will become fully vested upon reaching the normal retirement age of 65 while an active employee.

### **6. Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%, based on the rate in place the month the loan becomes effective. Notes receivable for the purchase of a principal residence may not exceed a repayment period of 15 years. Only one note may be outstanding at a time. Principal and interest is paid ratably through payroll deductions.

### **7. Payment of Benefits**

Upon termination of service due to death, disability, retirement or termination of service due to other reasons, a participant or the participant's estate or beneficiary will receive a lump-sum amount equal to the value of the participant's vested interest in the participant's account, or in the form of an annuity. Account balances that are less than \$5,000 at the time of a participant's termination from the Sponsor will be automatically distributed in the form of a lump sum payment. Distributions from a participant's rollover account may be made at any time. Hardship withdrawals and in-service withdrawals at age 59 ½ are also permitted, subject to provisions defined in the plan document. The Principal Group Annuity Contract contains additional limits as described in Note E.

### **8. Forfeited Accounts**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$3,796 and \$6, respectively. Forfeitures will be used to pay Plan expenses and reduce future Sponsor contributions. During the year ended December 31, 2024, \$20 in forfeitures were used to pay Plan expenses.

## **NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### **1. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **2. Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **3. Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors, Principal and Voya. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **4. Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

### **5. Contributions**

Contributions from plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

### **6. Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding expense deduction. The Plan had no excess contributions payable as of December 31, 2024 and 2023.

### **7. Payment of Benefits**

Benefits are recorded when paid.

## **NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - Continued**

### **8. Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants and certain benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### **9. Reclassifications**

Certain reclassifications have been made to the 2023 financial statements to conform to the 2024 presentation.

### **10. Subsequent Events**

The Plan has evaluated events and transactions for potential recognition or disclosure through October 15, 2025, the date the financial statements were available to be issued.

## **NOTE C – INFORMATION CERTIFIED BY THE PLAN'S CUSTODIANS**

Certain information related to investments and notes receivable from participants in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information provided to the Plan administrator and has been prepared and certified as complete and accurate by Principal Trust Company (Principal) and Voya Retirement Plan Services (Voya), the custodians of the Plan.

## **NOTE D – FAIR VALUE OF FINANCIAL INSTRUMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets:
- Quoted prices for identical or similar assets or liabilities in inactive markets:
- Inputs other than quoted prices that are observable for the asset or liability:
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

## **NOTE D – FAIR VALUE OF FINANCIAL INSTRUMENTS – Continued**

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered Investment Companies:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Voya Variable Annuity Account C – Pooled Separate Accounts:* The separate accounts invest directly in designated mutual funds or, in some cases, collective investment trusts. The AUV is the value of each unit in the separate account. The AUV is determined daily based on the NAV of shares of the underlying fund, the fund's dividends and the Contract's separate account charges.

## **NOTE E – PRINCIPAL GROUP ANNUITY CONTRACT**

The Plan has entered into a Group Annuity Contract (Contract) with Principal Life Insurance Company (PLIC) offering the Principal Fixed Income Guaranteed Option (PFIGO). The PFIGO is a single group annuity contract with a fixed rate of interest. PLIC maintains the assets in a general account of PLIC and is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. The contract value represents contributions made under the Contract, plus earnings, less any participant-directed withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer all or a portion of their investment at contract value.

In general, payments and transfers are made in full within 3 business days after the date the payment or transfer has been requested. In the event market conditions are such that it is determined that they will not allow for the orderly transfer or sale of financial instruments, up to an additional 30 days may be required to make such payments or transfers. Additionally, a surrender charge of 5% will be assessed on all transfers by a plan sponsor in excess of cumulative transfer percentages (as defined) as of the date of the transfer. Should the plan sponsor terminate the Contract, a twelve-month notice is required and depending on the cumulative transfer percentages, a surrender charge of 5% may apply.

The crediting interest rate is based on a formula agreed upon with the issuer, and under the terms of the existing contract, the composite crediting rate (as defined) is currently reset on a semiannual basis and will never be less than the guaranteed minimum interest rate (as defined). As amended for 2024, the guaranteed minimum interest rate will not be less than 1% or greater than 3%.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are probable of not occurring. There are no reserves against the investment contracts for credit risk of the contract issuers or otherwise.

## **NOTE F – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Principal Life Insurance Company, Voya Retirement Insurance and Annuity Company, and Benchmark Retirement Plan Services provided contract administration and recordkeeping services, respectively, for the Plan. Therefore, transactions with Principal Life Insurance Company, Voya Retirement Insurance and Annuity Company, and Benchmark Retirement Plan Services qualify as party-in-interest transactions. During the year ended December 31, 2024, the Plan paid \$76,450 to Principal Life Insurance Company, \$30 to Voya Retirement Insurance and Annuity Company, and \$6,254 to Benchmark Retirement Plan Services for contract administration and recordkeeping expenses.

## **NOTE G – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their allocation of Sponsor contribution accounts.

## **NOTE H – TAX STATUS**

The Internal Revenue Service (IRS) issued a standard prototype profit sharing opinion letter to Principal Life Insurance Company dated March 31, 2017, stating that its prototype plan document was designed in accordance with applicable IRC requirements as of that date. Although the Sponsor has not applied for a determination letter for the Plan and although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **NOTE I – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
