INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Robert Kaufman Co., Inc. Profit Sharing Safe Harbor 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Robert Kaufman Co., Inc. NOTE A - DESCRIPTION OF THE PLAN

The following description of the Robert Kaufman Co., Inc. Profit Sharing Safe Harbor 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

1. General

Effective September 30, 2001, the Board of Directors of Robert Kaufman Co., Inc. adopted the Robert Kaufman Co., Inc. Profit Sharing Safe Harbor 401(k) Plan. The Plan is a contributory profit sharing plan which was established for the benefit of all employees of Robert Kaufman Co., Inc. (the "Employer") and meets all requirements for contributory profit sharing plan qualification under Sections 401(a) and 401(k) of the Internal Revenue Code (IRC).

2. Eligibility

An employee is eligible for participation in the Plan on quarterly entry dates of January 1, April 1, July 1, and October 1 upon the completion of one year of service. Leased employees and nonresident aliens are not eligible to participate in the Plan.

3. Contributions

Participants may elect to contribute, on a tax-deferred and after-tax Roth basis, up to 100% of compensation up to the maximum deferral amount set by Section 402(g)(1) of the IRC. Additional "catch-up" contributions may be made beginning in the plan year in which a participant will be at least age 50 by the end of the plan year.

The Employer may make a safe harbor contribution equal to 3% of eligible compensation or may elect to make discretionary matching and discretionary non-elective profit sharing contributions ("discretionary contributions") to the Plan. No Employer contributions were made to the Plan for the year ended December 31, 2024. The Employer made corrections to participant accounts for Employer discretionary non-elective profit sharing contributions related to plan years ended December 31, 2023 and 2022 in the amount of \$6,048 during the year ended December 31, 2024.

4. Investment Options

Upon enrollment in the Plan, a participant may direct their contributions and Employer contributions, as desired, in any of a variety of investment options held by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (collectively "Empower"), the custodians, as provided by the Plan. Participants may change their investment options daily.

5. Participant Accounts

Each participant's account is credited with the participant's contribution, the Employer safe harbor and discretionary matching contributions, if any, and allocations of the discretionary Employer non-elective profit sharing contribution, if any, and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

6. Forfeitures

Forfeitures of terminated participants' nonvested accounts are applied against future Employer contributions at the Employer's discretion. As of December 31, 2024, outstanding forfeitures available totaled \$3,450 and are included in net assets available for benefits. There were no outstanding forfeitures at December 31, 2023.

7. Benefit Payments

Upon termination of employment, a participant is entitled to receive substantially equal installments or a lump-sum amount equal to the value of his or her vested account balance. When a participant attains normal or early retirement age, incurs total and permanent disability, or dies while employed, the participant or their beneficiary, in the case of death, is entitled to 100% of the participant's account balance. Participants may receive distributions for financial hardship, if certain criteria are met. In addition, participants who have attained age 50 may receive an in-service distribution, if certain criteria are met.

8. Plan Termination

Although it has not expressed such intent, the Employer reserves the right, at any time, to terminate the Plan by action of its Board of Directors subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Upon termination of the Plan, further contributions to the Plan will cease and all participants who are affected by such termination will become 100% vested. The assets of the Plan would be distributed to the participants based on each individual participant's interest in the Plan.

9. Notes Receivable from Participants

The Plan permits participants to borrow from their account a minimum of \$500 up to the lesser of 50% of their vested account balance or \$50,000, reduced by the highest outstanding balance of loans from the Plan during the previous twelve months. Participants may have up to two outstanding loans at any time. The loans are secured by the balance in the participant's account. Loans must be repaid within five years with interest at the prime rate plus 2% per annum. Loans for the purchase of a principal residence may be repaid over a longer period of time, as determined by the plan administrator.

10. Vesting

Participant contributions, Employer safe harbor contributions, and actual earnings thereon are fully vested at all times. However, vesting of Employer discretionary contributions portions of participant accounts, plus actual earnings thereon, is based upon the participant's years of service with the Employer as follows:

1. Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting.

2. Plan Administration

The Employer is the plan sponsor and the plan administrator. The plan administrator is responsible for carrying out the duties imposed under ERISA.

3. Payment of Benefits

Benefits are recorded when paid.

4. Administrative Expenses

Administrative expenses incurred by the custodians in the performance of their duties are paid from the assets of the Plan. Fees related to the administration of notes receivable from participants and other participant specific fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation in fair value of investments. The Employer may pay other expenses of the Plan. Expenses paid by the Employer are excluded from these financial statements.

5. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

6. Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded as earned on the accrual basis. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

7. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

8. Contributions

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation.

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, dividends and other income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (the custodians of the Plan), qualified institutions.

NOTE D - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE D - FAIR VALUE MEASUREMENTS (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan holds a group annuity contract with Empower Annuity Insurance Company of America (“Empower Insurance”), which is an investment that meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus credited interest, less participant withdrawals, and administrative expenses. The following represents the traditional investment contract held by the Plan as of December 31, 2024 and 2023:

The fully benefit-responsive investment contract is backed by Empower Insurance’s general account. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The crediting interest rate may not be less than 0% and is reset quarterly. Although plan participants generally may withdraw assets from the EI Account without restrictions, the custodian may impose a hold period up to 36 months or a market value adjustment on payments due to certain plan-level events. As of December 31, 2024, no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the custodian and that also would limit the ability of the Plan to transact at contract value with the participants.

The Employer is not allowed to offer competing funds unless mutually agreed upon by Empower Insurance and the Employer, in which case amounts withdrawn from the EI Account must be transferred to a noncompeting fund and remain there for at least 90 days before transferring to a competing fund.

NOTE F - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Investments are held with Empower, the custodians of the Plan. Empower Retirement is the recordkeeper of the Plan. Therefore, transactions with these entities qualify as party-in-interest transactions. Notes receivable from plan participants and the related interest income are also considered party-in-interest transactions.

The Plan entered into an agreement with Empower, whereby revenues that Empower would otherwise earn in connection with the services it provides to the Plan are credited to a Plan Expense Account on a monthly basis. These revenue credits may be used to pay reasonable plan expenses. During the year ended December 31, 2024, revenue credits totaled approximately \$58,000 and approximately \$52,000 was used to pay plan expenses. Amounts available in the Plan Expense Account totaled \$49,105 and \$42,248 as of December 31, 2024 and 2023, respectively.

NOTE G - TAX STATUS

The Employer adopted a non-standardized pre-approved profit sharing plan (“pre-approved plan”), which received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the pre-approved plan is designed in accordance with applicable sections of the IRC. The Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Administration errors, if any, which are insignificant or operational in nature, are handled by the plan administrator in accordance with applicable IRS correction policies. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statement of Net Assets Available for Benefits.
