Opinion

We have audited the accompanying financial statements of the Central Missouri Community Action ER 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Notes to the Financial Statements

For the Years Ended December 31, 2024 and 2023

NOTE A: DESCRIPTION OF THE PLAN

The following description of Central Missouri Community Action ER 403(b) Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is the retirement plan provided for employees of Central Missouri Community Action ("Agency").

- 1) General - The Plan was restated effective January 1, 2015. The Plan is a defined contribution plan covering all eligible employees of Central Missouri Community Action. The Plan is subject to the provisions of the Employee Retirement Income Security Act. The Board of Directors is responsible for oversight of the plan.
- 2) Contributions - Each year, participants may contribute as much as they want of pretax or Roth annual compensation, as defined in the Plan, up to IRS limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The employer will contribute an amount between two percent and four percent of gross salary based on the number of years an employee has been employed by the Agency when an employee has accumulated two years of service time (must have 1,000 hours within a twelve month span to qualify for a year of service). This changed during the year to only requiring one year of service time. Roth contributions are allowed.
- 3) Participant Accounts - Each participant's account is credited with the participant's contribution and Agency contributions as stated in 2) above. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- 4) Vesting - Participants are 100% vested upon participation.
- 5) Payment of Benefits - On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account or rollover amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of their account as a lump sum distribution or rollover. The Plan may make a distribution of the participant's account if the value of the participant's vested interest in their plan account is \$7,000 or less. The Plan account may be "cashed out" by distributing the vested interest in their Plan account in a single-sum payment immediately following the date employment terminates. If the value of the participant's vested interest in their Plan account is more than \$7,000, distribution of the Plan account cannot be made before the normal retirement date of the participant without their written consent.

NOTE B: SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accounting records of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at estimated fair value. Fair Value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and Sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Third Party Administrator Duties

Company contributions are held and managed by the Trustee, which invests cash received, interest, and dividend income and makes distributions to participants. Certain administrative functions are performed by officers or employees of the Agency or its subsidiaries. No such officer or employee receives compensation from the Plan.

Payments of Benefits

Benefit payments are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Agency. Expenses that are paid by the Agency are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

NOTE C: TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (Code). The plan administrator and the plan's tax counsel believe that the terms of the Plan have been prepared to conform with the written plan requirements of Regulation 1.403(b)-3 of the Code. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b).

NOTE D: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

NOTE D: FAIR VALUE MEASUREMENTS (Continued)

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and December 31, 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trusts: Valued at the daily closing price of the underlying investments which consist of mutual funds and money market funds. The total number of units of each fund is taken by their closing price to determine the value in the fund. All assets are then combined and divided by the total number of units in the trust to determine the per unit value.

Interest Bearing Cash: valued based on the initial investment plus interest amounts earned and paid to the account. Since it is not traded on an open market, it is valued using inputs that are observable for the asset. Accordingly, the unit value for the interest bearing cash is classified within level 2 of the valuation hierarchy.

Synthetic Cash: The synthetic cash is valued at fair value as of the last day of the Plan year. Fair value approximates contract value and is the total of all amounts allocated under the contract through contributions minus withdrawals and transfers. Amounts allocated to the synthetic cash account become part of the general assets of the custodian. The fixed account supports the obligations of the custodian and consists of all general assets and is guaranteed by the custodian. Accordingly, the investment is classified within the level 3 of the valuation hierarchy.

NOTE E: PLAN TERMINATION

Although it has not expressed any intent to do so, the Agency has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their Plan account.

NOTE F: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE G: RELATED PARTY/PARTY-IN-INTEREST TRANSACTIONS

Ascensus, LLC. is the Plan Administrator as defined by the Plan and is the custodian of plan assets, therefore, these transactions qualify as party-in-interest transactions.

The plan also has the following service providers: Jarred, Gilmore and Phillips, PA is the plan auditor and Central Missouri Community Action is the plan sponsor.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE H: SUBSEQUENT EVENTS

The Plan evaluated events and transactions occurring subsequent to December 31, 2024, through October 14, 2025, the date the financial statements were available to be issued. During this period, there were no subsequent events requiring recognition in the financial statements. Additionally, there were no nonrecognized subsequent events requiring disclosure.
