Note 1 - Plan Description

The following description of Lumin8 Transportation Technologies, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established on January 1, 1990 and restated effective January 1, 2022. The Plan is available to employees of Lumin8 Transportation Technologies, LLC and its subsidiaries, which include employees of the operating entities formerly known as W.L. Contractors, Carlson Construction Services, Wilburn Engineering, and Digital Traffic Systems (collectively, the "Company") who have completed 120 days or more of service with the Company and are at least 18 years of age, excluding nonresident aliens, employees covered under a collective bargaining agreement, and reclassified employees. Plan entry dates are the first day of the month following the date the eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The Company is the sponsor of the Plan. The Company, as provided in the plan agreement, is the plan administrator and has responsibility for the administration of the Plan. Empower Trust Company, LLC (formerly known as Great West Trust Company, LLC) (Empower Trust) and Empower Annuity Insurance Company of America (formerly known as Great-West Life & Annuity Insurance Company) (Empower Annuity) act as trustees and investment managers. Investment management fees and trustee fees are paid by the Plan in accordance with the plan agreement.

Contributions

The Plan provides for employee salary deferral contributions up to a maximum of 100 percent of annual eligible compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan allows participants to contribute up to 100 percent of their compensation on an after-tax basis. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan provides for discretionary employer matching and profit-sharing contributions to participants with at least 120 days of service who have attained the age of 18. Total discretionary employer matching and profit-sharing contributions of approximately \$141,235 were made to the Plan for the year ended December 31, 2024, net of forfeitures.

Certain participant contributions in 2024 were paid after the time frame required by the Department of Labor. The Company remitted these 2024 delinquent contributions during 2024, with the lost earnings related to the delinquent contributions contributed utilizing self-correction during 2025 and 2024.

Certain participant contributions in 2023 were paid after the time frame required by the Department of Labor. The Company remitted these 2023 delinquent contributions during 2023, with the lost earnings related to the delinquent contributions contributed utilizing self-correction during 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of plan losses and administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Note 1 - Plan Description (Continued)

Vesting

Participants are immediately 100 percent vested in employee salary deferrals and rollover contributions and any income or loss thereon. Vesting in the Company's contribution portion of their accounts, plus actual earnings or losses thereon, is based on years of service.

The Company's discretionary contributions (including forfeitures), if any, that are not fully vested when contributed and the earnings and losses thereon vest according to the following schedule:

A participant's account becomes 100 percent vested upon death, attaining normal retirement age (the age of 65), retirement due to disability, or termination of the Plan.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. Participants may have a maximum of one loan outstanding at any given time. The notes receivable are secured by the balance in the participant's account; bear interest at rates that range from 4.25 to 10.50 percent, which are commensurate with local prevailing rates determined periodically by the plan administrator; and mature at various dates through July 2030. Principal and interest are paid ratably through weekly payroll deductions or directly to the trustees.

Benefit Payments

Upon death, disability, termination of service, or retirement, a participant (or the participant's beneficiary in the case of death) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited account balances totaled approximately \$91,000 and \$194,000, respectively.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Empower Trust and Empower Annuity or their affiliates. Empower Trust and Empower Annuity are the trustees of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

The Plan provides for participant notes receivable to participants, which are party-in-interest transactions that are exempt from the prohibited transaction rules.

Note 1 - Plan Description (Continued)

Plan Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation

The Plan's investments are stated at fair value except as noted below. The fully benefit-responsive unallocated contract is valued at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

The common collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. There are no redemption restrictions or unfunded commitments on these investments. All other investments are valued based on quoted market prices reported in active markets. See Note 4 for additional information.

Benefit Payments

Benefits are recorded when paid.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Administrative Expenses

Various administrative costs are paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 10, 2025, which is the date the financial statements were available to be issued.

Notes to Financial Statements

December 31, 2024 and 2023

Note 3 - Certified Information

Empower Trust Company, LLC and Empower Annuity Insurance Company of America (collectively, the "Trustees") hold the Plan's investments and participant notes receivable and execute all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustees.

Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

Note 5 - Investment Contracts

The Plan has a benefit-responsive investment contract with Empower Annuity. Empower Annuity maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a semiannual basis for resetting. When establishing interest crediting rates for this product, Empower Annuity considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer’s general account.

Certain events may limit the ability of the Plan to transact at contract value with Empower Annuity. Such events may include (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) bankruptcy of the Company or other company events (for example, layoffs, divestitures, and spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (3) the failure to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. In addition, certain events may allow the issuer to terminate the contract with the Plan and settle at an amount different from fair value. Such events may include (1) an uncured violation of the Plan’s investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer. The plan administrator does not believe that the occurrence of any such events is probable.

Note 6 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.
