Note 1. Plan Description

The following description of O’Neill Vintners & Distillers 401(k) Plan (the “Plan”) is provided for general information only. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General:

The Plan is a defined contribution plan providing retirement benefits for employees of O’Neill Vintners & Distillers (the “Company”) who are twenty-one years of age or older. The Plan was established on January 1, 2005, and most recently restated on October 1, 2024, by the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions:

Eligible employees of the Company may elect to contribute up to the applicable limits allowed under the Internal Revenue Code. After one year of service the Company makes safe harbor matching contributions equal to 100% of an employee’s salary deferral that does not exceed 3% of their compensation plus 50% of the employee’s salary deferral between 3% and 5% of the employee’s compensation. In addition, the Company may also make discretionary non-elective contributions. The Company made profit sharing contributions of \$274,772 and \$0 for the years ended December 31, 2024 and 2023, respectively. Participants direct the investment of the contributions into various options offered by the Plan.

Participant Accounts:

The trustee of the Plan maintains an account for each participant. Each participant account is credited with the participant’s contribution and allocation of (a) the Company’s contribution and (b) Plan earnings, and charged with an allocation of investment and administrative expenses, not paid by the Company. Allocations are based on participant earnings or account balances, as defined.

Vesting:

Participants are immediately vested in their elective deferral contributions, rollover contributions, the Company’s safe harbor contributions and non-elective contributions plus actual earnings thereon. Participants are vested in the employer matching contributions made prior to 2015 in accordance with the following schedule:

Notes Receivable from Participants:

Participants may borrow from their accounts a minimum of \$1,000 up to the maximum equal to the lesser of \$50,000 (reduced by the highest outstanding loan balance in their account during the prior twelve-month period) or 50% of the vested account balance. Loans are secured by the balance in the participant's account. Principal and interest must be repaid over a period not to exceed five (5) years. Loans used to acquire a principal residence shall provide for periodic repayment over a reasonable period of time that may exceed five (5) years. Interest rates are based on the prime rate plus 2% at the time the loan is made and remain fixed for the duration of the loan. Principal and interest are paid ratably through bi-weekly payroll deductions.

Payment of Benefits:

Upon separation of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account in accordance with the Plan provisions. Similar options are available upon termination of employment. The Plan permits a hardship distribution to a participant prior to and after separation from service in accordance with the Plan's hardship policies.

Administrative Expenses:

Plan investment and trust management fees paid are charged against the Plan's assets, unless otherwise paid by the Company. These fees are allocated to the participants' accounts in the same manner as the allocation of income and loss. Expenses related to specific participant transactions are charged to the respective participant's account. The annual audit and tax fees are paid directly by the Company and are not included in the accompanying financial statements. Investment-related expenses are deducted from investment returns and included in net appreciation in fair value of investments.

Forfeited accounts:

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$17,994 and \$424, respectively. Amounts accumulated in the forfeiture account will be used to reduce future employer contributions and administrative fees. Forfeitures were not used during the years ended December 31, 2024 and 2023.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting:

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition:

The Plan's investments are stated at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date.

Net appreciation in fair value of investments presented on the statement of changes in net assets available for benefits includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note is recorded as a benefit payment based upon the terms of the Plan document.

Benefits Paid to Participants:

Benefits paid to participants are recorded when paid.

Use of Estimates:

The preparation of financial statements is in conformity with accounting principles generally accepted in the United States of America. Those standards require management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results may differ from those estimates.

Date of Management's Review of Subsequent Events:

The Plan has evaluated subsequent events through October 14, 2025, the date on which the financial statements were available to be issued.

Note 3. Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 measurements consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1), and Level 3 measurements are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Level 1 Fair Value Measurements:

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Note 5. Fixed Annuity Contract with Insurance Company

The Plan holds a fully benefit-responsive group annuity investment contract issued by Lincoln National Life Insurance Company. Lincoln National Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Lincoln National Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The methodology for calculating the interest crediting rate for the calendar quarter is determined in advance and is based on numerous factors including interest rate environment, plan level cash flow, and competitive marketplace for both guaranteed products and money market funds. The interest crediting rate is reset quarterly. The average rate earned by the Plan for the benefit-responsive fund is derived by averaging the quarterly gross interest rates for the fund over the year. For 2024 and 2023, the average crediting rate was 2.56% and 2.30%, respectively.

The Plan may transact according to the terms defined in the contract at any time. The Plan has the option to terminate the contract and receive immediate payment, whereas the payout will never be lower than the principal accumulated at the guaranteed minimum interest rate of 1% as specified in the terms of the contract. The guaranteed investment contract may be terminated by the issuer with at least ninety days of advance written notice to the other party.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time subject to the provisions set forth in ERISA and the Internal Revenue Code. Upon termination of the Plan, the total net assets of the Plan are to be distributed to the participants in proportion to their account balances.

Note 7. Related Party and Party-in-Interest Transactions

Certain investments in the Plan are issued by an affiliate of the trustee and recordkeeper; and therefore, these transactions qualify as party-in-interest transactions. Also, during the 2024 and 2023 plan years, the trustees of the Plan provided participant-level services as defined by the Plan and, therefore, these transactions qualify as party-in-interest. These transactions are covered by an exemption from the “prohibited transaction” provisions of ERISA and the Internal Revenue Code.

Participants may borrow from their vested account balance. Such loan transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA and the Internal Revenue Code.

Note 8. Income Tax Status and Plan Amendments

The Plan obtained its latest advisory letter on August 19, 2020, in which the Internal Revenue Service has determined and informed the sponsor of the non-standardized pre-approved plan that the plan and related trust, as then designed, were in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the Plan’s tax returns remain open for three to four years for income tax examination.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.
