### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

I have performed an audit of the accompanying financial statements of the 403(b) Thrift Plan of JAMHI Health & Wellness, Inc. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. **NOTE 1      DESCRIPTION OF PLAN**

The following description of the 403(b) Thrift Plan of JAMHI Health & Wellness, Inc. (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of Plan provisions.

General

The Plan was created on January 1, 1990, and was most recently restated on January 1, 2020. The Plan is a 403(b)-plan covering substantially all employees of Juneau Alliance for Mental Health, Inc. (the Organization). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Organization is the Plan Sponsor and serves as Plan Administrator. The Plan Administrator is responsible for oversight of the Plan, which includes determining the appropriateness of the Plan's investment offerings, and monitors investment performance.

Eligibility

Employees of the Organization are eligible to participate in the Plan at their date of hire. Employees excluded from participating in the Plan include employees who are non-resident aliens with no U.S. source income and those who are eligible to make salary reduction contributions to another plan of the Employer. Eligibility for the Organization's matching and base contributions includes age 18, and completing one year of service, with entry date the first day of each month.

Contributions

Employee deferrals – Participants may elect to contribute pretax and after-tax (Roth) of eligible compensation to the Plan, as defined by the Plan, and subject to certain Internal Revenue Service (IRS) limitations. Participants may also roll over eligible amounts from other qualified plans. Participants aged 50 and over may elect to defer additional amounts ("catch-up" contributions) to the Plan.

Employees of the Organization who are hired on or after August 1, 2021, will be automatically enrolled to the Plan beginning on the first day of the pay period following the employee's hire date. Default withholdings, notwithstanding an affirmative election from the participant, will be made at 3 percent of salary for the initial Plan year that automatic enrollment contributions commenced; 4 percent for the next Plan year; and 5 percent for the next and each subsequent Plan year.

Employer matching contributions – The Organization provides a matching contribution equal to 25 percent of the employee's deferrals, up to a maximum of 6 percent of the employee's eligible compensation. The contribution is paid at each payroll.

Employer base contributions – The Organization provides a base contribution, whether or not the employee makes employee deferrals to the Plan. The Organization's base contribution is fixed at an amount equal to 4 percent of the employee's compensation. The contribution is paid at each payroll.

Participant Accounts

Individual accounts are maintained for each participant. Each participant's respective account is credited with the participant's contributions and Organization matching and base contributions, as well as an allocation of Plan earnings. Participant accounts are charged with withdrawals, and an allocation of administrative expenses that are paid by the Plan, if any. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants direct the investment of their and the Organization's contributions into various investment options offered by the Plan. Participants may move portions of their accounts between investment options at any time and can change their salary deferral.

Vesting

Participants are immediately 100% vested in their deferral contributions, plus actual earnings thereon. A participant is 100% vested in employer matching and base contributions upon completion of 3 years of service, or upon attainment of age 59 ½, whichever comes sooner.

Notes Receivable from Participants

The Plan permits participants to borrow a minimum of \$1,000 up to a maximum of 50% of their vested account balance not to exceed \$50,000. The notes are secured by the balance in the participant's account, and generally have a term of 5 years. The loan interest fluctuates during the term of the loan, and is equal to the credited Interest Accumulation Account (IAA) interest rate, plus 3 percent. Principal and interest are paid ratably through payroll deductions and notes must be fully repaid within five years in accordance with Plan provisions.

Payment of Benefits

On termination of service due to any reason, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or an installment distribution.

Hardship withdrawals are permitted by the Plan. Hardship withdrawals must be approved by the Plan administrator and are limited to amounts of participants' contributions. In-service withdrawals are also permitted by the Plan and are available from all vested account balances.

Forfeitures

At December 31, 2024, and 2023, forfeited non-vested accounts totaled \$6 and \$4,636, respectively. Any balance available in these accounts may be used to reduce future employer contributions to the Plan. Also, for the year ended December 31, 2024, employer contributions were reduced by \$32,940 from forfeited non-vested accounts.

**NOTE 2      SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investments Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive interest accumulation account, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Contributions

Contributions from Plan participants and the Organization are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Organization and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Reclassification

Certain amounts in the prior year's financial statements have been reclassified to conform to the current year presentation. These reclassifications had no effect on the changes in net assets available for benefits or on net assets available for benefits as previously reported.

Subsequent Events

The Plan has performed an evaluation of subsequent events through October 9, 2025, which is the date the financial statements were available to be issued.

**NOTE 3      FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of fair value hierarchy under FASB ASC 820 are described as follows:

Level 2	Inputs to the valuation methodology include: <ul style="list-style-type: none"><li>• Quoted prices for similar assets or liabilities in active markets;</li><li>• Quoted prices for identical or similar assets or liabilities in inactive markets;</li><li>• Inputs other than quoted prices that are observable for the asset or liability;</li><li>• Inputs that are derived principally from or corroborated by observable market data by correlation or other means.</li></ul> If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:*

The net asset value (NAV) is used as a practical expedient to estimate fair value. Investments in pooled separate accounts (PSAs) represent ownership of units of participation (Units), rather than ownership of specific assets. The value of any one PSA is determined by aggregating the value of all the Units held by the Plan. The value of a single Unit is the total value of the PSAs underlying investments plus other assets less liabilities divided by the number of Units outstanding. Investments in the PSAs are valued at a net asset value per share method (unit pricing) which is generally determined by the quoted market price of the underlying investments.

*Interest accumulation account:*

The net asset value (NAV) is used as a practical expedient to estimate fair value. Investments in the interest accumulation account (IAA) represent ownership of units of participation (Units), rather than ownership of specific assets. There are no front- or back-end charges, so investments in the IAA are completely liquid. The interest rate credited to investments in the IAA is a current rate and is not dependent upon the length of time the assets are invested with Mutual of America. Requests for withdrawal can be made at any time and are processed on the day that they are received; they are not dependent on the Plan having to liquidate securities in order to generate payment. The value shown is the redeemable value of the fund; there are no deferred sales charges, loan assessments or interest rate adjustments that would affect the value as a result of a withdrawal request.

**NOTE 4 CERTIFIED INVESTMENT INFORMATION**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends income, for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America Life Insurance Company (the custodian of the Plan), a qualified institution. The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing the information with the information included in the financial statements and supplemental schedule.

**NOTE 5 RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are pooled separate accounts and the interest accumulation account that are managed by Mutual of America Life Insurance Company (MOA). MOA is the custodian as defined by the Plan, and, therefore, these transactions qualify as exempt party-in-interest transactions

The Organization is a party-in-interest to the Plan. However, there were no transactions with the Organization other than employer contributions and the payment of certain administrative expenses on behalf of the Plan. The Plan uses third-party service providers for administration and custodial services. These transactions qualify as exempt party-in-interest transactions.

Loans to participants also qualify as exempt party-in-interest transactions.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100% vested in all their employer contributions.

**NOTE 7 TAX STATUS**

The Organization has adopted a Prototype Non-standardized 403(b) Plan document that has received an opinion letter from the IRS dated March 31, 2017, stating that the form of the pre-approved Plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8      RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
