Notes to Financial Statements

(1) Description of the Plan and Funding Policy

The following description of the Roofers Union Local 30 Combined Health and Welfare Plan (the "Plan"), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General - The Plan is a multiemployer defined benefit health and welfare plan formed under collective bargaining agreements covering both commercial and residential roofing between the Roofing Contractors' Association of Philadelphia and Vicinity (the "Employers"), the Delaware Valley Roofing Contractors' Association, and Roofers Union Local No. 30 (the "Union"), affiliated with the AFL-CIO. The Plan provides health and welfare benefits covering substantially all the members and employees employed under the terms of the collective bargaining agreement between the Employers and the Union. The Plan is administered by a Board of Trustees, comprised of Union officials and management of the employers. The Trustees have overall responsibility for the operation and administration of the Plan, including the appropriateness of the Plan's investment elections and monitoring investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions - Employers of the Plan participants contribute to the Plan on the basis of hours worked.

Funding Policy - Under the terms of the collective bargaining agreement, the Employers are required to make contributions to the Plan on a monthly basis for each hour worked by the participants.

Benefits - The Plan provides hospitalization, surgical, major medical, prescription drugs, dental, vision and other health and welfare benefits through insured and/or a self-administered plan for participants who, as of the first day of the benefit period, worked at least 500 hours in the preceding six months or at least 1,000 hours in the preceding twelve months, provided that they are available for and actively seeking work in covered employment. Benefit periods begin the first day of January and July. The Plan also provides health and welfare benefits to eligible dependents of qualifying participants. Participants are also covered by a life insurance death benefit.

Employers withhold amounts from each employee's gross wages for each hour worked for McCullough Day and credit union benefits. Credit Union deductions are withheld from journeymen and 3rd and 4th year apprentices. Unclaimed benefits are forfeited. The employers remit the credit union withholdings to the benefits office for subsequent deposit in the Philadelphia Credit Union on behalf of each employee. If the employee does not have a credit union account, the funds are retained in the Plan and paid to the employee quarterly without earning any interest. McCullough Day is paid annually on December 15th for amounts accumulated September through August.

(2) Summary of Significant Accounting Policies

Basis of Accounting - The accompanying financial statements are prepared on the accrual basis of accounting.

Adoption of Recent Accounting Pronouncements - Effective January 1, 2023, the Plan adopted ASC 326 which changed how entities will measure credit losses for certain financial assets that aren't measured at fair value through changes in net assets available to benefits. The most significant change in this standard is a shift from the incurred loss model to the expected loss model. Under the standard, disclosures are required to provide users of the financial statements with useful information in analyzing the Plan's exposure to credit risk and the measurement of credit losses. The primary financial asset held by the Plan that is subject to the guidance in ASC 326 is employers' contributions receivable. The impact of the adoption was not considered material to the financial statements and primarily resulted solely in enhanced disclosures.

(2) Summary of Significant Accounting Policies (Continued)

Adoption of Recent Accounting Pronouncements (Continued) - On July 30, 2025, the FASB issued Accounting Standards Update (ASU) 2025-05, Financial Instruments—Credit Losses (Topic 326): Measurement of Credit Losses for Accounts Receivable and Contract Assets. This standard allows entities to elect a practical expedient that assumes that current conditions as of the fiscal year-end do not change for the remaining life of the asset. In addition, the standard provides for consideration of subsequent collections in developing reasonable and supportable forecasts as part of estimating expected credit losses. The Plan elected to early adopt this standard in the reporting period ended December 31, 2024.

Use of Estimates - The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amount of assets, liabilities, benefit obligations and changes therein, incurred but not reported ("IBNR"), eligibility credits, claims payable, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Employer's Contributions Receivable - The Plan's policy is to recognize contributions based on the latest executed collective bargaining agreement on an individual employer basis. Contributions from participating employers are based on an agreed upon hourly rate and are payable to the Plan during the subsequent month. Contributions due but not paid prior to year-end are recorded as contributions receivable. The Plan evaluates participating employers' contributions receivable periodically for potential uncollectible amounts based on the likelihood of collection, including subsequent period collections. As of December 31, 2024 and 2023, the Plan did not record any credit loss allowance for employers' contributions receivable.

The Board of Trustees has established a program to review participating employer records in order to determine compliance with contribution provisions of the collective bargaining agreement. As a result of this program, previously unreported contributions are identified related to current and prior fiscal years. However, due to the collection efforts required by the Plan, including litigation, the ultimate realization of any additional contribution receivable cannot be reasonably estimated until the collection process is completed. Accordingly, the Plan primarily recognizes these previously unreported contributions in the fiscal year in which the settlement proceeds are received.

Payment of Benefits - Benefit payments to participants are recorded upon distribution.

Administrative Expenses - Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. The Plan shares certain administrative expenses with related ERISA plans. In computing these allocated costs, various factors were considered, including the time spent, space used, costs incurred, and volume of transactions relating to the Plan in relation to the other plan.

Certain investment-related expenses are included in net appreciation in fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

Subsequent Events - The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

(3) Benefit Obligations

A benefit obligation has been recognized for active plan participants' medical benefits for eligible participants and their dependents upon retirement. The benefit obligations represent the actuarial present value of the cost of those estimated future benefits that are attributed by the terms of the Plan to employee service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current active plan participants of the Plan. The obligations represent the amounts that are expected to be funded by contributions from the participating employers and from existing assets of the Plan.

Plan obligations at December 31 for claims incurred but not reported are estimated by the Plan's actuary in accordance with accepted actuarial principles based on claims data provided by the Plan's third-party claims administrators. These amounts are paid by the Plan only if claims are submitted and approved for payment.

The obligations for accumulated eligibility credits is estimated by applying the current premium rates for insured benefits and the average cost of benefits per eligible participant for self-insured benefits to the accumulated months of future eligibility earned by active participants.

The foregoing assumptions are based on the presumption that the Plan will continue. If the Plan terminated, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

(4) Fair Value Measurements

Financial Accounting Standards Board ("FASB") *Accounting Standards Codification* ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets of liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Interest Bearing Cash: Valued using amortized cost which approximates fair value.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

U.S. Government Securities: Valued using pricing models maximizing the use of observable inputs for similar securities (Level 2). Valued as the closing price reported on the market in which the security if traded (Level 1).

Corporate Bonds: Valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Transfers Between Levels - The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

The Plan evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits.

(5) Related Party Transactions

Administrative expenses incurred and revenues received jointly by the Roofers Union Local 30 benefit plans (the "Plans") that are allocated among the Plans as follows:

- The salaries and fringe benefits of an employee are allocated based upon their specific time spent on each Plan.
- Revenues from processing fees, late charges and settlements are allocated among the plans based upon their relative amounts of employer contributions.

The net amount of administrative expenses allocated to the Plan at December 31, 2024 and 2023 was \$70,549 and \$59,394, respectively.

(5) Related Party Transactions (Continued)

During the years ended December 31, 2024 and 2023, the employer contribution allocation, to cover administrative expenses, to the Roofers Union Local 30 Combined Retiree Health Plan (the "Retiree Health") was \$928,587 and \$1,338,739, respectively. As of December 31, 2024 and 2023, the Plan was owed from the Retiree Health \$62,427 and \$151,895, respectively.

On February 6, 2023, the Third-Party Administrator ("TPA") providing claim services to the Plan notified the Board of Trustees of certain participant eligibility errors made by the TPA resulting in overpayments of plan benefits. In September 2024, a settlement agreement was finalized between the Plan and the TPA for \$360,050 to settle the amounts owed and release the TPA of any further action.

(6) Commitments and Contingencies

Effective November 1, 2017, the Plan entered into a long-term contract with BeneSys, Inc. (the "third-party administrator") for monthly administrative services through October 31, 2023. Subsequent to this date, the arrangement has been on a month to month basis. For the years ended December 31, 2024 and 2023, the third-party administrator was paid a fee on a monthly basis of \$16,661 and \$16,661, respectively. Third party administrator fees amounted to \$199,503 and \$199,932 for the years ended December 31, 2024 and 2023, respectively.

(7) Tax Status

The Plan obtained its latest determination letter dated January 1, 2013, in which the Internal Revenue Service (IRS) states that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Plan Termination

Although they have not expressed any intention to do so, the Trustees have the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA.

In the event of the termination of the Plan, the Trust funds are to be used to continue the payment of the benefits provided for in the Plan to eligible employees, their dependents and beneficiaries or next of kin and to otherwise effectuate the purpose of the Plan.

(9) Significant Participating Employers

In the event these participating employers were to suspend contributions, the Plan would retain the risk of meeting current plan obligations until the appropriate adjustments were made.

(10) Risks and Uncertainties

Investment Risks - The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statement of Net Assets Available for Benefits.

Actuarial Assumptions - The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates in the near term would be material to the financial statements.

Credit Risk - Cash consists of monies held in interest and non-interest-bearing transaction accounts. The Plan places its cash with a financial institution deemed to be creditworthy. Balances are insured by the FDIC up to \$250,000. At December 31, 2024 and 2023, the Plan's cash exceeded federally insured limits by approximately \$12,630,000 and \$7,525,000, respectively.


