## Report of Independent Auditors

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery,

intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

## Notes to Financial Statements

December 31, 2024

### 1. Description of the Plan

The following description of NNR Global Logistics USA Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering nonunion employees of NNR Global Logistics USA Inc. (the Company) who are scheduled to work more than 1,000 hours during the plan year, except employees who are transferred from Nishi Nippon Railroad Co., Ltd. on temporary assignment in the United States; nonresident aliens; and leased employees. Employees are eligible to participate in the Plan as of January 1, April 1, July 1, or October 1 following the completion of three months of service. Employees not scheduled to work 1,000 hours during the plan year will be eligible to participate upon completion of 1,000 hours. Eligible employees are automatically enrolled in the Plan once they complete three months of service unless they affirmatively decline to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### Contributions

Each year, participants may contribute, via payroll deduction, a portion of their annual compensation, as defined in the Plan, not to exceed the annual Internal Revenue Service (the IRS) limit. Contributions may be made on a pretax or Roth after-tax basis. If automatically enrolled, a participant's deferral is set at 2% of eligible compensation until changed by the participant. The Plan provides for an automatic savings increase program. A participant's pretax deferral percentage will increase by 1% annually until such time as the deferrals reach 10% unless the participant elects to change his or her deferral. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. The Company contributes 100% of the first 2% of compensation that a participant contributes to the Plan (the Matching Contribution). In addition, the Company may make a profit share contribution (the Regular Contribution). The Company's Regular Contribution is allocated to each participant employed by the Company on the last day of the plan year and to participants who were on a Company-approved leave of absence, became permanently disabled, retired, or died during the plan year. The Regular Contribution totaled \$373,654 and \$377,226 for the years ended December 31, 2024 and 2023, respectively.

### 1. Description of the Plan (continued)

#### Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's contributions and allocations of plan earnings, and is charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of his or her respective elected investment options. Allocations of administrative expenses are based on the participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Forfeitures

Forfeited balances of terminated participants' non-vested accounts are used to reduce the Company's future contributions or to pay administrative expenses of the Plan. The balance of forfeited non-vested accounts was \$106,586 and \$26,728 at December 31, 2024 and 2023, respectively. Forfeited balances of \$106,586 and \$26,728 were used to reduce the 2024 and 2023 Regular Contribution, respectively, funded after the Plan's year-end.

#### Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. A participant is vested in his or her Matching Contribution and Regular Contribution based on years of continuous service in accordance with the following schedules:

#### Investment Options

A participant may direct the company and employee contributions in 1% increments in any of the investment options offered by the Plan. Participants may change investment elections for future contributions and transfer funds between investment options at any time.

#### Benefit Payments

Benefits are generally payable upon retirement, death, disability, termination of employment, attainment of age 59 1/2, or financial hardship, as specified in the plan agreement.

Upon termination of service, a participant will receive a lump-sum amount or installments equivalent to the value of the participant's vested accounts, as determined in accordance with the provisions of the Plan. The distributions not reinvested in an approved, tax-deferred retirement account are subject to taxation in accordance with the tax laws.

#### Administrative Expenses

It is the intent of the Company to continue to pay most administrative expenses of the Plan, but if the Company fails to make the payments, or so directs, the Plan may be required to make payments for these expenses.

### 1. Description of the Plan (continued)

#### Participant Loans

Participants may borrow from their accounts in increments of \$1,000 up to a maximum equal to 50% of their vested account balance. Additionally, the loan cannot exceed the lesser of \$50,000 minus the difference between the highest outstanding balance of loans in the past 12 months and the outstanding balance of loans from the Plan on the date the loan is made, or \$10,000. Loan terms range up to five years. A participant may not have more than one loan outstanding at any point in time. The loans are secured by the balance in the participant's account (up to 50% of the participant's vested balance, with any loan under \$10,000 that is greater than 50% of a participant's vested balance requiring additional collateral, such as a second mortgage) and bear interest at the prime rate, as reflected in *The Wall Street Journal* at the date of issuance, plus 1% per year. Principal and interest are paid ratably through payroll deductions over not more than five years. If a participant terminates employment with the Company, the loan will become payable in full. If a participant defaults on a loan, the entire balance will become due immediately and will automatically be treated as a taxable distribution to the participant.

#### Plan Termination

Although it has not expressed any intent to do so, the Company has a right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

### 2. Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

#### Payment of Benefits

Benefit payments to participants are recorded upon distribution.

#### **Notes Receivable From Participants**

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are recorded when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

#### **Investment Valuation and Income Recognition**

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the plan administrator to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

### 3. Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest, dividends, and interest income on notes receivable from participants for the years then ended, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by American Trust Company, the trustee of the Plan.

### 4. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below.

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable, either directly or indirectly, for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in markets that are not active
- Observable inputs other than quoted prices that are used in the valuation of the assets or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

### 4. Fair Value Measurements (continued)

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management’s own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level of input that is significant to the fair value measurement in its entirety.

The following is a description of the valuation techniques and inputs used for each general type of investment measured at fair value by the Plan.

*Money market account:* Valued at cost plus interest, which approximates fair value.

*Mutual funds:* Valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end.

### **5. Tax Status**

The underlying preapproved plan has received an opinion letter from the IRS dated June 30, 2020, stating that the written form of the underlying preapproved document is qualified under Section 401 of the Internal Revenue Code (the Code). Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401 of the Code, and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator has indicated that it will take the necessary steps, if any, to bring the Plan's operations into compliance with the Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **6. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

### **7. Subsequent Events**

Management evaluated subsequent events for the Plan through October 15, 2025, the date the accompanying financial statements were available to be issued.
