INDEPENDENT AUDITOR'S REPORT

To the Administrator of
United Counseling Services 403(b) Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of United Counseling Services 403(b) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for plan benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of United Counseling Services 403(b) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of United Counseling Services 403(b) Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about United Counseling Services 403(b) Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTE A DESCRIPTION OF PLAN

The following description of the United Counseling Services 403(b) Retirement Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of United Counseling Service of Bennington County, Inc. who are eligible immediately upon hire. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan was adopted April 1, 1968.

Contributions

Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan, subject to annual IRS dollar limits (\$23,000 in December 31, 2024 and \$22,500 in 2023, respectively). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The participant must make elective deferrals of at least 2% to be eligible for the Company match contribution. The Company will match 1.5% of a benefit eligible participant's eligible compensation after one year of service and 3% of a participant's eligible compensation after 2 years of service.

Participant Accounts

Each participant's account is credited with the participant's contribution and company match. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately upon entry into the Plan in their account plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their fund accounts a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with prevailing rates as determined by the Plan administrator. Principal and interest are paid directly to the custodian. Notes Receivable to the Plan are measured at their unpaid principal balances plus any accrued but unpaid interest.

NOTE B SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Investment Valuation

At December 31, 2024, the Plan's investments were held in various mutual funds and are stated at fair value. Purchases and sales of investments are recorded on a settlement date basis. Interest income is accrued as it is earned, and dividends are recorded as of the ex-dividend date.

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Payment of Benefits

Benefits are recorded when paid.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles require the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Allowance for Doubtful Accounts

The Plan considers allowance for doubtful accounts to be amounts that would not be collectible by the plan. All notes receivable from participants are secured by vested participant balances. Therefore, there is no allowance for doubtful accounts as December 31, 2024 and 2023.

NOTE C PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will remain 100 percent vested in their accounts.

NOTE D TAX STATUS

The Plan is a volume submitter plan sponsored by Capital Bank and Trust Company, Inc. The document sponsor has obtained an IRS opinion letter on the Plan dated March 31, 2017, stating that the form of the plan is acceptable under Section 401 of the Internal Revenue Code (Code). Generally, the Plan Administrator and the Plan may rely on the opinion letter received by the document sponsor as to the form of the Plan qualifying under the Code (except as otherwise noted in the opinion letter). Additionally, the Plan Administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the Code, and accordingly is tax-exempt.

NOTE D TAX STATUS (continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or derecognize an asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRC. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or de-recognition of an asset) or disclosure in the financial statements. The Plan is subject to routine audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The federal tax returns for the years ended after December 31, 2018, remain open for potential examination by the Department of Labor. The plan administrator believes it is no longer subject to income tax examination for years prior to 2024.

NOTE E RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

The employer, United Counseling Service of Bennington County, provides administrative services to the plan at no charge.

Empower Retirement LLC is an affiliate of Capital Bank and Trust Company, the custodian of the plan. Empower Retirement, LLC performs recordkeeping services for the plan and receives direct and indirect compensation from the plan and therefore, these transactions qualify as party in interest transactions.

NOTE F FAIR VALUE MEASUREMENTS

Fair value measurements establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under are described below:

Basis of Fair Value Measurement

- Level 1 Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2 Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly. (market approach).
- Level 3 Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

NOTE F FAIR VALUE MEASUREMENTS (continued)

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The Trustee for the fund may waive or reduce the 12-month requirement to the extent that the trustee for the fund determines that such waiver or reduction would not negatively impact the Fund or the Participating Trusts. Subject to limitations in the Trust Document for the fund, participants may make withdrawals to make bona fide benefit payments in accordance with the plan provisions, to direct their own investments, to make participant loans, and to pay fees.

The following table presents by level, within the fair value hierarchy, the Plan investment assets at fair value, as of December 31, 2024 and 2023. As required by ASC Topic 820, investment assets are classified in their entirety based upon the lowest level of input that is significant to the fair value measurement.
