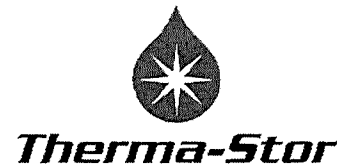

The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Notes to Financial Statements

Note 1: Description of Plan

The following description of the Therma-Stor Union 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees who are included in a collective bargaining unit at Therma-Stor, LLC (the "Employer") who are represented by Sheet Metal Workers Local 565. Participants may enter the Plan on the first day of their employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Each year, participants are allowed to make pretax, after-tax, or combination of pretax/after-tax contributions to the Plan ranging from 1% to 100% of eligible compensation as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also allows participants to roll over distributions from other qualified retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Employer makes a matching contribution equal to 50% of participant contributions up to 6% of eligible compensation. Employer matching contributions totaled \$135,829 for the year ended December 31, 2024. Additionally, active participants receive additional Employer contributions equal to \$0.65 for each hour of service credited to the participant during the period. Additional Employer contributions totaled \$170,689 for the year ended December 31, 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation.

Participant Accounts

Each participant's account is credited with the participant's contributions, Employer contributions, and allocations of plan earnings (losses) and forfeitures of terminated participant's nonvested accounts, if any. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Vesting and Forfeitures

A participant is fully and immediately vested in their contributions plus actual earnings thereon. A participant is vested in additional Employer contributions plus actual earnings thereon after two years of service. A participant is vested in the Employer matching and earnings thereon according to the following schedule:

Less than 2 years	0 %
2 years	20 %
3 years	40 %
4 years	60 %
5 years	80 %
6 or more years	100 %

An active employee becomes 100% vested upon reaching Normal Retirement Age (65), death or disability.

Forfeitures of nonvested participant balances are first used to pay plan expenses or reduce Employer contributions, with any remaining amounts reallocated to remaining participants. Reallocated forfeitures are subject to the same vesting schedule as the Employer matching contributions. Forfeitures used to reduce Employer contributions were \$11,018 and to pay expenses was \$856 for the year ended December 31, 2024. The amount of unallocated forfeitures at December 31, 2024 and 2023 were \$1,652 and \$0, respectively

Notes Receivable From Participants

Participants may borrow from their accounts up to the lesser of \$50,000, reduced by the highest outstanding loan balance during the one-year period ending on the day before the loan is made, or, 50% of the participant's vested balance. The minimum amount of any loan is \$1,000 and loan terms range from one to five years except loans used to acquire a dwelling unit may extend up to 15 years. Loans are secured by the participant's investment accounts and bear interest at rates ranging from 3.25%-9.50%, commensurate with local prevailing rates as determined by the plan administrator. Principal and interest generally is paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account or monthly installments over various periods. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution or leave the account under the Plan. Terminated participants with account balances under \$5,000 are forced paid out in a lump sum. The Plan also permits in-service distributions to participants over the age of 59 ½ or in the case of financial hardship.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Employer and are excluded from these financial statements. Fees related to benefit payments and to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Pooled separate accounts: Investments in pooled separate accounts are valued using a readily available fair value based on the fair value of the underlying securities in which the account is invested. The readily determinable fair value is used if the fair value per share is determined and published and is the basis for current transactions. There are currently no redemption restrictions or unfunded commitments on these transactions.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust funds: Investments in common trust funds are valued using a readily determinable fair value based on the fair value of the underlying securities in which the account is invested. The readily determinable fair value is used if the fair value per share is determined and published and is the basis for current transactions. There are currently no redemption restrictions or unfunded commitments on these investments.

Collective trust funds (Stable value funds): Valued at the NAV of units of an investment trust fund. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value and is based on the fair value of the underlying assets and liabilities of the fund. Fund unit sales and repurchases occur on a daily basis at the NAV per share determined at the close of each business day. The Plan has no obligation to buy any additional units.

Note 4: Information Prepared and Certified by Trustees

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal) and Charles Schwab Trust Bank (Charles Schwab), the Trustees of the Plan. Principal certified as of December 31, 2023 and for the period of January 1, 2024 to July 2, 2024 and Charles Schwab certified for the period of July 1, 2024 to December 31, 2024.

Notes to Financial Statements

Note 5: Party-in-Interest Transactions

Fees paid during the year for administrative services rendered by parties-in-interest were based on customary and reasonable rates for such services. The Plan made direct payments to the third-party administrator Principal and Charles Schwab of \$21,504 and \$2,901 during 2024, respectively. Certain legal, accounting, and administrative expenses relating to the maintenance of the Plan are paid by the Employer. Certain plan investments were managed by affiliates of Principal, a Trustee. Transactions involving these funds are considered transactions with parties-in-interest.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Employer contributions.

Note 7: Tax Status

The Employer adopted a nonstandard pre-approved document with an IRS notification letter which states the pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9: Partial Plan Termination

During October 2023, Plan management determined that the Plan had experienced a partial plan termination for the year ended December 31, 2022. When a partial plan termination occurs, affected participants are to become fully vested. Plan management determined that participants affected by the 2022 partial plan termination had forfeitures deducted from their withdrawals. During the year ended December 31, 2024, the plan received a corrective contribution from the Plan Sponsor of \$85,791 related to the 2022 forfeiture errors. As of December 31, 2023, the Plan has a receivable related the partial plan termination of \$85,791.
