Scope and Nature of the ERISA Section 103(a)(3)(C)

We have performed audits of the financial statements of Boston Red Sox Retirement and Savings Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

Note 1. Description of Plan

The following description of the Boston Red Sox Retirement & Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan, formed on January 1, 2015, is a defined contribution plan established by the Boston Red Sox Baseball Club LP (the Partnership), for the purpose of providing eligible employees of the Partnership with certain retirement benefits in accordance with Sections 401(a) and 401(k) of the Internal Revenue Code (IRC). The Plan was amended and restated on January 1, 2022, and is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Eligibility

All employees of the Partnership, other than employees covered by a collective bargaining agreement, nonresident aliens, leased employees, employees paid on a per game basis, minor league baseball players, and designated coaches and trainers, are eligible to participate in the Plan and receive safe harbor contributions on the first day of the month coinciding with or next following obtaining the age of 21 as defined in the Plan Document. Eligible employees are able to receive employer contributions other than safe harbor contributions, after completing one year of service.

Participant Contributions

Eligible participants may make voluntary pre-tax or Roth contributions through salary reductions from 1% to 100% of eligible annual compensation, as defined by the Plan, limited to the maximum amount allowable under the provisions of the IRC. Further, participants who are 50 years of age or older can contribute an additional "catch up" contribution. The Plan also allows rollover contributions from other qualified plans, as defined in the Plan Document.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a pooled separate account, various mutual funds, and money market funds as investment options for participants.

Employer Contributions

The Plan provides for a safe harbor contribution equal to 3% of each participant's eligible compensation calculated on a pay period basis, a discretionary matching contribution up to 2% of each participant's eligible compensation calculated on an annual basis, and a discretionary non-elective contribution. For the year ended December 31, 2024, the Partnership elected to make the discretionary matching contribution and discretionary non-elective contribution. The discretionary non-elective contribution was equal to 3% of each participant's eligible compensation.

Participant Accounts

Each participant's account is credited with their respective contribution and its allocation of (a) Partnership contributions and (b) Plan earnings or losses.

Vesting

Participants are immediately vested in their contributions, safe harbor contributions and employer matching contributions plus actual earnings thereon. Vesting in non-elective contributions and any earnings thereon is based on the number of years of continuous service as defined in the Plan document. A participant will be 100% vested, based on a cliff vesting schedule, after three years of credited service as defined in the Plan document. In the event of death, disability, or the attainment of age 65, participants' accounts become fully vested.

Benefits

Upon termination of employment, retirement, attainment of age 59 ½, death or disability, the participant or the participant's beneficiary is entitled to receive the vested portion of the participant's account in a single lump-sum or installments, in accordance with Internal Revenue Service ("IRS") regulations and Plan provisions. Further, withdrawals from the Plan before leaving the Partnership are available for special "hardship" reasons, and certain other conditions, as defined in the Plan document. Distributions to participants are recorded when paid.

Forfeitures

The Plan provides that forfeitures, the unvested portion of Partnership discretionary profit-sharing contributions for terminated participants, will serve to reduce future Partnership contributions. As of December 31, 2024 and 2023, the balance in the forfeiture account was approximately \$11,900 and \$9,600, respectively. During the year ended December 31, 2024, forfeitures from employees was approximately \$17,600 and \$15,300 was utilized to fund employer contributions.

Notes Receivable from Participants

Participants may borrow up to 50% of their vested account balance with a minimum of \$1,000 and a maximum of \$50,000. Loans are subject to approval by the plan administrator and the interest rate is set periodically to be in line with current market rates for similar types of loans. Loan terms range from one to five years. However, if the loan is to acquire the principal residence of the participant, the term may be extended to ten years. Loans are secured by the balance in the participant's account. Principal and interest is paid ratably through automatic payroll deductions.

Plan Transfers

During the year ended December 31, 2024, transfers out to related retirement plans of the Partnership, Fenway Sports Management 401(k) Plan and Boston Red Sox 401(k) Plan, totaled \$1,715,600 which included \$51,260 of loans.

Administrative Expenses

All reasonable expenses related to plan administration will be paid from Plan assets, except to the extent the expenses are paid or reimbursed by the Partnership. The Partnership will allocate Plan expenses among the accounts of Plan participants. The Partnership will allocate these expenses either proportionally based on the value of the account balances or pro rata based on the number of participants in the Plan.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and liabilities and changes therein, and when applicable, disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's sponsor determines the Plan's valuation policies utilizing information provided by the trustee. See Note 8 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through October 15, 2025, which is the date the financial statements were available to be issued.

Note 3. Certification of Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Trust Company LLC, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate.

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

Note 4. Related-Party Transactions

Plan investments include mutual funds, pooled separate account and money market funds managed by John Hancock. John Hancock is the trustee, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules, as defined by ERISA. For the year ended December 31, 2024, the Plan paid \$18,990 to John Hancock for administrative fees. For the year ended December 31, 2024, the Plan paid \$938 to its investment advisor.

Note 5. Tax Status

The Plan operates under a non-standardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by John Hancock Trust Company LLC. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified, and the related trust was tax exempt as of the financial statement date.

The Financial Accounting Standards Board has issued a standard regarding the accounting and recognition of income tax positions taken or expected to be taken by the Plan. The plan administrator assesses the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6. Plan Termination

The Plan may be amended or terminated, in whole or in part, by the Partnership, subject to the provisions set forth in ERISA. In the event of any termination of the Plan, the accounts of all participants immediately become fully vested and the Plan assets will be distributed in accordance with the terms of the Plan.

Note 7. Risks and Uncertainties

The Plan provides for various investment options in accounts which invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that these changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Note 8. Fair Value Measurements

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs. Valuation techniques used to measure fair value are defined as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2** Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the assets or liabilities; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market funds: Valued at the closing price reported by the fund sponsor from an actively traded exchange.

Pooled separate accounts: The fair value of the pooled separate accounts is determined by the fair value of the underlying mutual funds or stocks and fixed income securities. The fair value of the underlying securities is based on quoted prices of similar assets.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
