Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Nexdine, LLC 401(k) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Nexdine, LLC 401(k) Profit Sharing Plan & Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion



1. Description of the Plan

The following description of the Nexdine, LLC 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Nexdine, LLC (the “Employer” or the “Plan Administrator”). Employees are eligible to voluntarily participate in the Plan after completing three (3) months of service and have attained the age of 18 years. After completing one year of eligible service, employees are eligible for the employer matching contribution. After completing two years of eligible service, employees are eligible for the employer profit sharing contribution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each participant may contribute up to 100% of his or her compensation as defined in the Plan, or the amount allowed by the Internal Revenue Service (up to a maximum of \$23,000 in 2024 or \$30,500 for participants who are at least fifty years of age). On behalf of each participant, the Employer makes a fixed matching contribution equal to (i) 100% of the matched employee contributions that are not in excess of 2% of the Plan compensation, plus (ii) 50% of the amount of the matched employee contributions that exceed 2% of the Plan compensation but that do not exceed 3% of the Plan compensation. Contributions are subject to certain limitations and are recorded on a pre-tax or post-tax basis.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, and allocations of (a) the Employer’s contribution and (b) Plan earnings, and charged with an allocation of administrative expenses.

Employer Profit Sharing Contributions

The Employer has a discretionary profit-sharing plan and the contribution is at the complete and sole discretion of the Employer and may vary from year to year.

Forfeitures

The Plan provides that forfeited non-vested accounts are used to offset Employer contributions. Forfeitures were immaterial to the Plan as a whole as of December 31, 2024 and for the year then ended.

Vesting

Participants are vested immediately in their contributions, any Qualified Non-Elective Employer Contributions and discretionary profit-sharing contributions, plus actual earnings thereon. Vesting in the employer’s discretionary matching contribution portion of their accounts is based on years of service. A participant is 100% vested after five or more years of credited service in accordance with the following schedule:

Participant Notes Receivable

Participants may borrow from their fund accounts to a maximum equal to the lesser of \$50,000 or 50% of their account balance, whichever is less. The notes receivable from participants are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Interest rates on outstanding notes receivable from participants range from 4.25% to 9.50% at December 31, 2024. Principal and interest are paid ratably through weekly payroll deductions.

Payment of Benefits

On termination of service due to retirement, termination of employment, death or permanent or total disability, a participant will receive a lump sum distribution or installment payments.

2. Summary of Significant Accounting Policies

Basis of Accounting

The following accounting policies, which conform with accounting principles generally accepted in the United States of America ("GAAP"), have been used consistently in the preparation of the Plan's financial statements.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and disclosure of contingent assets and liabilities at the date of the financial statements, as well as the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Notes Receivable from Participants

Loans to participants are measured at their unpaid principal balance plus any accrued and unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024. If a participant ceases to make a loan repayment and the Plan administrator deems the notes receivable from participant to be in default, the notes receivable from participant balance is reduced and a benefit payment is recorded.

Benefits to Participants

Benefits are recorded when paid.

Basis of Fair Value Measurement

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

2. Summary of Accounting Policies (continued)

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below.

Basis of Fair Value Measurement (continued)

Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

Level 3: Prices or valuations that require inputs that are both significant to the fair value measurements and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the prices that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Pension Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Income Taxes

The Plan evaluates all significant tax positions as required by generally accepted accounting principles in the United States. As of December 31, 2024, the Plan does not believe that it has taken any tax positions that would require the recording of any additional tax liability nor does it believe that there are any unrealized tax benefits that would either increase or decrease within the next twelve months. The Plan's income tax returns are subject to examination by the appropriate taxing jurisdictions. If the plan was to incur interest and penalties on uncertain tax positions, such amounts would be reflected as income tax expense on the statement of changes in net assets available for benefits. No interest or penalties were recognized during the year ended December 31, 2024.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. During the year ended December 31, 2024, the Plan changed its third-party administrator from Principal Financial to Human Interest. The change did not have a material effect on the Plan's net assets available for benefits or the changes therein.

Subsequent Events

The Plan has evaluated all subsequent events through October 15, 2025, the date the financial statements were available to be issued. Management did not identify any events requiring adjustment to or disclosure in the financial statements.

3. Fair Value Measurements

Investments in registered investment companies of \$3,893,796 and \$2,652,040 as of December 31, 2024 and 2023, respectively, are measured at fair value using the daily closing price as reported by the investment. The registered investment companies are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded. As such, investments in registered investment companies are included in Level 1 of the fair value hierarchy described in Note 2, *Basis of Fair Value Measurement*.

Investments in pooled separate accounts of \$0 and \$54,877 as of December 31, 2024 and 2023, respectively, are measured at fair value using net asset value per share based on the fair value of the underlying investments. In accordance with Financial Accounting Standards Board Standards Codification Topic 820-10, such investments are not required to be classified within the fair value hierarchy described in Note 2, *Basis of Fair Value Measurement*.

4. Information Prepared and Certified by Trustee

The following is a summary of investment information regarding the Plan as of December 31, 2024 and 2023 and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedule, that was prepared or derived from information prepared by Matrix Trust Company ("Matrix") and Delaware Charter Guarantee and Trust Company, the trustees of the Plan, and furnished to the Plan administrator. The Plan administrator has obtained certification from the trustees that such information is complete and accurate.

5. Party-in-Interest Transactions

In the prior year, certain Plan investments were shares of pooled separate accounts managed by the plan custodian. Additionally, the Plan makes loans to participants. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit and market risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statement of net assets available for benefits.

7. Tax Status

Pursuant to an adoption agreement of the prototype plan offered by The MandMarblestone Group, LLC (the "TPA"), on which the Internal Revenue Service determined and informed the TPA by letter dated March 31, 2014 that the prototype plan was qualified under IRC Section 401(a), the Plan administrator and the Plan's tax counsel believe that the Plan is qualified under IRC Section 401(a). The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

8. Plan Termination and Amendment

Although the Employer has not expressed any intent to do so, the Employer has the right, under the Plan agreement, to discontinue contributions and terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their employer contributions.

9. Use of Service Organizations

The Plan utilizes Human Interest to process transactions, maintain participant account balances, and hold plan investments. The Plan's management has obtained and reviewed the service auditor's report on the design and operating effectiveness of controls at Human Interest (SOC 1, Type 2 report), covering the period of January 1, 2024 to December 31, 2024. Management has also considered user entity controls identified in the SOC 1 report and implemented complementary procedures where required.

Based on its review, management has determined that the controls at the service organization, together with the Plan's own complementary user controls, provide reasonable assurance that plan transactions are processed completely and accurately. No material issues were noted in the SOC 1 report that would have a significant impact on the Plan's financial statements.

10. Participant Count

In accordance with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the number of participants with account balances as of December 31, 2024, is disclosed on Form 5500. The methodology used to determine the participant count for purposes of the Form 5500 may differ from the methodology used in preparing the financial statements, which presents only those participants with account balances.
