We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Emphasis of Matter

Portions of the employer contribution for 2024 remain outstanding as of the date these financial statements were available to be issued. Accordingly, the outstanding contribution was not deducted on the Plan sponsor's income tax return. The employer has made a commitment to compensate the plan and its participants for any potential lost earnings due the delinquent contributions.

Other Matters – Supplemental Schedule Required by ERISA

The supplemental Schedule H, Line 4i-Schedule of Assets (Held at End of Year) and Schedule H, Line 4a – Schedule of Delinquent Participant Contributions as of December 31, 2023, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Kansas Medical Center Profit Sharing/401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Emphasis of Matter

Portions of the employer contribution for 2024 remain outstanding as of the date these financial statements were available to be issued. Accordingly, the outstanding contribution was not deducted on the Plan sponsor's income tax return. The employer has made a commitment to compensate the plan and its participants for any potential lost earnings due the delinquent contributions.

Other Matters – Supplemental Schedule Required by ERISA

The supplemental Schedule H, Line 4i-Schedule of Assets (Held at End of Year) and Schedule H, Line 4a – Schedule of Delinquent Participant Contributions as of December 31, 2023, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. Description of the Plan

The following description of the Kansas Medical Center, LLC Profit Sharing/401(k) Plan and Trust (the Plan) provides only general information. Participants should refer to the *Summary Plan Description* for a more complete description of the Plan's provisions, which is available from the plan administrator.

General

The Plan is a defined contribution plan covering substantially all employees of Kansas Medical Center, LLC and subsidiaries (collectively the Company). Employees are eligible to participate in the deferral and after-tax Roth portion of the Plan as of the first calendar quarter following date of hire and attainment of age 18. Participants are eligible for employer contributions the first calendar quarter coincident with or immediately following the date in which they have completed one year of eligible service and have attained age 18. One year of eligible service for this purpose is 12 consecutive months from the employment date during which the employee worked at least 1,000 hours.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was originally adopted on October 1, 2006, and was most recently restated effective January 1, 2022. Effective February 25, 2022, the Plan was amended for a change in individual discretionary Trustees. The Plan's Trustees determine the appropriateness of the Plan's investment offerings and monitor investment performance.

Contributions

Participants may elect to make pre-tax or after-tax Roth contributions equal to a specified percentage up to 100% of their compensation per scheduled pay period up to the maximum allowed by law. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes an annual nonelective safe harbor contribution in the amount of 3% of each participant's compensation. In addition, the Company may make a discretionary matching contribution equal to the participant's contribution up to a certain percentage of their annual compensation provided the participant is still employed as of the last day of the year and has at least 1,000 hours of service. Participants not employed on the last day of the year due to death, disability or retirement are eligible to receive the discretionary matching contribution. For the year ended 4, the discretionary matching percentage approved by the Board of Directors of the Company is 100% of deferrals up to a maximum of 1%. The Company contributions are invested in the same options and allocation percentages elected for the participant contributions. These contributions are made in cash and are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's contributions as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and the Company nonelective safe harbor contribution plus actual earnings thereon. Vesting in the Company discretionary matching contribution plus earnings thereon is based on years of eligible service with the Company as follows:

Notes Receivable from Participants

Participants may request a loan against their account in a minimum loan amount of \$1,000 to a maximum loan amount of the lesser of \$50,000 or 50% of the participant's vested account balance. A participant may not have more than one loan outstanding at any time. The loans are secured by the balance in the participant's account and bear interest at a fixed rate of 2% above the prime rate. Principal and interest is paid ratably through bi-weekly payroll deduction. Participants are charged for any related loan fees.

Payment of Benefits

On termination of service, a participant may elect to receive the value of the vested interest in his or her account as a lump sum distribution. Accounts less than \$5,000 are subject to automatic cash-out provisions. In-service distributions are permitted for participants who are at least 59 ½ years of age. Hardship withdrawals are also permitted for participants regardless of age within the scope of IRS regulations.

Forfeited Accounts

Forfeitures occur at the earlier of the distribution of the entire vested portion of the participant's account or five consecutive one-year breaks in service. Forfeitures totaled \$40,829 for the year ended December 31, 2024, and are used to reduce employer contributions. The remaining forfeiture account balance as of December 31, 2024 and 2023, was \$43,321 and \$2,959, respectively.

Administration of the Plan

The Plan's assets are held in custody by either Nationwide Trust Company, FSB or Nationwide Life Insurance Company. Recordkeeping services are provided by Nationwide Financial Services, Inc. Third-party administration and advisory services are provided by Keating & Associates, Inc. and its affiliates. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Trustees determine the Plan's valuation policies using information provided by the investment advisors, custodian and recordkeeper. See Note 4 for discussion of fair value investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends, if any, are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. All investments held by the Plan are considered to be participant directed investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits paid to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid by the Company. Any expenses paid by the Company are excluded from these financial statements. Fees related to the administration of benefits paid to participants, notes receivable from participants, and other recordkeeping and administration services are charged directly to the participant's account and are included in administrative expenses. Asset-based investment expenses are included in net depreciation in fair value of investments, while advisory services are charged to administrative expenses and allocated to participant accounts.

3. Information Certified by Asset Custodians (Unaudited)

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the asset custodians have certified that the following data included in the financial statements and supplemental schedule is complete and accurate.

The following information was certified by Nationwide Trust Company, FSB and Nationwide Life Insurance Company, the asset custodians, as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Investment income, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024;
- Assets presented in Schedule H, Line 4i – schedule of assets (held at end of year) as of December 31, 2024.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Money Market and Mutual Funds: Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Group Annuity Contract with Nationwide Life Insurance Company

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Nationwide Life Insurance Company, the Nationwide Fixed Select Option, totaling \$1,388,742 and \$1,351,295 as of December 31, 2024 and 2023, respectively. Nationwide Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer and may not be less than .5%. The crediting rate is reviewed on a quarterly basis for resetting.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Nationwide Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

5. Group Annuity Contract with Nationwide Life Insurance Company (Continued)

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

6. Related-Party and Party in Interest Transactions

Nationwide Financial Services, Inc. and its affiliates, including Nationwide Trust Company, FSB and Nationwide Life Insurance Company provide asset custody and recordkeeping services to the Plan. Keating & Associates, Inc. provides third-party administration services and Keating Financial Advisory Services, Inc. provides investment advisory services to the Plan. Regier, Carr & Monroe, LLP provides audit services to the Plan. The Plan paid fees to these entities for the services described during the year ended December 31, 2024. Fees paid for these services qualify as exempt party in interest transactions and are included in administrative expenses in the statement of changes in net assets available for benefits.

The 2023 employer contribution receivable in the amount of \$326,151 was in transit to the plan at December 31, 2024. It was received and recorded by the plan on January 3, 2025.

The 2024 employer contribution receivable in the amount of \$291,485 was not remitted to the plan as of the date these financial statements were available to be issued. The Company has expressed an intent to remit the remaining 2024 employer contribution receivable of \$291,485 by December 31, 2025.

The Company committed to make an additional payment to the Plan for lost earnings of the participants due to the delinquent payment of the employer contributions as described above. The total amount estimated for lost earnings as of December 31, 2024 and 2023 was \$94,114 and is presented as other receivables in the statements of net assets available for benefits. Similar to the 2023 employer contribution receivable, payment of this amount by the Company was in transit to the plan at December 31, 2024. It was received and recorded by the plan on January 3, 2025.

8. Income Tax Status & Contingency

The Company has adopted a non-standardized pre-approved plan sponsored by Keating & Associates, Inc. The IRS determined and informed the pre-approved plan by letter dated June 30, 2020, that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing jurisdictions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Income Tax Status & Contingency (Continued)

Certain employer contributions have not been timely deposited to the Plan as required by applicable sections of the IRC for the contributions to have been deducted by the plan sponsor relative to the Plan year, or as required by the Plan document, including its safe harbor provisions. As such, the Plan has not operated in compliance with the applicable requirements of the IRC which, if not corrected, could be treated by the IRS as a qualification failure. The plan administrator has taken steps to correct these issues through approved methods for previous year delinquent contributions and plans to do so for the current year delinquent contribution, and, therefore, believes the Plan will retain its tax-qualified status and recognition of a contingency is not required. See Note 7 for additional information.

9. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

10. Risks and Uncertainties - Investments

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

11. Correction of an Error

During the year ended December 31, 2024, the Company discovered that a participant contribution from a member owner of the Company of \$11,250 had not been recorded by the plan at December 31, 2023. The financial statements have been revised to reflect this correction. This correction resulted in the following corrected balances as reflected on the Statement of Net Assets Available for Benefits as of December 31, 2023:
