Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

I have performed audits of the financial statements of METALfx Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Metalfx Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), my audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. NOTE 1 – DESCRIPTION OF PLAN

The following description of the METALfx Retirement Savings Plan “the Plan” provides only general information. The Plan’s sponsor is Advanced Manufacturing and Development, Inc., dba Metalfx, “the Company.” Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a single employer defined contribution retirement plan. All employees of the Company are eligible to participate on the first day of the month following three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 “ERISA”. The Plan was established on January 1, 1994 to provide retirement benefits for the employees of the Company. The Plan was amended and restated to the Empower Retirement, LLC Defined Contribution Pre-Approved Plan on September 20, 2021, in order to bring the plan into compliance with the requirements of the 2017 Cumulative List (Notice 2017-37). The Plan Sponsor’s Board of Directors is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Plan Sponsor’s Board of Director’s.

Eligibility – Employees of the Company become participants on the first of the month after, or coinciding with, completing three months of service.

Contributions – Each year, participants may contribute up to 90% of pre-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Deferral contributions are subject to a maximum limitation as provided in the Internal Revenue Code. The maximum contribution of pretax compensation that a participant could defer in 2024 was \$23,000, and the maximum catch-up additional deferral for participants who reached the age of fifty by the end of the 2024 plan year was \$7,500.

The Plan includes an automatic-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan on their entry date unless they affirmatively elect not to participant in the Plan. Automatically enrolled participants have their deferral rate set at 4 percent of eligible compensation and their contributions invested in a target date collective trust fund until changed by the participant.

Effective January 1, 2024, the Plan was amended to add automatic deferral increases of 1% every January 1st to a maximum of 6% of gross compensation. The increases apply to participants who have not made a positive deferral election and commence on the second January 1st subsequent to the start date of the automatic deferrals.

NOTE 1 – DESCRIPTION OF PLAN (continued)

The Company has elected to make Safe Harbor enhanced match contributions equal to 100% of the first 4% of eligible compensation that participants contribute to the Plan each pay period. During the year ended December 31, 2024, the Company contributed Safe Harbor enhanced match contributions totaling \$389,824. Approximately \$19,183 and \$0 of employer contributions were receivable at December 31, 2024 and 2023, respectively.

Investment Elections – The participant contributions and the company contributions are allocated to the various investment options offered by the Plan as directed by participants.

Participant Accounts - Each participant's account is credited with the participant's contribution and Company's contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's accounts.

Vesting - A participant is always fully (100 percent) vested in his or her salary reduction account, rollover contribution account, and employer safe harbor contributions, plus actual earnings thereon. Participants also immediately vest 100% in discretionary employer match contributions.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms range from one to five years. The plan sponsor sets the interest rate based on the prime rate. The loans are secured by the balance in the participant's account. A participant may only have one loan currently outstanding at a time from the Plan. A participant's account is charged monthly interest on the outstanding loan balance.

Principal and interest is paid ratably through payroll deductions. In 2024, the interest rates on loans ranged from 3.25% to 8.50% per annum. The loans mature on various dates through November 25, 2029.

Payment of Benefits - On termination of service or attaining the age of 59 ½, a participant may elect to receive a lump-sum amount equal to the value of the vested portion of his or her account. For termination of service, if a participant's balance is less than \$5,000, a participant will receive a mandatory lump-sum distribution of the vested interest in his or her account. Mandatory distributions exceeding \$1,000 are subject to an automatic rollover into an individual retirement account (IRA).

Participants with certain immediate and heavy financial needs are allowed hardship distributions of their balances of deferral contributions.

Forfeited Accounts – Forfeitures of the nonvested portion of terminated participants' accounts may be used to pay reasonable plan expenses or reduce employer contributions. Available forfeitures totaled approximately \$4,134 and \$4077 at December 31, 2024 and 2023, respectively.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing the information provided by the investment advisers and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits - Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to participant recordkeeping, the administration of notes receivable from participants and benefit distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation or depreciation in fair value of investments.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
Level 2	Inputs to the valuation methodology include: <ul style="list-style-type: none">• Quoted prices for similar assets or liabilities in active markets;• Quoted prices for identical or similar assets or liabilities in inactive markets;• Inputs other than quoted prices that are observable for the asset or liability;• Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the assets or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Mutual Funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. These investments are reflected as Level 1 because the inputs used to determine fair value are quoted prices in an active market.

GWI Fixed Account-Series Class I

The GWI Fixed Account-Series Class I investment option is a general account product of Empower Annuity Insurance Company of America. Although the investment option is benefit responsive for participant-initiated transactions, the Plan's contract with Empower is not considered fully benefit responsive because there is a provision in the investment contract that prevents the immediate and full payout of the contract value for plan-initiated transactions. The fair value is reported daily based on a discounted cash flow valuation methodology where the interest rate for this portfolio investment contract is reset at least as frequently as annually. Using this methodology, the fair value approximates contract value. This investment is considered Level 2 because the inputs used to determine fair value are not quoted prices in an active market, but there are observable inputs.

Collective Investment Trusts

Collective Investment Trusts (CIT) are valued at the net asset value per unit (NAV) of the collective investment trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the CIT less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchase and sales) may occur daily.

NOTE 4 – INFORMATION CERTIFIED BY THE PLAN’S TRUSTEE

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Trust Company, LLC, the directed trustee of the Plan, and Empower Annuity Insurance Company of America.

NOTE 5 – RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

The investment in the GWI fixed account is a general account product of Empower Annuity Insurance Company of America, the parent company of Empower Trust Company, LLC. Empower Trust Company, LLC is the directed trustee as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Indirect fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment.

The Plan made direct payments to Empower Annuity Insurance Company of America totaling \$15,227, and a financial advisor totaling \$989 during the year ended December 31, 2024. The Plan Sponsor pays directly any other fees related to the Plan’s operations.

NOTE 6 –PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 7 – TAX STATUS

The Empower Trust Company, LLC Defined Contribution Pre-Approved Plan Basic Plan Document #2 received a determination letter on November 14, 2022 informing Empower Trust Company, LLC that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code, and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service and state taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 – OPERATIONAL ERROR

The Company missed matching and remitting into the Plan approximately \$16,136 of employer enhanced safe harbor match contributions during the 2024 plan year. The missed contributions, plus lost earnings of \$3,047, have been included in employer contribution receivables at December 31, 2024.

NOTE 9 – RISKS AND UNCERTAINTIES

The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market fluctuations and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

NOTE 10 - RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

In accordance with generally accepted accounting principles, the financial statements include participant loans that are deemed distributed. For tax reporting purposes, these loans are considered distributed and are no longer included in participant loans. This results in differences between the financial statements and Form 5500.
