NOTES TO FINANCIAL STATEMENTS

Note 1. Plan Description

The following description of Scientific Specialties, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General:

The Plan is a defined contribution plan covering non-union employees of Scientific Specialties, Inc. (the “Company”). The Plan’s original effective date was January 1, 1995 and most recently restated for the Cycle 3 Restatement effective January 22, 2021. Effective July 1, 2024 the Plan was amended to revise the eligibility criteria for participant deferrals where the required service period was reduced from one year to 90 days. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions:

Eligible employees of the Company may elect to contribute up to the applicable limits established annually by the Internal Revenue Service. Effective January 1, 2019, the Company makes safe harbor matching contributions equal to 100% of employee salary deferrals up to 3% of their compensation, plus a 50% match of employee salary deferrals of the next 2% of their compensation. In addition, the Company may elect discretionary profit sharing contributions. The Company did not make profit sharing contributions for the years ended December 31, 2024 and 2023. Participants direct the investment of the contributions into various options offered by the Plan.

Vesting:

Participants are immediately vested in their contributions and the Company’s matching contributions and actual earnings thereon. Discretionary profit sharing contributions are vested at 20 percent per year over five years. A participant is 100 percent vested after 5 years of credited service, after reaching normal retirement age, or upon death or disability.

Participant Accounts:

The recordkeeper maintains an account for each participant. Each participant account is credited with the participant’s contributions and allocations of (a) the Company’s contributions and (b) Plan earnings. Allocations are based on participant compensation or account balances, as defined. The earnings are based on the earnings of the investments selected by the participant. The participant directs the investment of their account into various investment options offered by the Plan. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Note 1. Plan Description (Cont.)

Notes Receivable from Participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance at a reasonable rate of interest. Loan terms range from 1-5 years or in excess of 5 years in limited circumstances. The loans are secured by the balance in the participant's account. Interest rates are based on the prime rate plus 1% at the time the loan is made and remains fixed for the duration of the loan. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits:

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or various options as defined in the Plan. Similar options are available upon termination of employment. The Plan provides a mandatory cash-out on a terminated participant's account with a non-forfeitable balance of less than \$7,000 unless the terminated participant provides rollover instructions. The Plan permits a hardship distribution to a participant prior to and after separation from service in accordance with the Plan's hardship policies.

Administrative Expenses:

Plan investment and trust management fees paid are charged against the Plan's assets, unless otherwise paid by the Company. These fees are allocated to the participants' accounts in the same manner as the allocation of income and loss. Expenses related to specific participant transactions are charged to the respective participant's account. The annual audit and tax fees are paid directly by the Company and are not included in the accompanying financial statements.

Forfeited Account:

Forfeited non-vested accounts totaled \$13,678 and \$7,771 at December 31, 2024 and 2023, respectively. Amounts accumulated in the forfeiture account will be allocated to participants as an additional discretionary nonelective contribution. Forfeitures of \$7,767 and \$15,547 were reallocated to the participants as additional discretionary nonelective contributions during the years ended December 31, 2024 and 2023, respectively.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting:

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition:

The Plan's investments are stated at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date.

Net appreciation in fair value of investments presented on the statement of changes in net assets available for benefits includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participants account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note is recorded as a benefit payment based upon the terms of the Plan document.

Benefits Paid to Participants:

Benefits are recorded when paid.

Note 2. Summary of Significant Accounting Policies (Cont.)

Use of Estimates:

The preparation of financial statements is in conformity with accounting principles generally accepted in the United States of America. Those standards require management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results may differ from those estimates.

Date of Management's Review of Subsequent Events:

The Plan has evaluated subsequent events through October 14, 2025, the date on which the financial statements were available to be issued.

Beginning January 1, 2026, the Plan was amended to include an automatic enrollment feature for newly eligible employees. These employees will be automatically enrolled at a deferral rate of 3% of eligible compensation, unless they elect a different rate or opt out. The Plan was also amended to include an automatic escalation provision, under which the deferral rate will increase by 1% annually, up to a maximum of 5% of eligible compensation, unless the participant elects otherwise.

Note 3. Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 measurements consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1), and Level 3 measurements are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Note 5. Fixed Annuity Contract with Insurance Company

The Plan holds a fully benefit-responsive group annuity investment contract issued by Empower Annuity Insurance Company of America. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower Annuity Insurance Company of America, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset quarterly. The average yield earned by the Plan for the benefit-responsive fund is derived by averaging the quarterly gross interest rates for the fund over the year. For 2024 and 2023, the average yield earned by the Plan was 1.41% and 1.23%, respectively. The actual average yield earned by the Plan for the benefit responsive fund is derived by averaging the Plan's quarterly interest rates. For 2024 and 2023, the actual average yield earned by the Plan was 1.41% and 1.23%, respectively.

The Plan may transact according to the terms defined in the contract at any time, however, certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include the premature termination of the contracts by the Plan, plant closings, layoffs, plan termination, bankruptcy, mergers, and early retirement incentives. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable. The guaranteed investment contract may be terminated by the issuer with at least sixty days of advance written notice to the other party.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time subject to the provisions of ERISA and the Internal Revenue Code. Upon termination of the Plan, the total net assets of the Plan are to be distributed to the participants in proportion to their account balances.

Note 7. Related Party and Party-in-Interest Transactions

Certain investments in the Plan are issued by an affiliate of Empower Annuity Insurance Company of America; and therefore, these transactions qualify as party-in-interest transactions. Also, during the 2024 and 2023 plan years, the custodian of the Plan provided participant-level services as defined in the Plan; and, therefore, these transactions qualify as party-in-interest transactions. These transactions are covered by an exemption from the “prohibited transaction” provisions of ERISA and the Internal Revenue Code.

Participants may borrow from their vested account balance. Such loan transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA and the Internal Revenue Code.

Note 8. Income Tax Status and Plan Amendments

The Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service has determined and informed the sponsor of the non-standardized pre-approved plan that the Plan and related trust, as then designed, were in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the advisory letter, the plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the Plan’s tax returns remain open for three to four years for income tax examination.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.
