**Scope and nature of the ERISA Section 103(a)(3)(C) audit**

We have performed audits of the financial statements of CF Industries Holdings, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. #### NOTE A - DESCRIPTION OF THE PLAN

The following description of the CF Industries Holdings, Inc. 401(k) Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information. The Plan is a defined contribution plan that covers substantially all U.S. employees of CF Industries Holdings, Inc. and its subsidiaries (the Company). The Plan is administered by the Company and the Benefit Plans Committee, consisting of certain Company employees appointed by the Board of Directors of the Company (collectively, the Plan Administrator). Separate accounts are maintained for each participant, with account balances adjusted daily for contributions, forfeitures, market value changes, investment income and chargeable Plan expenses.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Regular employees, as defined in the Plan document, are eligible to participate in the Plan after 60 days of service. Non-regular employees, as defined in the Plan document, are eligible to participate in the Plan 60 days after completing one year of continuous service and 1,000 work hours. Subject to Internal Revenue Service (IRS) and Plan limitations, participants may make voluntary contributions. The Plan provides for 3% automatic enrollment for participants who have not elected to make voluntary contributions, and contributions will automatically increase each year on January 1 by 1% until contributions reach 6%. The Plan provides for Company matching contributions wherein the Company matches participant voluntary contributions up to 6% of base compensation and certain bonuses. Participants are vested in Company matching contributions after two years of continuous service. Participant forfeitures of Company matching contributions are used to pay administrative expenses of the Plan or offset future Company matching contributions.

The Plan was amended effective April 1, 2024, to allow Waggaman Union employees to participate in the Plan upon meeting applicable eligibility requirements. Waggaman Union employees who became participants in the Plan during 2024 had outstanding participant loans totaling \$108,322 that were transferred to the Plan during 2024.

Effective January 1, 2023, the Plan was amended to add certain automatic annual contributions to be made by the Company for those employees who have not actively accrued pension benefits under the CF Industries Holdings, Inc. Pension Plan during the year and were employed on the last day of the year or terminated employment due to death, disability, or after reaching at least age 55 and having completed at least five years of employment. Participants become fully vested in the automatic annual contribution after three years of service. These contributions are a percentage of eligible compensation based on an employee's length of service with the Company as follows:

- 4% for less than 5 years
- 5% for less than 10 years but more than 5 years
- 6% for less than 15 years but more than 10 years
- 7% for 15 or more years of service

Automatic annual contributions of \$13,315,429 and \$12,049,654 are included within the Company contributions receivable reported on the Statement of Net Assets Available for Benefits as of December 31, 2024 and 2023, respectively.

During 2024, there were approximately \$409,000 of forfeitures used to reduce Company matching contributions. At December 31, 2024 and 2023, forfeited accounts held by the Plan totaled approximately \$279,000 and \$311,000, respectively.

Each participant's account is credited with the participant's contributions and an allocation of Company contributions and Plan earnings and is charged with his or her withdrawals, Plan losses and certain fees. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested

account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Upon termination of service (as defined in the Plan agreement), death, disability or retirement, a participant or their beneficiary may receive payment of the vested interest in their account balance as a lump-sum distribution or as a partial withdrawal.

The Plan offers participants the ability to borrow from their vested account balances. The amount of the loan is limited to the lesser of \$50,000 or 50% of the participant's vested account balance. Interest is set at the prime rate at the inception of the loan, and the loan is repaid through payroll deductions over a maximum period of 15 years for loans related to the purchase of a principal residence and five years for all other loans. Participants in the predecessor Terra Industries, Inc. Employees' Savings and Investment Plan (Terra Plan), which allowed loans up to a maximum period of 30 years for the purchase of a principal residence, were allowed to keep the terms of their loans that were effective in the Terra Plan after they transferred to the Plan.

While the Company has not expressed any intent to terminate the Plan, it may do so at any time. In the event of the Plan's termination, all affected participants will become 100% vested in the employer contribution portion of their accounts subject to the provisions of ERISA.

The custodian and trustee of the Plan is Fidelity Management Trust Company (Fidelity).

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures and actual results may differ from those estimates.

***Risks and Uncertainties***

The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value as further described in Note D. Purchases and sales of securities are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are valued at the unpaid principal balances plus accrued unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

***Contributions***

Contributions from participants are recorded bi-weekly from payroll deductions or when loan repayments or rollovers are made by participants. Contributions from the Company are recognized by the Plan in the period to which they relate.

***Payment of Benefits***

Benefits paid to participants are recorded upon distribution.

***Administrative Expenses***

Certain professional, administrative and custodial expenses are paid by the Plan and are included in the statement of changes in net assets available for benefits as a reduction of net investment income or as expenses.

**NOTE C - PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain Plan investments are shares of mutual funds and collective trust funds managed by Fidelity or an affiliate of Fidelity. Fidelity is the custodian and trustee of the Plan, and therefore, these transactions and payment of administrative and investment management fees to Fidelity qualify as party-in-interest transactions. Notes receivable from participants are also party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain administrative expenses of the Plan are paid directly by the Company.

**NOTE D - FAIR VALUE MEASUREMENTS**

Accounting Standards Codification Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

- Level 1 - Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.
- Level 2 - Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3 - Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan:

***Mutual Funds***

The fair values of mutual fund investments with registered investment companies are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

***Collective Trust Funds***

The fair values of participation units in the collective trust funds are based upon the net asset value (NAV) of the fund, as reported by the fund manager as of the Plan's financial statement dates which is supported by recent transaction prices. The collective trust funds provide for daily redemptions by the Plan participants at reported NAV per share, with no advance notice requirement.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
