Independent Auditors' Report

To the Participants and Plan Administrator of
Nasco Pension Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Nasco (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits and of accumulated plan benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in accumulated plan benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for at least one year following the date that the financial statements are available to be issued.

1. Description of Plan

The following description of the Nasco Pension Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined benefit plan which covers majority of the employees of the Nasco Holdings LLC entities of Nasco Healthcare, Inc., Nasco Education LLC, Nasco Sampling LLC, Nasco Agriculture LLC (formerly Nasco-Fort Atkinson, Nasco International, Nasco-Modesto) and Triarco Arts & Crafts (Triarco) (collectively, the Company).

The Plan, as set forth herein, is the amended and restated version of the Nasco Salaried Employees Pension Plan (Salaried Plan) originally effective as of March 25, 1952 as the Aristotle Corporation Pension Plan, which was merged with the Nasco International Hourly Employees Pension Plan (Hourly Plan) and the Southern Life and Health Insurance Company Revised Retirement Plan (Southern Life Plan) on September 10, 2004 (the Merger). The effect of the Merger was to combine the assets and liabilities of the three predecessor plans into one plan without changing the benefits provided to participants and beneficiaries of each of the three predecessor plans. The Plan, as amended and restated, is intended to qualify as a defined-benefit pension plan under Internal Revenue Code (the Code or IRC) Section 401(a). The Plan is maintained for the exclusive benefit of eligible employees and their beneficiaries. The Plan's administrator is responsible for oversight of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Nasco Education LLC is the plan sponsor.

Funding Policy

The Plan's funding policy is for the Company to contribute an amount which will meet or exceed the annual ERISA minimum funding requirement. The minimum funding requirements of ERISA were met in 2024. Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Pension Benefits

Salaried employees of the Company who had completed at least five years of credited service as of January 1, 2006 are entitled to monthly pension benefits beginning at normal retirement age (65) equal to 1.075% of the employee's average monthly earnings times the employee's years of benefit service plus 0.580% of the employee's average monthly earnings in excess of \$600 multiplied by the employee's years of benefit service to a maximum of 35 years. The benefit will be reduced by any benefit earned under the Hourly Plan if the employee transferred from the Hourly Plan to the Salaried Plan prior to January 1, 1994. Effective January 1, 2006, the Plan froze to new entrants and accruals for salaried participants with less than five years of service to the Plan and effective December 31, 2020, the Plan was fully frozen with no increase to the average annual earnings and no additional credited service.

Hourly employees of the Company who have met the five-year vesting requirement are entitled to monthly pension benefits beginning at normal retirement age (65) equal to \$8.00 per month for each year of service completed after December 31, 1978 (May 31, 1981 for Triarco employees) through December 31, 1994, and \$16.00 per month for each year of service completed thereafter, with a minimum monthly pension benefit of \$50.00 per month. Effective January 1, 2006, the Plan froze to new entrants and accruals for hourly participants of the Plan.

Southern Life employees eligible for accrued benefits as of the date the Plan was frozen to new entrants and accruals, May 25, 1992, are entitled to monthly pension benefits beginning at normal retirement age (65) equal to 1% of the employee's final average earnings, multiplied by the employee's years of credited service. The accrued benefit for each participant who was actively employed by Southern Life as of March 1, 1992 was increased by 20% as of the date benefits under the Plan ceased to accrue.

The Plan permits early retirement at reduced monthly benefits from ages 55 to 64, provided at least 10 years of service has been completed for hourly and salaried employees of the Company. The Plan permits early retirement at reduced monthly benefits from ages 55 to 64 for employees of Southern Life, provided at least five years of service have been completed.

Employees may elect to receive their pension benefits in the form of a single sum payment (salaried and hourly employee option), certain life annuity or they may elect to receive their benefits as a joint and survivor annuity payable monthly from retirement, with options providing for reduced payments to a designated beneficiary upon the employee's death. Participants may work past normal retirement, subject to the mutual agreement of the participant and the Company. If employment is terminated before an employee renders five years of credited service, the employee's right to receive the value of their accumulated plan benefit is forfeited.

Death and Disability Benefits

If an hourly or salaried participant of the Company dies prior to retirement after having completed at least five years of credited service, a survivor benefit is paid to the surviving spouse equal to 50% of the amount, which would have been payable to the participant under an actuarially equivalent joint and survivor annuity beginning on the day the participant would have been first eligible to retire. If a participant of the Southern Life Plan dies prior to retirement after having completed at least five years of credited service, a survivor benefit is paid to the surviving spouse equal to 75% of the amount, which would have been payable to the participant under an actuarially equivalent joint and survivor annuity beginning on the day the participant would have been first eligible to retire.

If a participant dies after retirement after having completed at least five years of credited service, the death benefit is paid in accordance with the annuity election chosen by the participant upon retirement.

Salaried active participants of the Company between the ages of 50 and 64 with at least 15 years of credited service are to receive disability benefits, provided that the participant is receiving or is eligible to receive a Social Security disability benefit. Participants of the Southern Life Plan who ceased to be eligible employees after December 31, 1975 and before January 1, 1978, under circumstances entitling them to a disability benefit under the terms of the Southern Life Plan, as amended and in effect at the time they ceased to be eligible employees, are entitled to disability benefits. Disability benefits paid are equal to the normal retirement benefit that the participant has accumulated as of the time the participant becomes disabled. Disability benefits are paid until the normal retirement age at which time disabled participants begin receiving normal retirement benefits computed as though they had been employed until the participant's normal retirement date with no credited service being granted for periods when the participant received a disability benefit.

If a participant of the Company is married when disability benefits begin, the participant's disability benefit will be actuarially adjusted to 50% of the amount that would have been payable to the participant under an actuarially equivalent joint and survivor annuity beginning on the day the participant would have been first eligible to retire. If a participant of the Southern Life Plan is married when disability benefits begin, the participant's disability benefit will be paid in the form elected by the participant, with appropriate spousal consent if necessary.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein; disclosure of contingent assets and liabilities; and the actuarial present value of accumulated plan benefits at the date of the financial statements, and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits payments to participants are recorded upon distribution.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation in fair value of investments in the statement of changes in net assets available for benefits.

Subsequent Events

Subsequent events were evaluated through October 15, 2025, the date the financial statements were available to be issued.

3. Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments, including lump-sum distributions, that are attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died and (c) present employees or their beneficiaries. Benefits under the Plan are based on employees' compensation during each year of credited service. The accumulated plan benefits for active employees will equal the accumulation, with interest, of the annual benefit accruals as of the benefit information date. Benefits payable under all circumstances, such as retirement, death, disability and termination of employment, are included, to the extent they are attributable to employee service rendered to the valuation date. Benefits to be provided via annuity contracts excluded from plan assets are excluded from accumulated plan benefits.

The actuarial present value of accumulated plan benefits is determined by the Plan's independent actuary and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

The computations of the actuarial present value of accumulated plan benefits were made as of January 1, 2024 and 2023. Had the valuations been performed as of December 31, there would be no material differences. The significant actuarial assumptions used in the valuations were:

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Pooled separate accounts are valued based upon the unit values of such pooled accounts held by the Plan at year-end. Unit values are based on the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation or other means. The underlying investments of the pooled separate accounts consist of mutual funds, each of which follows a separate investment strategy. Due to the nature of these pooled accounts, there are no unfunded commitments or redemption restrictions.

5. Information Certified by Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, the Trustee of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024 and the information reported in the supplemental Schedule H, Line 4(j) - Schedule of Reportable Transactions for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

6. Related-Party and Party in Interest Transactions

The Plan's investments are administered under a contract with the Trustee of the Plan. Contributions are held and managed by the Trustee, who invests cash received, interest and dividend income and makes distributions to participants. These transactions are party in interest transactions under ERISA.

As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to various service providers. Additionally, certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. These transactions are party in interest transactions under ERISA.

7. Plan Termination

In the event the Plan terminates, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

1. Annuity benefits that former employees or their beneficiaries have been receiving for at least three years, or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under plan provisions in effect at any time during the five years preceding plan termination.
2. Other vested benefits insured by the Pension Benefit Guaranty Corporation (PBGC) (a U.S. government agency) up to the applicable limitations.
3. All other vested benefits (that is, vested benefits not insured by the PBGC).
4. All nonvested benefits.

Certain benefits under the Plan are insured by the PBGC if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations and may also depend on the financial condition of the plan sponsor and the level of benefits guaranteed by the PBGC.

8. Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 9, 2015, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since the date of the IRS Determination Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

The Plan may hold certain investments that represent 10% or more of the Plan's net assets available for benefits. As of December 31, 2024 and 2023, the Plan held three such investments totaling \$13,937,788 and \$14,796,170, respectively.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
