### ***Basis for Opinion***

### 1. Plan Description

The following description of the Cole's Quality Foods, Inc. Bargaining 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### *General*

The Plan was formed on July 1, 1997 and is a defined contribution plan that covers substantially all bargaining-unit employees of Cole's Quality Foods, Inc. (the Company or Plan Sponsor). Employees become eligible to participate at age 18 and upon completion of six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### *Contributions*

Participant contributions to the Plan are elective and are in the form of payroll deductions up to a maximum of 100% of compensation, as defined by the Plan, not to exceed the maximum annual amount allowed by the Internal Revenue Code (IRC). Participants are automatically enrolled at 3%, unless the participant opts out or changes their deferral. Participants' deferral percentage will be automatically increased each April 1 by 1% up to a maximum of 6%. Participants may also contribute amounts representing distributions from other qualified plans (rollover).

For each Plan year, the Company may provide a matching contribution to the Plan for participants who enter into a salary deferral agreement, under the matching contribution policy. The matching contribution will not exceed \$1,000, annually. Certain participants are also eligible to receive a \$5 contribution per pay period. In addition to the matching contribution, the Company may also elect to make a discretionary contribution on behalf of eligible participants. The amount of these contributions is determined solely at the discretion of the Company. The Company did not approve additional discretionary contributions during 2024 or 2023.

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions, allocations of the Company's matching and discretionary contributions, and Plan earnings, and charged with an allocation of administrative expenses. Allocations to participant accounts are specified by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investment of their account balances into various investment options offered by the Plan. Participants may change the direction of their investment accounts and the manner in which they are invested on a daily basis.

### ***Vesting***

Participants are immediately vested in their elective deferral and rollover contributions plus earnings thereon. Vesting of employer contributions is based on years of service, as shown in the following schedule:

### ***Forfeitures***

Forfeitures can be used to pay administrative expenses or can be applied to reduce employer contributions and are allocated to each participant's account based on the provisions of the Plan. Forfeitures of \$15,304 and \$16,636 were used to reduce employer contributions in 2024 and 2023, respectively. Forfeitures of \$1,101 and \$1,074 were used to pay administrative expenses in 2024 and 2023, respectively. Unallocated forfeitures as of December 31, 2024 and 2023 were \$17,174 and \$16,379, respectively.

### ***Payment of Benefits***

Participants may withdraw amounts from the Plan only after the occurrence of a distributive event and after requesting a distribution. Distributive events include death, the attainment of age 59½, total and permanent disability, termination of employment, and termination of the Plan. Upon termination of employment, participants will receive a lump-sum payment. The Plan does not allow for annuities. The Plan allows for hardship withdrawals of employee pre-tax contributions and rollovers in certain instances.

### ***Administrative Expenses***

Administrative expenses of the Plan are paid by either the Plan or the Company, as provided in the Plan Document. Expenses paid by the Plan are allocated to participants proportionately, based on the value of account balances. Fees incurred as a result of participant withdrawals are charged directly to the participant's account.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (GAAP).

### ***Subsequent Events***

Subsequent events have been evaluated by management through October 14, 2025, the date these financial statements were available to be issued.

On September 10, 2025, the Company notified employees that the Muskegon production facility was immediately ceasing operations. The official closure date of the facility will be November 9, 2025. The Company is currently in the process of evaluating if the closure will result in a partial plan termination for the Plan.

### ***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets and changes therein. Actual results could differ from those estimates.

### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value, except for the guaranteed investment contract, which is stated at contract value. Fair value is the price that would be received to sell an asset (an exit price) in the principal or most advantageous market for the asset in an orderly transaction between market participants on the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### ***Payment of Benefits***

Benefits are recorded when paid.

## **3. Fair Value Measurements**

In accordance with Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, the Plan utilizes a fair value hierarchy for valuation inputs that gives the highest priority to quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The three levels of the fair value hierarchy are described as follows:

*Level 1* - This level consists of quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2* - This level consists of significant other observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data.

*Level 3* - This level consists of significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

There have been no changes in the methodologies used at December 31, 2024 or 2023. The following valuation methodologies were used to measure the fair value of the Plan's investments:

*Mutual Funds* - Mutual funds are valued at quoted market prices in an exchange and active market, which represent the net asset value (NAV) of shares held by the Plan.

*Pooled Separate Accounts (PSAs)* - Units held in PSAs are valued based on the underlying investments (i.e., common stock, mutual funds, short-term securities). While the majority of the underlying asset values are based on quoted prices, the NAV of the PSAs are not publicly quoted. The NAV is reported by the fund managers as of the financial statement date based on recent transaction prices. The NAV is used as a practical expedient to estimate fair value. The NAV would not be used if it was probable that the investment would not be traded at NAV. The PSAs held by the Plan provide for daily redemptions by the Plan at reported NAV with no advance notice requirement. The Plan is permitted to redeem investment units at the NAV on the measurement date. There are no unfunded commitments relating to investments in PSAs.

*Collective Investment Trusts (CITs)* - Units held in CITs are valued at the NAV, as reported by the trustee, which is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the CITs will sell for an amount different than the reported NAV. The CITs held by the Plan provide for daily redemptions by the Plan at reported NAV with no advance notice requirement. The Plan is permitted to redeem investment units at the NAV on the measurement date. There are no unfunded commitments relating to investments in CITs. These are direct filing entities.

The Plan's valuation methods may result in a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Although Plan management believes the valuation methods are appropriate and consistent with the market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 4. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments as of December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company, Principal Life Insurance Company (Principal Life), and Principal Life on behalf of Principal Global Investors Trust Company (collectively, Principal), qualified institutions.

#### 5. Guaranteed Investment Contract

The Plan invests in the Principal Fixed Income Guaranteed Option (PFIGO), a guaranteed investment contract. The PFIGO is a benefit responsive contract entered into with Principal Life. Principal Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The PFIGO is valued at contract value for presentation in the Plan's net assets available for benefits. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal Life, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate will not be less than 0.15% or greater than 3.0%. Such interest rates are reviewed on a semi-annual basis for resetting.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the maturity date. The Plan is required to give a 12-month notice before terminating the contract or a 5% penalty will be assessed against the contract value, as defined by the contract. Currently, Plan management believes the occurrence of an event that would cause the Plan to transact at less than contract value is not probable.

### 6. Related Party Transactions

Certain Plan investments include CITs, PSAs, and a guaranteed investment contract, managed by Principal. Therefore, these transactions qualify as party-in-interest transactions. Administrative fees paid to Principal were \$17,138 and \$15,087 for the years ended December 31, 2024 and 2023, respectively.

### 7. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to completely terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan is terminated, the net assets of the Plan will be allocated for payment of Plan benefits to the participants in order of priority, determined in accordance with ERISA, applicable regulations thereunder, and the Plan Document. In the event of Plan termination, participants would become 100% vested in their accounts.

### 8. Tax Status

The Plan uses a pre-approved plan document sponsored by Principal Life. Principal Life received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the pre-approved plan document, as then designed, satisfied the applicable provisions of the IRC. Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 9. Delinquent Participant Contributions

During the Plan year ended December 31, 2024, participant contributions totaling \$104,866 were not remitted to the Plan within the period prescribed by Department of Labor (DOL) regulations. These transactions constitute prohibited transactions, as defined by ERISA. The Company is in the process of correcting these delinquent contributions.

During the Plan year ended December 31, 2022, participant contributions totaling \$18,754 were not remitted to the Plan within the period prescribed by DOL regulations. These transactions constituted prohibited transactions, as defined by ERISA. The Company corrected the transactions and remitted lost earnings to the Plan in 2024.

### 10. Plan Transfer

During the plan year ended December 31, 2024, as permitted by the Plan, funds totaling \$40,722, were transferred out of the Plan and into the Cole's Quality Foods, Inc. Non-Bargaining 401(k) Plan (an affiliated plan sponsored by the Company). The transfer was based on changes in job status of the employee that correspondingly affected their eligibility to participate in the affiliated plan.
