**Note 1. Description of Plan**

The following description of Aligned Orthopedic Partners 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

***General***

The plan was established effective January 1, 1989 and was amended and restated effective July 3, 2023. The Plan is a defined contribution plan covering all employees of ASC Ortho Management Company, LLC and its controlled affiliates (collectively, the Company) that are age 21 or older. Alerus Financial, N.A. served as trustee of the Plan through July 3, 2023. Effective July 3, 2023, plan assets were transferred to Charles Schwab Trust Bank, the trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is a qualified plan under the Internal Revenue Code (IRC) § 401(a) and 401(k) and is, therefore, exempt from federal income taxes under the provisions of IRC § 501(a).

***Contributions***

Each year, participants may contribute up to 100 percent of pre-tax annual compensation, subject to limitations by the Internal Revenue Service (IRS). Participants may also opt to make after-tax contributions, subject to limitations by the IRS. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make matching contributions. Company matching contributions are equal to a discretionary percentage of participant salary deferrals. For the year ended December 31, 2024, there were no Company matching contributions.

The Company has elected safe harbor provisions, which require a four percent safe harbor employer contributions to all eligible participants based on eligible compensation. Additional profit sharing amounts may be contributed at the option of the Company up to eight percent. Safe harbor and profit sharing contributions were approximately \$1,537,000 and \$276,000, respectively, for the year ended December 31, 2024.

***Participant Accounts***

Each participant's account is participant-directed and is credited with the participant's contributions, employer contributions, if applicable, and allocations of Plan earnings (losses), transaction fees related to notes receivable from participants and distributions, and allocations of administrative expenses. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

***Vesting***

Participants are immediately vested in their contributions and employer safe harbor contributions plus actual earnings thereon. Participants become fully vested in the Company's profit sharing contributions upon retirement at age 65, at death, upon total and permanent disability, or according to the following vesting schedule based on years of service:

Less than 2 years	0%
2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 years	100%

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Each participant may only have one loan outstanding at a time. Loans are secured by the balance in the participant's account and bear interest at a rate commensurate with prevailing interest rates charged on similar loans. Loan repayments are made through monthly payroll deductions. The repayment period of loans cannot exceed five years unless the proceeds are used to purchase the participant's principal residence, in which case longer loan terms are permitted. Notes receivable balances as of December 31, 2024 and 2023, were approximately \$322,000 and \$252,000, respectively.

***Payment of Benefits***

Upon disability, retirement, death, or termination of employment, participants are entitled to the vested benefits in their separate accounts. In addition, in-service withdrawals are permitted when a participant attains age 59 ½. Benefits are paid as lump sum distributions. Hardship distributions are permitted if certain conditions are met.

***Forfeited Accounts***

Forfeitures may be used to reduce employer contributions. No forfeitures were used during the year ended December 31, 2024 to reduce employer contributions. Forfeited non-vested accounts totaled approximately \$41,000 and \$2,000 as of December 31, 2024 and 2023, respectively.

**Note 2. Summary of Significant Accounting Policies**

***Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities at the date of the financial statements. Accordingly, actual results may differ from those estimates.

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with GAAP.

***Notes Receivable from Participants***

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account. If a participant does not make loan repayments, and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. As of December 31, 2024 and 2023, management believes no allowance should be recorded as all loans outstanding have been deemed collectible.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

***Benefits Paid to Participants***

Benefits are recorded when paid.

***Administrative Expenses***

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions are charged directly to the participant's account.

***Subsequent Events***

Management has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.

**Note 3. Fair Value Measurements**

Fair value, as defined under GAAP, is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

The following is a description of the valuation methodologies used for assets measured at fair value:

***Mutual Funds***

The fair value of publicly traded equity shares are based on the closing prices reported on the active markets where the individual securities are traded. The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund.

***Common Collective Trusts***

The Plan invests in stable value collective trust funds for which quoted prices are not available in active markets for identical instruments. The Plan utilizes the net asset value (NAV) provided by the trustee as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of a collective trust fund, the issuers reserve the right to require advanced notification to ensure that securities liquidations will be carried out in an orderly business manner.

***Self-Directed Brokerage Accounts***

The plan allows participants to invest their account balances in any investment desired within certain Plan and ERISA limitations. Participants are allowed to place investments into the self-directed program in addition to or in place of various formal investment programs offered by the Plan. **Note 5. Party In Interest Transactions**

As discussed in Note 2, the Plan paid certain fees related to Plan operations to various service providers. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Fees paid to the trustee by the Plan for administrative services were approximately \$140,000 for the year ended December 31, 2024.

**Note 6. Tax Status**

The Plan has not obtained a determination letter from the IRS stating that the Plan was in compliance with the applicable requirement of the IRC. The Plan is relying on the IRS approval of the prototype plan that it is utilizing. The IRS has determined and informed the document sponsor by a letter dated September 21, 2020 that the prototype plan document was designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' accounts balances and the amounts reported in the statements of net assets available for benefits.

**Note 8. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**Note 9. Nonexempt Transactions**

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. While the Company remitted all employee contributions to the Plan, lost earnings on \$14,598 of contributions were not fully corrected as of December 31, 2024.
