## INDEPENDENT AUDITOR'S REPORT

To the Plan Sponsor and Participants of  
the Loffler Companies, Inc. 401(k) Profit Sharing Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Loffler Companies, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Loffler Companies, Inc. 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from The Standard Insurance Company and Minnesota Life Insurance Company, qualified institutions as of December 31, 2024 and 2023, respectively, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the

Audit of the Financial Statements section of our report. NOTE 1 – PLAN DESCRIPTION

The following description of the Loffler Companies, Inc. 401(k) Profit Sharing Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Background: The employer established Loffler Companies, Inc. 401(k) Profit Sharing Plan (the "Plan") effective April 1, 1996, to provide employee benefits to all employees who have met certain eligibility requirements as described below.

General: The Plan is a defined contribution plan covering all employees who have attained the age of 18 and have completed one month of service. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Contributions to the Plan, which are made by both the employee and the employer, are maintained in separate accounts for each employee. The employee may contribute any amount up to the annual dollar limitation set forth by the Internal Revenue Service. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The employer's discretionary matching contribution is an amount equal to one-half of the employees' contributions, up to 6% of their compensation, plus any amount the employer, in its sole discretion, may designate as a non-elective contribution (profit sharing). Eligible employees for the discretionary contribution must have worked at least 1,000 hours during the plan year and must be employed by the employer on the last day of the plan year. The Plan has elected automatic enrollment of eligible employees at a rate of 3%, increasing by 1% each subsequent year to a maximum of 6%. Employees are able to opt-out if they desire.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting of the employer's contribution portion is based on a top-heavy 6-year graded vesting schedule. An employee must complete at least 1,000 hours of service during each plan year in order to receive credit for a year of service. Vesting schedule is as follows:

Forfeited Accounts: Under the current Plan, forfeitures can be used as additional employer matching contributions, non-elective contributions, or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$165,237 and \$74,255, respectively. For 2024 and 2023, forfeitures were applied towards the employer match and to pay administrative expenses in the amount of \$30,676 and \$66,327, respectively. During 2024 and 2023, the Plan removed \$0 and \$60,870, respectively, from certain plan participants' accounts to the forfeiture account that were a result of 2023 and 2022 employer match excess contributions. However, \$12,780 of the \$33,257 2021 employer match excess was removed in error and corrected in 2023.

Participant Accounts: Each participant's account is credited with the participant's voluntary contribution, the employer's matching and profit sharing contributions, and Plan earnings, which are allocated proportionately among all participants based on their investment in each fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by any outstanding loans from the plan, or 1/2 of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates of 4.25% to 9.5%, which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest are paid ratably through payroll deductions. The receivables include interest that is accrued.

Payment of Benefits: On termination of service due to death, disability, or retirement a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or in installments as described in the Plan. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Investment Valuation and Income Recognition: Investments are reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses: Certain administrative expenses are paid by the employer.

Notes Receivable from Participants: Loans to participants are reported at their unpaid principal balances. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred. If a participant ceases to make loan payments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

NOTE 3 – TAX STATUS

The Company adopted the Minnesota Life Insurance Company Volume Submitter 401(k) Profit Sharing Plan which received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process.

NOTE 4 – TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

NOTE 5 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1*

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2*

Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3*

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There were no investments required to be presented in the fair value hierarchy by level at December 31, 2024 and 2023.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Pooled Separate Accounts:** The Plan invests in pooled separate accounts. A pooled separate account is an investment vehicle in the form of a "special account" that is separate from the general assets of an insurance company. A pooled separate account permits comingled investment of plan assets of employee benefits plans sponsored by unrelated employers. Pooled separate accounts are measured at net asset value. Net asset value (NAV) is value per share of mutual fund or an exchange-traded fund (ETF) on a specific date or time. With both security types, the per-share dollar amount of the fund is based on the total value of all the securities in its portfolio, any liabilities the fund has and the number of fund shares outstanding.

There are no restrictions on when the Plan may redeem its investments other than when a Plan is in discontinuance (blackout) or if a plan participant has been placed on restrictions due to market timing. Investments may be redeemed daily. The investment objective for each separate account can be found on the particular investments' fact sheet. This fact sheet is located in the investment section of the sponsor website. None of the pooled separate accounts have any unfunded commitments, and all funds are liquid at the time of distribution from the plan.

NOTE 6 – INVESTMENT CONTRACT

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Minnesota Insurance Company (the Fund). The Fund invests in investment contracts and security-backed contracts. An investment contract is a contract issued by a financial institution to provide a stated rate of return of the contract for a specified period of time. A security-backed contract has similar characteristics as a traditional investment contract and is comprised of two parts; the first part is a fixed-income security or portfolio of fixed-income securities; the second part is a contract value guarantee (wrapper) provided by a third party. Wrappers provide contract value payments for certain participant-initiated withdrawals and transfers, a floor crediting rate, and return of fully accrued contract value at maturity.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for plan benefits. Contract value, as reported to the Plan by the Fund, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$2,610,986 and \$1,340,829, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (1) an uncured breach of the Plan’s investment guidelines, (2) a material amendment to the contract without the issuer’s consent, (3) a violation of material obligation under the contract, or (4) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan’s ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the company to terminate the agreement prior to the scheduled maturity date.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

As of December 31, 2024 and 2023, the Plan had investments of \$31,348,432 and \$29,076,359, which were concentrated in three funds.

NOTE 9 – PARTY-IN-INTEREST TRANSACTIONS

Minnesota Life Insurance Company is the custodian as defined by the Plan and, therefore, any transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$18,257 and \$12,714 for the years ended December 31, 2024 and 2023, respectively.

Additionally, the Plan paid \$30,676 and \$25,751 for the years ended December 31, 2024 and 2023, respectively, to pay audit fees to Foley, Kalseim & Co, Ltd, a party in interest.

NOTE 10 – SUBSEQUENT EVENTS

Management has evaluated events and transactions for potential recognition or disclosure through October 15, 2025, the date the financial statements were issued.

NOTE 11 – PLAN CORRECTIONS

During 2022, there were employee contributions in the amount of \$45,959, which were not remitted timely to the Plan in accordance with the Department of Labor (DOL). The deposits were made in 2022 and 2023, along with lost earnings of \$1,993 to participant accounts. An excise tax of \$87 was paid.

During 2024, it was discovered that there were employee roth contributions from 2023 in the amount of \$80 that were not remitted to participant accounts until 2024. These amounts are immaterial to the financial statements as a whole and are not included as a receivable on the Statements of Net Assets Available for Plan Benefits.

During 2025, it was identified that the 2023 employer match true-up of \$8,795 was not remitted to the Plan in January 2024 as intended. Additionally, the 2024 match true-up had not been calculated or remitted as of October 15, 2025, the date these financial statements were issued. The 2024 true-up is currently being determined and is estimated to be approximately \$16,000. These amounts are not reflected in the financial statements; however, management has concluded the omission is not material.

Also in 2024, a participant's elective deferral of \$109 was not processed. A qualified nonelective contribution (QNEC), along with applicable earnings, will be made to the participant's account. The correction is not reflected in these financial statements.
