Opinion

NOTE 1: DESCRIPTION OF THE PLAN

The following description of The Horst Group Employee Benefit Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan provides certain medical, short-term disability, prescription drug, flexible spending and death benefits covering substantially all full-time employees of The Horst Group, Inc. and affiliated companies ("Companies"). The Plan and related trust were established in 1980. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits

The Plan provides certain medical and prescription drug benefits to regular full-time employees on the first day of the month following the completion of 60 days of active service and election to participate in the Plan with either single, employee plus child, employee plus spouse, employee plus children or family coverage. A part-time employee who was reclassified as a regular full-time employee could elect to participate immediately upon the reclassification, if the employee had at least 60 days of service.

Flexible spending account plans were established to provide for unreimbursed health care and dependent care expenses. Each employee is eligible to participate in the plans by completing a participation agreement which is valid for only the specified Plan year. The employee must provide a newly executed participation agreement for each subsequent Plan year in which the employee desires to participate in the plans. A separate participation agreement must be prepared for each flexible spending account.

Short-term disability and life insurance benefits are also provided by the Plan to eligible employees.

Stop-Loss Coverage

The Plan has entered into a stop-loss insurance arrangement in its effort to limit its exposure for self-insured benefits.

Continuation of Coverage

An individual covered by the Plan immediately prior to a qualifying event within the meaning of Internal Revenue Code Section 4980B may elect to continue coverage under the Plan. This continuation of coverage may only be for a specified period of time as outlined in the Plan document. The cost for this continuation of coverage is the responsibility of the covered individual.

Contributions

The employer contributes such amounts to the trust fund from time to time as it deems appropriate in order to enable the third-party administrator to pay the benefits and other costs of the Plan. The employer also pays the premium for the death benefits directly to an insurance company. Employees contribute to the Plan based upon their elected coverage at rates specified by the employer.

Plan Amendments

The employer may modify or amend the Plan at any time. The effective date of the modification or amendment will be the date of approval unless the employer specifies an earlier or later date.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan presents its financial statements in accordance with the modified cash basis of accounting which is a comprehensive basis of accounting other than U.S. generally accepted accounting principles. Under the modified cash basis of accounting, only revenues collected, costs and expenses paid, and assets and liabilities arising as a result of cash transactions or from the recognition of income due from insurance companies for claims are recognized. Therefore, accrued income and expenses, payables and deferred expenses, which may be material in amount, are not reflected in the accompanying financial statements.

Use of Estimates

The preparation of financial statements in accordance with the modified cash basis of accounting requires management to make assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Stop-Loss Provision

The Plan's sponsor has a stop-loss provision for certain medical benefits that are self-funded. The provision calls for an insurer to provide for Plan benefits in excess of \$135,000 per person per year for each of the Plan years ending December 31, 2024 and 2023. During the years ended December 31, 2024 and 2023, the Plan received \$82,278 and \$662,919, respectively, in reimbursements from the stop-loss reinsurance carrier related to claims paid.

Management's Evaluation of Subsequent Events

Events that occurred subsequent to December 31, 2024, have been evaluated by the Plan's management through October 15, 2025, which is the date the financial statements were available to be issued.

NOTE 3: TAX STATUS

The trust funding certain benefits of the Plan received an exemption letter from the IRS dated March 16, 1981, stating that the trust is tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code (IRC).

In addition, the Plan and trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and therefore believes that the related trust is tax-exempt.

Under the modified cash basis of accounting, Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4: TERMINATION OF THE PLAN

Although it has not expressed any intention to do so, the Plan sponsor has the right under the Plan to modify the benefits provided to, and contributions required of, participants, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Companies or be used for purposes other than for the exclusive benefit of the Plan's participants.

NOTE 5: BENEFIT OBLIGATIONS

Plan obligations at December 31 for claims incurred but not reported are estimated by the Plan's management based upon claims data provided by the Plan's third-party claims administrator. These amounts are paid by the Plan only if claims are submitted and approved for payment.

NOTE 6: PARTY-IN-INTEREST TRANSACTIONS

The Plan has insurance policies with an affiliate of the Plan sponsor. Premiums paid to the party in interest for the years ended December 31, 2024 and 2023, were \$599,081 and \$551,723, and the administrative fees paid to the party in interest were \$68,054 and \$56,552, respectively.

NOTE 7: CONCENTRATION

Financial instruments that potentially subject the Plan to concentrations of credit risk consist principally of cash deposits. Accounts at each institution are insured by the Federal Deposit Insurance Corporation (FDIC) up to certain limits. At December 31, 2024, there were \$626,351 in excess of FDIC insured limits. At December 31, 2023, there were no balances in excess of FDIC insured limits.

NOTE 8: ADMINISTRATIVE EXPENSES

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Plan sponsor on behalf of the Plan.
