## INDEPENDENT AUDITOR'S REPORT

To the Board of Directors of  
the National Caucus and Center on Black Aging, Inc. 401(A) DC Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the National Caucus and Center on Black Aging, Inc. 401(A) DC Plan [the Plan], an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

NOTES TO FINANCIAL STATEMENTS  
DECEMBER 31, 2024

**NOTE 1      DESCRIPTION OF PLAN**

The following description of the National Caucus and Center on Black Aging, Inc. (NCBA) DC Plan [the Plan], a 401(A) plan, provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering all employees of National Caucus and Center on Black Aging, Inc. (NCBA). The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

**Eligibility:** All full-time employees are immediately eligible to participate in the Plan.

**Contributions:** Each year, NCBA contributes 6% of employees' compensation to the Plan. Contributions can not be more than \$71,496 in 2024 or an amount equal to 100% of employees' compensation, whichever is less. The \$71,496 limit is increased as the cost of living increases. There are no participant contributions.

**Participant Accounts:** Each participant's account is credited with the employer's contributions and allocations of plan earnings or losses based thereon. Allocations are based on participant earnings or account balances, as defined. Participants may direct the investment of their account balances into various investment options offered by the Plan.

**Vesting:** Participants are immediately 100% vested.

**Rollovers:** Rollovers represent transfers of eligible cash distributions from any other qualified plans through a direct transfer from such plan. All participants are 100% vested in their rollover contributions. There was a \$67,003 rollover contribution in 2024.

**Payment of Benefits:** On termination of service due to death, disability or retirement, a participant (or beneficiary) may elect to receive distributions as a lump-sum payment, partial payments, installment payments, or annuity contract. The Plan does not provide loans. A participant may receive an early distribution withdrawal in accordance with IRS rules while still employed with the NCBA, but their funds are subject to IRS penalty. They may also be subject to any early withdrawal penalties as required by the individual funds in which they invest.

**Forfeited Accounts:** Contributions received from the employer are always vested and cannot be forfeited.

**NOTE 2      SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The financial statements are prepared on the accrual method of accounting, whereby revenues are recognized when earned and expenses when incurred. The Plan adheres to accounting principles generally accepted in the United States of America.

***Use of Estimates***

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value, except for guaranteed annuity contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefits are recorded when paid.

***Operating Expenses***

All expenses of maintaining the plan are paid by the Plan sponsor NCBA. These expenses are excluded from the Plan's financial statements.

***Reclassifications***

Certain prior year amounts have been reclassified to conform to the current year's presentation.

**NOTE 3 FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Registered Investment Company:** Registered investments include those funded through variable annuity contracts. The underlying investments are typically mutual funds that invest principally in equity securities, fixed income instruments and short-term investments in accordance with each portfolio's investment objectives. Account investments and fund holdings are primarily valued using market quotations or prices obtained from independent pricing sources that may employ various pricing methods to value the investments including matrix pricing minus contractual charges. Mutual funds included by the Plan are deemed to be actively traded.

**Pooled Separate Account (TIAA Real Estate Account):** An insurance separate account of TIAA investing mainly in real estate and real estate-related investments. The value of the units held in the pooled separate account is based on the market value of the underlying real estate holdings which are valued principally utilizing external appraisals.

**Guaranteed Annuity Contract** is a non-benefit responsive contract which is valued based on contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the plan. The contract is valued at fair value by the insurance company by discounting the related cash flows based on current yields of similar instruments.

The guaranteed minimum interest rate and the amounts in excess of the guaranteed interest rates make up the crediting interest rate. The average crediting rate for TIAA traditional annuity was 4.61% for the year ended December 31, 2024.

#### NOTE 4 INVESTMENT INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN/TRUSTEE

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 252.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by TIAA (the custodian/trustee of the Plan). The custodian/trustee has certified that the related data included in the accompanying financial statement and supplemental schedule is complete and accurate.

The Plan's independent accountants did not perform auditing procedures on the information noted above, except for comparing such information to the related information included in the accompanying financial statements and supplemental schedule.

**NOTE 5 RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by TIAA. These investments and investment transactions qualify as party-in-interest transactions. Fees paid by the plan for investment management services are included in net appreciation in the fair value of investments.

These party-in-interest transactions are exempt from prohibited transaction rules of ERISA.

**NOTE 6 TAX STATUS**

The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements. Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of tax liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 PLAN TERMINATION**

Although it has not expressed any intent to do so, NCBA reserves the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will continue to be 100% vested in their accounts.

**NOTE 8 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 9 SUBSEQUENT EVENTS**

The Plan sponsor National Caucus and Center on Black Aging, Inc. changed its name to NCBA, Inc. effective March 26, 2025. The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued. This review and evaluation revealed no events or transactions other than the item noted above which require adjustment to or disclosure in the accompanying financial statements.
