We have performed an audit of the accompanying financial statements of Signallamp Health 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). Management, having determined it is permissible in the circumstances, has elected to have the audit of Signallamp Health 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of May 10, 2024 and December 31, 2023, and for the period ended May 10, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

### **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Signallamp Health 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. As discussed in Note 5 to the financial statements, the governing body of Signallamp Health 401(k) Plan approved a plan liquidation on May 10, 2024, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from accounting principles generally accepted in the United States of America used in presenting the 2023 financial statements to the liquidations basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to that matter.

**1. Description of Plan**

The following description of the Signallamp Health 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

*General*

The plan is a defined contribution plan covering all employees of Signallamp Health Inc. or any affiliates who have adopted the plan (the “Company” or Employer”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

*Eligibility*

An eligible employee becomes a participant in the Plan upon completion of 3 months of service and having reached age 21. Effective September 28, 2022, if the employee does not make an affirmative or negative election to participate, they will be automatically enrolled in the Plan at an initial period elective deferral of 3% of compensation, with their contributions invested in designated funds until changed by the participant.

*Contributions*

Participants may contribute up to 100% of annual compensation, as defined in the Plan. Participant-elected annual salary deferrals are limited to the maximum allowable under the Internal Revenue Code (“IRC”). Salary deferrals can be designated on a portion of pretax compensation or designated as a Roth 401(k) contribution. The Company’s matching contribution shall be determined by the Company with respect to each plan year. For the period ended May 10, 2024 and year ended December 31, 2023, the Company matched 100% of the first 3% of the participant’s contributions. The Company may also make a discretionary non-elective contribution, in which the participant must be employed on the last day of the plan year. There were no discretionary non-elective contributions made during the period ended May 10, 2024 and year ended December 31, 2023. Eligible rollover distributions from other qualified retirement plans may also be transferred into the Plan and retained as rollover contributions.

Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain IRS limitations. Participants may change their deferral election at times (per pay period) throughout the year as defined in the plan document.

*Participant Accounts*

Each participant’s account is credited with the participant’s contribution, any rollover contributions, and allocations of (a) the Company’s matching contribution (b) the Company’s discretionary non-elective contribution and (3) Plan earnings, and are charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Participants are vested immediately and fully in their salary deferral account, employer matching contribution account, discretionary non-elective contribution account, and rollover account plus actual earnings thereon regardless of the number of years of service.

*Notes Receivable from Participants*

Notes receivable from participants are permitted under the Plan in an amount not to exceed the lesser of one-half of the participant's vested interest under the Plan or \$50,000. The minimum of any loan shall be \$1,000. Participants may only have one loan outstanding at any one point in time. The loans are secured by the balance in the participant's account and bear interest at fixed rates. Principal and interest is paid ratably through payroll deductions.

*Payment of Benefits*

On termination of service due to death, disability, or retirement, a participant may elect to receive either a non-recurring partial payment or lump-sum amount equal to the value of the participant's vested interest in his or her account. The Plan allows participants to make in-service withdrawals upon attaining age 59 ½ and hardship withdrawals. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Vested account balances less than \$5,000 are distributed automatically upon termination.

**2. Summary of Accounting Policies**

*Basis of Accounting*

The financial statements of the Plan are prepared using the liquidation basis of accounting.

*Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**2. Summary of Accounting Policies (Continued)**

*Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on the investments bought and sold as well as held during the years.

*Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest is recorded on the accrual basis. If a participant ceases to make loan payments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. No allowance for credit losses has been recorded as of May 10, 2024 and December 31, 2023.

*Investment Fees*

Net investment returns reflect certain fees paid by the investment funds to their affiliated investment advisors, transfer agents, and others as further described in each fund prospectus or other published documents. These fees are deducted prior to allocation of the Plan's investment earnings activity and thus are not separately identifiable.

*Plan Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative fees. Certain investment-related expenses are included in net appreciation of fair value of investments.

*Benefit Payments*

Benefits are recorded when paid.

**3. Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820-10, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2            Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Investments classified within Level 3 whose fair value measurements consider several inputs may include Level 1 and/or Level 2 inputs as components of the overall fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at May 10, 2024 and December 31, 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**3. Fair Value Measurements (Continued)**

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**4. Information Certified by the Trustee**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at May 10, 2024 and December 31, 2023 and net appreciation/(depreciation) in fair value of investments, interest and dividends for the period ended May 10, 2024, was obtained or derived from information supplied to the plan administrator who has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, and certified as complete and accurate by MTG LLC d/b/a Betterment Securities, the trustee of the Plan.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and the supplemental Schedule of Assets (Held at End of Year).

**5. Plan Termination**

On May 10, 2024, the Board of Directors of Signallamp Health 401(k) Plan, the Plan sponsor, approved the termination of the Plan effective May 10, 2024. Subsequent to May 10, 2024, all participants were enrolled in the Principal EASE 401(k). Additionally, participant balances were transferred into the Plan and the plan was formally liquidated in its entirety as of May 10, 2024.

**6. Tax Status**

The Company adopted a Prototype Non-standardized Profit-Sharing Plan with CODA which received favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020. Although the Plan has been amended since receiving the determination letter, the Company believes that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of May 10, 2024 and December 31, 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. Transactions with Parties in Interest**

Certain routine plan administrative expenses are incurred and/or paid by the plan sponsor. Notes receivable from participants also qualify as exempt transactions with parties-in-interest. Other than the aforementioned, the Plan has no agreements or transactions with parties-in-interest.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risk such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

**9. Subsequent Events**

Management has evaluated subsequent events through October 14, 2025, the date on which the financial statements were available to be issued, and has determined that no material subsequent events exist that require recognition or disclosure.
