Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Fisher Island Club, Inc. 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1—Description of Plan

The following description of the Fisher Island Club, Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan documents for a more complete description of the Plan’s provisions.

General – The Plan, a defined contribution safe harbor plan, was established on January 1, 2006 for eligible employees of Fisher Island Club, Inc., the Plan’s sponsor, and the Plan administrator (the “Company” or the “Employer”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. Effective January 1, 2023, the minimum service requirement is 6 months and an employee must be 21 years old to be eligible to participate in the plan.

Administration of Plan Assets – The Plan is administered by the Company. The Plan’s assets are maintained and administered by Voya Retirement Insurance and Annuity Company (the “qualified institution”), and the Plan’s recordkeeping services and maintenance of participant account records are maintained by Definiti, LLC.

Contributions – Subject to certain limitations, under Internal Revenue Code (“IRC”) Section 401(k), participants may contribute up to 100% of pre-tax annual compensation, subject to 2024 annual limits of \$23,000, and an additional \$7,500 for catch-up contribution for participants who are age 50 or older. Participants may also contribute amounts representing rollovers from other qualified defined benefit or defined contribution plans along with after-tax contributions. Participants may change their contribution elections quarterly.

The Employer matches 100% of the participant’s elective deferral contribution up to 3% of the participant’s compensation, plus 50% of the participant’s elective deferral contribution over 3% up to 5% of the participant’s compensation. In addition to a safe harbor matching contribution, the Plan allows for discretionary Employer matching and profit sharing contributions. The Employer made no discretionary Employer matching or profit sharing contributions during the 2024 Plan year.

Participant Accounts – Each participant’s account is credited with the participant’s contribution including any rollover amounts from qualified plans and allocations of: (a) the sponsor’s discretionary-matching contribution, (b) the sponsor’s discretionary profit sharing contribution, (c) Plan earnings (losses), and (d) forfeitures, and charged with the participant’s distributions and allocations of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options – Participants may direct contributions to selected investments as made available and determined by the Plan administrator. Participants may change their investment options at any time throughout the year via direct phone and internet access to the third party administrator.

Vesting – Participants are fully vested in their elective contributions, as well as any rollover contributions, and Employer safe harbor matching contributions, plus or minus any earnings or losses thereon. Discretionary Employer matching and profit sharing contributions made, and earnings or losses thereon, are 25% vested after the completion of the first year of employment and are 100% vested after four years of credited service.

Forfeitures – Forfeitures occur when a participant terminates employment and is not vested in a portion of the Employer discretionary-matching and profit sharing contribution amounts. Forfeitures are used to reduce future Employer contributions and to offset administrative expenses. At December 31, 2024 and 2023, there were approximately \$1,600 and \$1,500 respectively, of forfeitures outstanding.

Note 1—Description of Plan (continued)

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The interest rate is equal to the current prime rate plus one percentage point at the date the note is made. The effective interest rates on notes receivable from participants ranged from 4.25% to 9.50% as of December 31, 2024. The maximum note repayment period is five years unless the note is for the purchase of a primary residence, in which case the repayment schedule may be for a term in excess of five years. The notes are collateralized by the participant's vested interest in their account balance. Principal and interest payments with respect to the notes are credited solely to the account of the borrowing participant from which the note was made.

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan documents.

Hardship Distribution – Hardship distributions are permitted only if a participant is 100% vested and if the distribution is due to expenses incurred or necessary for medical care described in the IRC Section 213(d), purchase of a principal residence, payment of tuition, to prevent eviction from or foreclosure of the principal residence, or any other condition which the Internal Revenue Service (“IRS”) deems an immediate and financial need of the participant.

Payment of Benefits – Upon termination of employment by reason of death, disability, or retirement, a participant is entitled to the entire participant account balance, which includes all of the vested Employer contributions allocated to the participant's account and all gains or losses attributable thereto. Terminating participants may elect to receive a distribution of their vested benefits in a lump-sum distribution or annuity contract. Participants should refer to the Plan documents for a full description of the distribution methods offered by the Plan.

Plan Termination – Although it has not expressed any intent to do so, the Company reserves the right at any time to amend, modify, or terminate the Plan without the consent of any participant or beneficiary, subject to the provisions of ERISA. In the event of such termination, the Plan provides that the participants shall become 100% vested in their accounts.

Note 2—Summary of significant accounting policies

Basis of Accounting – The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are valued at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investment contracts held by a defined contribution plan are required to be reported at contract value. Contract value is the relevant measure attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 4 for discussion of fair value measurements.

U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

Three levels of inputs may be used to measure fair value:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodology used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy:

Pooled Separate Accounts – These investments are public investment vehicles valued at the net asset value ("NAV") of units of a trust. NAV, as provided by the administrator of the fund, is used as a practical expedient to estimate fair value and is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Transactions (purchases and sales) may occur daily. Investments measured at fair value based on NAV practical expedient are excluded from the fair value hierarchy.

The Plan believes its valuation method is appropriate and consistent with those of other market participants; however, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's losses and gains on investments bought and sold as well as held during the year.

Benefits Paid to Participants – Benefits are recorded when they have been processed and paid by the Plan.

Administrative Expenses – Fees and expenses of the Plan for legal, accounting, and other administrative services may be paid directly by the Company or, at the Company's discretion, may be paid in whole or in part from Plan assets. A portion of the fees incurred by the Plan are paid through a revenue sharing agreement with the qualified institution in which a portion of excess investment revenue received by the qualified institution is allocated to an account and is used by the Plan to pay administrative expenses. During the year ended December 31, 2024, revenue received from this revenue-sharing agreement totaled approximately \$23,000 and \$19,000 was used to pay Plan expenses. At December 31, 2024, approximately \$10,000 remained unutilized.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant note receivable balance is reduced and a benefit payment is recorded as defaulted distribution based upon terms of the Plan document.

Note 3—Information prepared and certified by the qualified institution (unaudited)

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the qualified institution, has certified the following data included in the accompanying financial statements and supplemental schedule of assets as complete and accurate:

- Investments at fair value, and fully benefit-responsive investment contract at contract value, as shown in the statements of net assets available for benefits as of December 31, 2024 or 2023.
- Net appreciation in fair value of investments, and other income, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan’s independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note 5—Fully benefit-responsive investment contract

The Plan holds an interest in a guaranteed investment contract ("Voya Fixed Account"). The account is credited with contributions and earnings on the underlying investments and charged for participant withdrawals and administrative expenses charged by the qualified institution. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by the qualified institution, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

The Plan administrator does not believe any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

Note 6—Party-in-interest transactions

Certain Plan investments and the related transactions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, were in investments managed by the qualified institution; therefore, these investments and transactions qualify as party-in-interest transactions. Fees paid during the year for accounting and other services rendered by parties-in-interest were based on customary and reasonable rates for such services. These administrative expenses totaled approximately \$31,600 for the year ended December 31, 2024.

Notes receivable from participants are also considered to be party-in-interest transactions because they are transacted with Plan participants.

Note 7—Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8—Income tax status

On June 30, 2020, the Internal Revenue Service stated that the volume submitter profit sharing plan adopted by the Plan, as then designed, qualified under Section 401 of the IRC. The prototype plan has been amended since receiving the determination letter. The Plan has not received a determination letter specific to the Plan itself however, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 or 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9—Subsequent events

The Plan's management evaluated subsequent events through October 14, 2025 in connection with the preparation of these financial statements, which is the date that the financial statements were available to be issued.
