**NOTES TO FINANCIAL STATEMENTS**

**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the North Sails Group, LLC 401(k) Plan (the "Plan"), sponsored by North Sails Group, LLC (the "Company"), provides general information only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering all full-time employees of the Company who are age 19 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The trustee of the Plan is T. Rowe Price Trust Company.

**Contributions** - Each employee who elects to become a participant of the Plan may authorize a payroll deduction not in excess of 75 percent of his/her compensation for contribution to the individual's account in the Plan. The total contribution is not to exceed the maximum permitted by the Internal Revenue Code. As of January 1, 2000, the Plan provides that the Company will make a matching contribution to eligible participants equal to 100 percent of an employee's contribution up to 3 percent of the employee's compensation and 50 percent of an employee's contribution for the next 2 percent of the employee's compensation. Eligibility for this matching contribution is 19 years of age and six months of service.

**Participant Accounts** - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings, and is charged with an allocation of administrative expenses, if any. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Both employee and employer contributions are immediately fully vested, plus actual earnings thereon.

**Investment Options** - Upon enrollment in the Plan, a participant may direct his or her contributions in any of the funds offered by the Plan through T. Rowe Price. Participants may elect to change their investment options daily.

**Payment of Benefits** - Benefits are payable upon termination of employment, retirement, death or total disability. Participants may elect to receive benefits in an annuity, a lump-sum or installments.

**Hardship Withdrawals** - The Plan allows for "hardship" withdrawals in accordance with the Internal Revenue Service regulations as specified in the Plan summary.

## NORTH SAILS GROUP, LLC 401(K) PLAN NOTES TO FINANCIAL STATEMENTS

### NOTE 1 - DESCRIPTION OF PLAN (Continued)

**Plan Expenses** - All costs and expenses with regard to the purchase or sale of investments are paid by the Plan. Administrative expenses may be paid by the Plan sponsor or through utilization of the plan administrative budget provided by T. Rowe Price. Personnel and facilities of the Company have been used by the Plan for its accounting and other activities at no charge to the Plan. Expenses paid by the Plan sponsor are excluded from these financial statements. Fees related to administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Notes Receivable from Participants** - Participants may borrow from their fund accounts up to an amount equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant loan. The maximum payment term for most loans is five years. Loans for the purchase of a principal residence can be repaid over thirty years. The minimum loan is \$1,000. The interest rate charged to participants is one percent above the prime interest rate established by commercial lending institutions. Principal and interest is paid ratably through payroll deductions.

### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Presentation** - The Plan financial statements have been prepared on the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Fair Value Measurements** - ASC Topic 820 *Fair Value Measurements* defines fair value, establishes guidelines for measuring fair value, and expands disclosure regarding fair value measurements. The Plan follows the guidance in ASU 2015-07 which removed the requirement to categorize within the fair value hierarchy all investments for which fair value is measured using the net asset value ("NAV") per share as quoted on a private market that is not active.

**Investment Valuation and Income Recognition** - The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**Risks and Uncertainties** - The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**Payment of Benefits** - Benefits are recorded when paid.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Disclosure of Subsequent Events** - Management has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

**NOTE 3 - INFORMATION CERTIFIED BY TRUSTEE (UNAUDITED)**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, T. Rowe Price Trust Company, the trustee for the Plan, has certified as to the completeness and accuracy of the investments and investment transactions of the Plan as of December 31, 2024 and 2023 and for the year ended December 31, 2024. The following information included in the accompanying financial statements and supplemental schedule of assets (held at end of year) was obtained from data that has been prepared and certified to as complete and accurate by T. Rowe Price Trust Company:

### NOTE 4 - FAIR VALUE MEASUREMENTS

ASC Topic 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual and money market funds:* Valued at the net asset value ("NAV") of shares held by the Plan at year-end. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust:* The stable value fund, held in a common collective trust fund, invests in conventional guaranteed investment contracts issued by insurance companies and other institutions and security-backed contracts. The value of the common collective trust is measured at NAV as a practical expedient.

**NOTE 5 - TAX STATUS**

The Plan uses a prototype plan document sponsored by T. Rowe Price Retirement Plan Services. T Rowe Price Retirement Plan Services obtained a favorable determination letter on August 19, 2020, in which the Internal Revenue Service stated that the prototype document satisfies the applicable requirements of the Code. The Plan itself has not received a determination letter from the IRS.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes it is no longer subject to income tax examination for years prior to 2021.

**NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS**

During 2024, there were transactions involving the investment of plan assets in mutual funds maintained by T. Rowe Price, a party-in-interest, as defined under Section 3(14) of ERISA.

T. Rowe Price receives revenue from mutual fund service providers for service T. Rowe Price provides to the funds. This revenue is used to offset certain amounts owed to T. Rowe Price for its administrative services to the Plan.

T. Rowe Price provides the Plan with an administrative budget account in which excess revenue is credited to the Plan. Such amounts may be used by the Plan to pay administrative expenses or allocated to the accounts of the participants. There were no allocations to participants during 2024. Additionally, amounts credited during 2024 amounted to \$66,640 with \$44,171 being utilized for Plan expenses. The ending balance in the administrative account as of December 31, 2024 and 2023 was \$24,993 and \$18,385, respectively.

Additionally, Edgewater Power Boats, LLC was removed from the controlled group effective May 31, 2023. The Plan Sponsor had all participant accounts in the former participating employer transferred out of the Plan during 2023.

**NOTE 7 - TERMINATION PRIORITIES**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, there is no impact to participants as they are 100 percent vested in all contributions at all times.
