### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Odawa Casino Resort 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the



supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1. Description of the Plan

The following brief description of the Odawa Casino Resort 401(k) Plan (the Plan) is provided for general information only. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

#### *General*

The Plan was established by Odawa Casino Resort (the Company) and became effective January 1, 2013. The Plan is a defined contribution plan established under the provisions of Sections 401(a), 401(k), and 501(a) of the Internal Revenue Code (IRC). Under Section 401(k), contributions to a qualified plan are not included in the participant's compensation for federal income tax purposes until distributed to the participant. Substantially all employees who have completed three months of service and are not seasonal employees, as defined by the Plan, are eligible for participation. An eligible employee becomes a participant on the first day of the month following the date the employee satisfies the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Effective June 1, 2024, the Company appointed Standard Insurance Company (The Standard) as their contract holder and recordkeeper, and Reliance Trust Company as the custodian of the Plan.

The Standard replaced Empower Trust Company, LLC and its affiliates as the contract holder and recordkeeper of the Plan.

#### *Contributions*

Participants may contribute up to the maximum amount allowed by law of their eligible annual compensation, subject to certain limitations, with the contributions and earnings thereon, being non-taxable until withdrawn from the Plan. Participants may also contribute amounts representing distributions from other qualified plans. Roth contributions and catch-up contributions for those aged 50 and older during the Plan year, subject to limitations, are allowed as well.

The Plan sponsor will match 100% of participant contributions up to a maximum of 3% of eligible compensation. Additionally, the Company may make additional discretionary contributions as determined by the Company. No additional discretionary contributions were made by the Company for the years ended December 31, 2024 and 2023.

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions, allocations of the Company's contributions, and Plan earnings and losses, and is charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined by the Plan documents. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investment of their account balances into various investment options offered by the Plan.

#### *Vesting*

Participants are immediately vested in their elective deferral and actual earnings thereon. Vesting in the Company's matching and discretionary contributions and actual earnings thereon is based on

years of continuous service. Participants vest at a rate of 20% for each year starting after year one of continuous service and become 100% vested in Company contributions after five years of credited service. Participant accounts are distributed without regard to the vesting provisions in the event of death or permanent physical or mental disability.

### ***Notes Receivable from Participants***

Participants may, under certain circumstances as defined in the Plan documents, borrow up to the lesser of \$50,000 or 50% of their vested account balance. The minimum note is \$1,000. Participants may have no more than two notes outstanding at any time. The notes are secured by the balance in the participant's account and bear interest at, prior to June 1, 2024, the prime rate plus 1%. Effective June 1, 2024, the rate was changed to prime rate. The notes are repaid ratably through payroll deductions over a period of five years or less, unless the note is for the purchase of a principal residence, for which the note terms may not, prior to June 1, 2024, exceed 15 years. Effective June 1, 2024, if a note is for purchase of a residence, the note term may not exceed ten years.

### ***Payment of Benefits***

Upon termination of service due to death, disability, retirement, or separation, a participant (or a participant's beneficiary in the event of death) may elect to receive a lump-sum payment equal to the value of the participant's vested interest in their account. If the amount of the participant's vested balance is less than \$7,000, a single lump-sum payment will be made to the participant, or on behalf of the participant, to an individual retirement account. In-service distributions at age 59 ½ and hardship withdrawals are allowed, as defined by the Plan documents.

### ***Forfeitures***

As of December 31, 2024 and 2023, forfeited, non-vested accounts totaled \$0 and \$23,113, respectively. These accounts can be used to pay administrative expenses or to reduce future employer contributions. For the years ended December 31, 2024 and 2023, \$715 and \$3,494, respectively, of forfeitures were used to reduce employer contributions, as allowed by the Plan.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements of the Plan have been prepared under the accrual method of accounting.

### ***Subsequent Events***

Subsequent events have been evaluated by management through October 14, 2025, the date these financial statements were available to be issued.

### ***Risks and Uncertainties***

The Plan utilizes various investment instruments, which are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in their values could occur in the near term and

such changes could materially affect participants' account balances and the amounts reported in the financial statements.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from these estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value except for the fully benefit responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements. See Note 5 for information on guaranteed investment contracts reported at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### ***Contribution Receivable***

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### ***Payment of Benefits***

Benefits are recorded when paid.

### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees relating to an annual asset charge and the administration of the Plan (for notes receivable from participants and payment of benefits) are charged directly to the participant's account and are included in administrative expenses. Certain investment-related expenses are included in net appreciation of fair value of investments.

### 3. Fair Value Measurements

Inputs to valuation techniques refer to the assumptions that market participants would use in pricing the asset. The Plan utilizes a fair value hierarchy for valuation inputs that gives the highest priority to quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The three levels of the fair value hierarchy are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets.

*Level 2* - Inputs to the valuation methodology include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in inactive markets, and other inputs that are observable or can be corroborated by observable market data.

*Level 3* - Inputs to the valuation methodology are both significant to the fair value measurement and unobservable.

There have been no changes in the methodologies used at December 31, 2024 or 2023. The following valuation methodology was used to measure the fair value of the Plan's investments:

*Mutual Funds* - These are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The Plan's valuation method may result in a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Although the Plan's management believes the valuation method is appropriate and consistent with the market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 4. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC (Empower) for the period January 1, 2023 until May 30, 2024 and Standard Insurance Company for the period June 1, 2024 until December 31, 2024. Empower and Standard Insurance Company are qualified institutions.

### 5. Guaranteed Investment Contracts

Prior to June 2024, the Plan held a fully benefit-responsive interest account with MassMutual. MassMutual maintained the contributions in a general account. There were not any specific securities in the general account that back this interest account. The Guaranteed Interest Account (GIA) issuer was contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The average guaranteed minimum interest rate was 1.65% for the year ended December 31, 2023. There were no reserves against contract value for credit risk of the contract issuer or otherwise. MassMutual was responsible for establishing the interest crediting rates for this product. When establishing the interest crediting rates, MassMutual considered many factors, including current economic and market conditions, and the general interest rate environment. Such interest rates are reviewed on a monthly basis for resetting. This contract was terminated in 2023.

During June 2024, the Plan invested in a deposit administration contract account with The Standard. The Standard invests the deposits of plan participants as part of its general account assets, which include its fixed income securities portfolio and its commercial mortgage loan portfolio. There were not any specific securities in the general account that back this interest account. The issuer was contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The average guaranteed minimum interest rate is 1% per year. There were no reserves against contract value for credit risk of the contract issuer or otherwise. The Standard is responsible for establishing the interest crediting rates for this product. When establishing the interest crediting rates, the Standard considered many factors, including current economic and market conditions, and the general interest rate environment. Such interest rates are reviewed on a monthly basis for resetting.

Contract value represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants ordinarily may direct the withdrawal or transfer of all or a portion of their investments at contract value.

There were no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid overtime.

### 6. Related Party and Party-in-Interest Transactions

Certain Plan investments are managed by The Standard and Empower, the current contract holder and former contract holder of the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investment. The Plan made direct payments to service providers of approximately \$62,000 and \$67,000 for the years ended December 31, 2024 and 2023, respectively. Notes receivable from participants also qualify as party-in-interest transactions.

### 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, the contract holder shall distribute all assets remaining in the Plan, after payment of any expenses properly chargeable against the Plan, to the participants in accordance with the value of the units credited to such participants as of the date of such termination.

### 8. Income Tax Status

The Plan was amended and restated effective June 1, 2024 to a pre-approved plan document sponsored by The Standard. The Standard received an opinion letter dated June 30, 2020, in which the Internal Revenue Service (IRS) stated that the plan document, as then designed, was in compliance with the applicable requirements of the IRC. The plan document has since been amended; however, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements. Prior to June 1, 2024, the Plan was using the non-standardized pre-approved Plan document from CCH, which had received an opinion letter dated June 30, 2020.

GAAP requires the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.


