A. DESCRIPTION OF PLAN:

The following description of the Campagna-Turano Bakery, Inc. Self-Funded Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

1. *General.* The Plan provides health and other benefits covering all participants employed by the Campagna-Turano Bakery, Inc. and affiliated companies (Knead Dough Bakery, Inc., Turano Florida Bun, LLC, Turano Georgia Bread, LLC, and Turano Nevada Baking, LLC) (collectively, the Company). The Plan and related trust were established on January 1, 1982. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.
2. *Administration.* The Campagna-Turano Bakery, Inc. Self-Funded Benefit Plan Administrative Committee has the responsibility for administering the Plan. Campagna-Turano Bakery, Inc. Self-Funded Benefit Plan Review Committee has the responsibility for the management and control of the assets of the Plan.
3. *Contributions.* The Plan is funded by the Company with monthly contributions based on premium quotes calculated by Blue Cross Blue Shield into a money market fund maintained by the Chicago Trust Company N.A., the Trustee of the Plan.

In addition, participating employees contribute as follows through payroll deductions: medical coverage only - \$35 per week for single, \$70 per week for married and \$75 per week for family; medical, dental and vision coverage - \$40 per week for single, \$75 per week for married and \$80 per week for family.

4. *Benefits.* The Plan provides health benefits where participants may receive all of their care through a network of participating providers, hospitals and specialists; or receive out-of-pocket benefits both without referral. The Plan has deductibles, coinsurance and out-of-pocket maximums for both in-network and out-of-network care. Terminated employees are entitled to similar health benefits if enrolled under the Consolidated Omnibus Budget Reconciliation Act (COBRA).

The Plan also provides health benefits to participants during periods of unemployment, provided that they have accumulated, in the current or in prior years, credit amounts (expressed in hours) in excess of the hours required for current coverage. Accumulated eligibility credits equal to one year's coverage may be carried forward. The Plan also provides vision, dental, life and disability insurance for all participants.

All claims of active participants, dependents, and beneficiaries are processed by Blue Cross Blue Shield, the administrator of the Plan, but the responsibility for payments to participants and providers is retained by the Plan.

5. *Other.* The Plan's board of trustees, as the plan sponsor, has the right under the Plan to modify the benefits provided to active employees. The Plan may be terminated only by joint agreement between the employer and participants, subject to the provisions set forth in ERISA.

B. SIGNIFICANT ACCOUNTING POLICIES:

1. *Basis of accounting.* The financial statements of the Plan are prepared under the accrual method of accounting.
2. *Use of estimates.* The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, claims payable, incurred but not reported (IBNR) and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates. The most significant estimate is the calculation of IBNR.
3. *Fair value of financial instruments.* The carrying values of cash equivalents and claims incurred but not reported liabilities approximate their fair value.
4. *Interest income.* Interest income is recorded on the accrual basis.
5. *Benefits paid.* Health claims and premiums are reported when paid. Any refunds due to overpayments, subrogation, or adjustments are recorded in the period received and are shown netted with claim payments.
6. *Prescription rebates.* Prescription drug rebates are recorded in the period to which the related claims were paid and are shown netted with claim payments.
7. *Subsequent events.* Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 855, *Subsequent Events* establishes general standards of accounting for and disclosure of events that occur after the balance sheet date but prior to the issuance of the financial statements. ASC 855 distinguishes events requiring recognition in the financial statements and those that may require disclosure in the financial statements. Furthermore, ASC 855 requires disclosure of the date through which subsequent events were evaluated. The Plan has evaluated the period after the balance sheet date up through October 15, 2025, which is the date that the financial statements were issued, and determined that there were no subsequent events or transactions that required recognition or disclosure in the financial statements.

C. FAIR VALUE:

The fair value of the Plan's cash equivalents is determined in accordance with FASB ASC 820, *Fair Value Measurements and Disclosures*. ASC 820 clarifies that fair value is an exit price, representing the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. As such, fair value is a market-based measurement and should be determined based on assumptions that market participants would use in pricing an asset or liability. As a basis for considering such assumptions, ASC 820 establishes a three-tier value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

This hierarchy requires the Plan to use observable market data, when available, and to minimize the use of unobservable inputs when determining fair value. The Plan measures certain financial assets at fair value.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Short-term investments – A money market fund transacts subscription and redemption activity at a \$1 stable net asset value (NAV). However, on a daily basis the fund's NAV is calculated using the amortized cost (not market value of) the securities held in the fund. Amortized cost does not meet the criteria for an active market. As such, the fund is valued as Level 2 category.*

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## D. STOP LOSS INSURANCE:

The Company separately purchases excess or stop loss insurance for losses exceeding \$190,000 per claim from Blue Cross Blue Shield.

## E. BENEFIT OBLIGATIONS:

Plan obligations at December 31, 2024 and 2023 included unpaid health claims incurred by active participants both reported and not reported to Blue Cross Blue Shield at that date. Unpaid health claims incurred by active participants but not reported at that date were estimated by the Plan's Trustee in accordance with accepted actuarial principals, which were estimated by using a "claims development" or "lag" method. Both amounts are reported in the statements of plan benefit obligations and the statements of changes in plan benefit obligations. At December 31, 2024 and 2023, total benefit obligations amounted to \$802,676 and \$695,729, respectively.

## F. TAX STATUS:

The Plan has received a favorable determination letter from the Internal Revenue Service and is qualified for exemption from federal income taxes under Section 401(a) of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax exempt.

F. TAX STATUS (CONTINUED):

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would be sustained upon examination by the applicable tax authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

G. PARTY-IN-INTEREST TRANSACTIONS:

Campagna-Turano Bakery, Inc. and affiliates administer the financial activities of the Plan including paying general and administrative expenses of the Plan through the Company's corporate office.

H. RISKS AND UNCERTAINTIES:

The Plan invests in short-term investments, which are exposed to risks such as interest rate, market and credit risks. In addition, various assumptions are used for the valuation of benefit obligations. Due to the level of risk associated with investments and the valuation of benefit obligations, it is at least reasonably possible that changes in the values of investments and the valuation of benefit obligations will occur in the near term and that such changes could materially affect the amounts reported in the statement of benefit obligations and net assets available for benefits.

I. PLAN TERMINATION:

Under certain conditions, the Plan may be terminated. Upon termination, the assets remaining shall be subject to the applicable provisions of the Plan in effect and shall be used until exhausted to pay benefits to employees in the order of their entitlement.
