**December 31, 2024**

**1. Plan Description**

The following brief description of the LTD Management Company, LLC 401(k) Profit-Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan’s provisions.

*General:* The Plan is a defined-contribution plan covering all eligible employees of LTD Management Company, LLC and participating companies (“Company”). The Plan is subject to the provisions of ERISA. The Plan trustees are responsible for oversight of the Plan, determining the appropriateness of the Plan’s investment offerings, and monitoring investment performance.

Effective Date: January 1, 2005

Anniversary Date: December 31

Valuation Date: Daily

*Eligibility:* All new employees become eligible to participate in the salary deferral benefit under the Plan as of the first day of the month coinciding with or next following the date for which employees have attained 30 days of service and the age of 18. All new employees are eligible for discretionary profit-sharing as of the first day of the quarter coinciding with or next following the date for which employees have attained one year and 1,000 hours of service and have attained the age of 18. All participants share in the allocations regardless of service completed during the Plan year or employment status on the last day of the Plan year.

*Compensation:* Compensation is defined as salary or wages, including any overtime, commissions, or tips, but excluding compensation paid during the “determination period” while not a participant in the component of the Plan for which the definition applies, contributions by the employer to the Plan, and benefits paid under the Plan.

*Normal Retirement Date:* The Plan defines the normal retirement date as the anniversary date coinciding with or next following the date of the participant’s 65<sup>th</sup> birthday.

*Early Retirement Date:* No early retirement date is defined by the Plan.

*Disability Retirement Date:* Disability retirement shall be upon total and permanent disability under the federal Social Security Act.

*Retirement Benefits:* At the applicable retirement date, each participant shall be entitled to receive the vested interest in their trust account.

*Participant Contributions:* Participants may elect to defer up to 100% of pretax compensation as defined by the Plan. However, total deferrals in any taxable year may not exceed the dollar limit set by law. A participant may make catch-up contributions of up to \$7,500 if the participant has attained age 50 by the end of the calendar year. Participants are 100% vested in all elective deferrals made to the Plan and any investment earnings from these deferrals. Participants may commence salary deferrals on the effective date of participation and on the first day of each month. Participants may modify salary deferral elections monthly as of the first day of any calendar month.

1. Plan Description - Continued

*Participant Accounts:* Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative and investment expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Employer Contributions:* The Company may make matching contributions and profit-sharing contributions to eligible participants. Participants direct the investment of all contributions into various investment options offered by the Plan. Contributions are subject to certain IRS limitations. For the Plan year ended December 31, 2024, the Company made matching contributions of 25% of employee's elective deferrals up to the first 10% of eligible compensation, subject to IRS limits.

*Death Benefits:* If a participant dies before his normal retirement date, his designated beneficiary vests 100% in the participant's account.

*Vesting:* Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their account is based on years of continuous service. A participant is 100% vested after six years of credited service and is based on the graduated scale as follows:

Less than 2 years	0%
2, but less than 3 years	20%
3, but less than 4 years	40%
4, but less than 5 years	60%
5, but less than 6 years	80%
6 or more years	100%

*Forfeitures:* At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$104,456 and \$48,786, respectively. These accounts will be used to reduce future employer contributions or to pay administrative expenses of the Plan. No forfeitures were used during the Plan year.

*Investment Options:* Upon enrollment in the Plan, a participant may direct up to 100% of employee contributions in any of the available investment funds offered.

*Guaranteed Interest Accounts:* Investments in these funds are through a group annuity contract with participant principal and interest fully guaranteed by the entire general account assets of Empower Annuity Insurance Company of America. Daily interest is credited to the account. The credited interest rate may change based on the investment portfolio of the account.

Participants may change their investment options at any time within the general investment accounts. Transfers from the general investment accounts into a mutual fund investment account can occur only on a valuation date of such mutual fund investment account.

**1. Plan Description - Continued**

*Notes Receivable from Participants:* Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set by the Plan administrator at a reasonable rate of interest, which is comparable to the rates being charged by lending institutions in the same geographic locale as the Company. Principal and interest is paid ratably through payroll deductions.

*Hardship Distributions:* Hardship distributions are permitted from participants' pre-tax elective deferrals. The minimum amount of a hardship distribution is \$1,000 and may only be made from accounts which are fully vested.

*Payment of Benefits:* On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, partial payments, or substantially equal installments over a period not to exceed life expectancy. In-service withdrawals are permitted for participants who have attained age 59 1/2 or for a qualified financial hardship.

**2. Summary of Significant Accounting Policies**

*Basis of Accounting:* The financial statements of the Plan are prepared on the accrual basis of accounting.

*Estimates:* The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition:* Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan trustees determine the Plan's valuation policies utilizing information provided by The Ascent Group LLC, Empower Annuity Insurance Company of America, and Empower Trust Company, LLC. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Notes Receivable from Participants:* Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

#### 2. Summary of Significant Accounting Policies - Continued

*Contributions:* Each year, participants may contribute up to the maximum allowed by law of their pretax annual compensation, as defined in the Plan. Participants may elect to designate all or a portion of their elective deferrals as Roth contributions. Participants may also contribute amounts representing distributions from other qualified defined-benefit or defined-contribution plans (rollover).

*Automatic Enrollment:* The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated fund until changed by the participant. The Plan also includes an automatic increase provision whereby a participant's deferral rate is increased by 1% each year, up to a maximum of 10% of Plan compensation, subject to certain conditions. The Company may make matching contributions and profit-sharing contributions to eligible participants.

*Payment of Benefits:* Benefits are recorded when paid.

*Administrative Expenses:* Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to recordkeeping, the administration of notes receivable and benefits paid are charged directly to the participant's account and are included in administrative expenses. Fees paid directly by the Plan for investment advisory services are included in investment expenses. Investment-related expenses paid indirectly are included in net appreciation of fair value of investments.

*Evaluation of Subsequent Events:* The Plan has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued.

4. Fair Value Measurements (Unaudited)

Financial Accounting Standards Board Accounting Standards Codification (“FASB ASC”) 820-10, “Fair Value Measurements and Disclosures,” establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or 2 inputs are not available.

*Level 1 Inputs* - The values of mutual fund investment accounts are reported using a unit value based on quoted prices in active markets for identical assets.

There were no Level 2 or 3 inputs available to the Plan at December 31, 2024.

The Plan’s mutual funds are reported at fair value and the general investment account is reported at contract value in the statements of net assets available for benefits.

The Plan’s common collective trusts are reported at the NAV of the units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the trust, less its liabilities. The practical expedient is not used when it is determined to be probable that the trust will sell the underlying investments for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common collective trust, the trust’s investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### 5. Investment Contract with Insurance Company (Unaudited)

As described in Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) 962-325-50-3, "*Reporting on Fully Benefit-Responsive Investment Contracts*", investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. As required by FASB ASC 962-325-50-3, the statements of net assets available for benefits present the fair value of the investment contracts as well as the adjustment of the fully benefit-responsive investment contracts from fair value to contract value.

The Plan is a party to a benefit-responsive investment contract. Empower Annuity Insurance Company of America maintains the contributions in a general account. The contract is included in the financial statements at contract value as reported to the Plan by Empower Annuity Insurance Company of America. Contract value represents contributions made under the contract, plus interest and earnings on underlying investments, less participant withdrawals, and administrative expenses. Interest rates for monies invested in the general account are established by Empower Annuity Insurance Company of America and are not guaranteed through a specific maturity date. These rates may change periodically at the discretion of Empower Annuity Insurance Company of America. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

As described in Note 2, because the group annuity contract is fully benefit-responsive, the contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The fair value of the investment contract at December 31, 2024 and 2023 was \$115,853 and \$54,412, respectively.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the Plan's ability to transact at contract value with Empower Annuity Insurance Company of America. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974, or (e) premature termination of the contract. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants are probable of occurring.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle an amount different from contract value. Such events include (a) an uncured violation of the Plan's investment guidelines, (b) a breach of material obligation under the contract, (c) a material misrepresentation, or (d) a material amendment to the agreement without the consent of the issuer.

#### 6. Plan Termination

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### 7. Tax Status

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### 8. Parties-in-Interest

Empower Annuity Insurance Company of America provides recordkeeping services to the Plan. Empower Annuity Insurance Company of America is a service provider of the Plan; therefore, transactions with Empower Annuity Insurance Company of America are party-in-interest transactions. Fees paid to Empower Annuity Insurance Company of America by the Plan totaled \$44,028 for the year ended December 31, 2024.

The Ascent Group LLC is an investment advisor to the Plan. The Ascent Group LLC is a service provider of the Plan; therefore, transactions with The Ascent Group LLC are party-in-interest transactions. Fees paid to The Ascent Group LLC by the Plan totaled \$24,916 for the year ended December 31, 2024.

BDO USA, LLP is the third-party administrator of the Plan; therefore, transactions are party-in-interest transactions. Fees paid to BDO USA, LLP for the year ended December 31, 2024 were paid by the Plan Sponsor.

WellsColeman performs the audit for the Plan. WellsColeman is a service provider of the Plan; therefore, transactions are party-in-interest transactions. Fees paid to WellsColeman for the year ended December 31, 2024 were paid by the Plan Sponsor.

All of these party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

**9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
