Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Keim Company 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

1. Description of the Plan

The following description of The Keim Company 401(k) Retirement Plan provides only general information. Participants should refer to the Plan agreement and summary plan description for a more complete description of the Plan's provisions.

General

Keim Lumber Company established the Keim Lumber Company 401(k) Retirement Plan effective January 1, 2000. During 2024, Keim Lumber Company changed their name to "The Keim Company" (the Plan Sponsor). Additionally, effective February 5, 2024, the Plan Sponsor amended the Plan to change the name of the Plan to "The Keim Company 401(k) Retirement Plan." The Plan is a defined contribution plan covering substantially all non-union employees of the Plan Sponsor who are 18 years of age and have three months of service. The Keim Company is the Plan's administrator and has appointed Mid Atlantic Trust Company and AuguStar Life Insurance Company as custodians of the Plan. The Plan is subject to the provisions of the ERISA.

Contributions

Each year participants may contribute the maximum amount which will not cause the Plan to violate the actual deferral percentage test, the maximum annual additions allowed pursuant to the Internal Revenue Code (IRC) or cause the Plan to exceed the maximum amount allowable as a deduction under the IRC. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also accepts Roth elective deferrals.

The Plan is a qualified automatic contribution arrangement (QACA) safe harbor 401(k) plan. The Plan provides for an QACA automatic enrollment deferral percentage of 6% for newly eligible participants. There is no automatic escalation feature. The new participant may affirmatively elect a different percentage or elect not to make an elective deferral contribution.

The QACA safe harbor matching contribution is 100% of the participant's elective deferral for the first 1% of participant compensation and 50% of the participant's elective deferral up to the next 5% of plan compensation, which was \$918,400.

Additional discretionary profit-sharing contributions may be contributed by the Plan Sponsor. These contributions are allocated to the participant's account in the proportion that each participant's compensation for the Plan year bears to the total compensation of all participants within the same group for such year. The Plan Sponsor made no discretionary profit-sharing contributions for each year ended December 31, 2024.

Vesting

A participant is 100% vested immediately in their contributions (including rollover contributions). Vesting for QACA safe harbor matching contributions is subject to 2-year cliff vesting. Vesting for discretionary profit-sharing and non-elective employer matching contributions (prior to conversion to QACA safe harbor provisions) is as follows:

Participant Accounts

Each participant's account is increased or decreased as appropriate with (a) the participant's contributions, (b) the Plan Sponsor's contributions, (c) net investment earnings based on the participant's account balance and composition, (d) administrative expenses, and (e) benefit payments. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments of the Plan are fully participant directed.

Notes Receivable from Participants

Participants are permitted to borrow from their vested interest of their individual account a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the participants' vested account balance. These loans are generally payable in equal installments through payroll deductions and carry an interest rate (4.25% to 9.50% at December 31, 2024) based on a bank or other professional lender's rate charged for a loan with similar characteristics. Loan terms typically range from 1-5 years but can be longer if for the purchase of a primary residence.

Payment of Benefits

Upon termination of service, a participant having an account balance of less than \$5,000 may elect to receive a lump-sum distribution as soon as administratively possible. If no election is made, a lump sum distribution will automatically be made when the participant terminates and receives the proper notice. Participants with more than \$5,000 may elect to receive a distribution in the form of a lump-sum distribution or a partial lump-sum distribution.

Non-terminated employees who have reached age 59 ½ may make withdrawals of up to 100% of their vested account balance. Non-terminated employees may also make withdrawals from their elective deferral account balance as a hardship withdrawal prior to reaching normal retirement age. Hardship withdrawals are subject to additional rules and conditions as outlined in the Plan agreement.

Forfeitures

Forfeitures may be used to reduce administrative expenses or future employer contributions. As of December 31, 2024 and 2023, unallocated forfeitures of \$4,653 and \$36,196, respectively, were available to reduce administrative expenses or future employer contributions. During the year ended December 31, 2024, \$19,656 was transferred into the forfeitures account and \$51,199 of forfeitures were used to reduce administrative expenses or employer contributions.

2. Summary of Significant Accounting Policies

Basis of Reporting

The Plan's financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Sponsor to make estimates and assumptions that affect certain reported amounts in the financial statements and accompanying notes. Accordingly, actual results may differ from these estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid using Plan assets, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of benefit payments and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

3. Information Provided by Custodians

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income (loss), interest income on notes receivable from participants, and benefit payments for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Sponsor and certified as complete and accurate by the Mid Atlantic Trust Company and AuguStar Life Insurance Company, the custodians of the Plan.

4. Fair Value Measurements

The authoritative accounting guidance establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the authoritative accounting guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs include quoted prices that are observable for the asset or liability and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Registered investment companies: Valued at the closing price reported on the active market on which the individual securities are traded.

Stable value collective trust: A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value (NAV) of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This

practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a partial or full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Insurance company separate account: Direct investments in separate accounts. These accounts are unit investment trusts that hold variable portfolios that correspond with the Plan's investment choices. The fair value of the Plan's investment in the separate account is based on the fair value of the underlying variable portfolios chosen. The fair value of the underlying variable portfolios is based on the closing NAV of the corresponding fund shares. There are no liquidity or redemption restrictions, and participants are able to transact based on the NAV published daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right per the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

6. Tax Status

The Plan has adopted a non-standardized, prototype plan document sponsored by July Business Services. The prototype plan obtained an opinion letter dated June 30, 2020, in which the Internal Revenue Service (IRS) stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter, however the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the Plan Sponsor to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Transactions With Parties in Interest

Mid Atlantic Trust Company and AuguStar Life Insurance Company are the custodians of the Plan and hold all of the Plan's investments. The custodians are parties in interest of the Plan as defined by ERISA Section 3(14), and accordingly, investment transactions in the funds are parties in interest transactions. Certain legal and accounting fees and certain administrative expenses relating to the maintenance of participant eligibility records are absorbed by the Plan Sponsor.

8. Risks and Uncertainties

The Plan invests in various investment securities which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. Delinquent Contributions

The Plan Sponsor made late participant contributions and participant loan repayments to the Plan for the year ended December 31, 2024. The Plan contributed late amounts totaling \$98,268 for the year ended December 31, 2024.

Also, a disclosure has been made on Form 5500, Schedule H, Page 4, line 4a that \$98,268 participant contributions and participant loan repayments were not made within the time period described in 29 CFR 2510.3-102, which is considered a Section 4975(a) prohibited transaction.

All prohibited transactions as described herein have been corrected. Plan management has yet to calculate earnings related to these transactions at the date of this report.

10. Reconciliation to Form 5500

Distributions in progress are unpaid distributions of terminated participants that are included on Form 5500.
