NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the Rochester Friendly Home 403(b) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Rochester Friendly Home d/b/a The Friendly Home (the Plan Sponsor). USI Consulting Group, Inc. (USI) serves as the third-party administrator and recordkeeper of the Plan. Charles Schwab Trust Bank serves as the custodian of the Plan's assets. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

All employees are eligible to participate in the Plan immediately upon hire. Participants are eligible to receive discretionary employer matching contributions and nonelective contributions upon attainment of the age 18 and will receive the match on the first day of the month coinciding with or next following the date the eligibility requirements are achieved.

Contributions

Active participants may make voluntary contributions in the form of salary reductions. The Plan allows participants to contribute up to 100% of their annual compensation, subject to certain limitations of the Plan and the Internal Revenue Code (IRC). Participants may also roll over contributions from other qualified retirement plans, at the discretion of the Plan Administrator. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan has a 3% automatic enrollment deferred election provisions, which is effective upon achieving eligibility.

The Plan allows for discretionary employer matching contributions. The employer match is calculated as 50% of employee deferral contributions up to 4% of eligible compensation for the years ended December 31, 2024 and 2023 and totaled \$237,775 and \$212,579, respectively, net of forfeitures applied.

The Plan allows for discretionary employer nonelective contributions. The nonelective contribution was 3% of eligible compensation for the years ended December 31, 2024 and 2023 and totaled \$478,298 and \$418,757, respectively. Such additional contributions will be allocated to participants based upon their percentage of total compensation to all eligible participants' compensation.

Participant Accounts

Each participant's account is credited with the participant's contribution, allocations of the discretionary employer matching and nonelective contributions, the Plan's earnings/losses, and charged with an allocation of administrative expenses. Allocations of administrative expenses are based on participant earnings/losses on investments, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF PLAN (Continued)

Vesting

Participants are immediately vested in their contributions plus actual earnings/losses thereon. Vesting in the discretionary employer matching and nonelective contributions is based on years of continuous service. A participant is fully vested after three years of credited service, or at death or permanent disability while an employee of the Plan Sponsor, as defined by the Plan.

Forfeitures

If an employee terminates their employment before their account has become fully vested, they will forfeit the unvested balance of their account, and the forfeitures are used to reduce employer matching and nonelective contributions. Forfeitures of non-vested account balances, including related investment earnings and fees, totaled \$123,503 and \$81,693 for the years ended December 31, 2024 and 2023, respectively. The Plan Sponsor used \$52,238 and \$62,652 of forfeitures to reduce employer matching and nonelective contributions in 2024 and 2023, respectively. There were \$117,166 and \$45,901 of available forfeitures for the years ending December 31, 2024 and 2023, respectively.

Notes Receivable from Participants

Participants may borrow from the funds attributable to the participant's contributions, the discretionary employer matching and nonelective contributions and rollover contributions. A participant may borrow a minimum of \$1,000 and up to the lesser of 50% of their vested account balance, or \$50,000, reduced by the excess of: (1) the participant's highest outstanding loan balance during the preceding one-year period over (2) the participant's loan balance outstanding before the loan is made. The Plan allows for one outstanding loan per participant at any time.

Loans are repayable through payroll deductions over not more than five years, except in the case of a loan taken for the purpose of purchasing a primary residence, which allows for a repayment period of fifteen years. All loans bear interest at the prime rate plus 1% as of the last day of the preceding calendar quarter.

Benefit Payments

On termination of service due to death, disability, or retirement, a participant will receive a lump-sum amount equal to the value of the participant's balance in his or her account. Participants may elect disbursement of their vested account balance in either a lump-sum amount or direct rollover into an individual retirement account of another qualified plan. The normal retirement is 65. Additionally, the Plan provides for in-services withdrawals from rollover contributions at any time to actively employed participants that have reached the age of 59 ½. Required distributions commence at the later of the calendar year after the participant attains age 70 ½ or retires.

Hardship Withdrawals

Hardship withdrawals from the Plan are permitted from a participant's account. All hardship withdrawals must comply with the rules relating to hardships, which are uniformly applicable to all participants.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

Noninterest-bearing Cash

Noninterest-bearing cash includes bank demand deposits accounts. The Plan's cash balances may at times exceed federally insured limits. The Plan has not experienced any losses in these accounts and believes it is not exposed to any significant risk with respect to cash.

Investment Valuation and Income Recognition

The Plan invests in mutual funds, money market funds and a guaranteed investment account. Investments are reported at fair value, except for fully benefit responsive investment contracts, which are reported at contract value. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's realized and unrealized gains on investments bought and sold, as well as held during the year. The costs of investments used in determining realized and unrealized gains is based upon average cost.

Fair Value Measurements – Definition and Hierarchy

The Plan uses various valuation techniques in determining fair value. Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 – Valuations based on quoted prices in active markets for identical assets or liability that the Plan has the ability to access.
- Level 2 – Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 – Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

See Note 4 for a description of where the Plan's assets fall within the fair value hierarchy.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan document.

Benefit Payments

Benefit payments are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

Risks and Uncertainties

Investments are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with investment securities and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in values in the near term would materially affect participants' account balances and the amount reported in the financial statements.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Accordingly, actual results could differ from those estimates.

3. CERTIFIED INVESTMENT INFORMATION

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following information was certified as accurate and complete by Charles Schwab Trust Bank, the custodian, as of and for the years ended December 31:

The following is a description of the valuation methodology used for assets measured at fair value:

Noninterest-bearing cash: fair value approximates the carrying amounts of such instruments due to their short maturity.

Mutual funds: valued at fair value based on quoted prices in active markets.

Money market funds: Valued at net asset value of shares held at year end based on quoted prices in active markets.

There were no changes in valuation methodologies used during 2024 and 2023.

5. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has an investment contract through Prudential Retirement Insurance and Annuity Company (Prudential). The investment product is a guaranteed income account which refers to assets invested under the guaranteed income fund. Under the terms of the contract, participants may ordinarily direct permitted withdrawal or transfers of all or a portion of their account balance at contract value within reasonable timeframes.

Contract value is the relevant measurement attribute for the portion of net assets available attributable to the investment contract. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. The contract is between the Plan Sponsor and the issuer. The repayment of principal and interest credited to participants is a financial obligation of the issuer. The contract is determined to be fully benefit responsive.

5. INVESTMENT CONTRACT WITH INSURANCE COMPANY (CONTINUED)

There are no events that allow the issuer to terminate the contract and which required the Plan Sponsor to settle at an amount different than contract value. The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring. The crediting interest rate is based on a contractually guaranteed interest rate. Such interest rates are reviewed on a semi-annual basis for resetting. The interest rate guaranteed by the contract issuer was 1.56% and 1.42% as of December 31, 2024 and 2023, respectively.

6. PARTY-IN-INTEREST TRANSACTIONS

USI is the recordkeeper of the Plan's assets. Charles Schwab Trust Bank is the custodian of the Plan's assets. As such, transactions between the recordkeeper, custodian and the Plan qualify as party-in-interest transactions. Additionally, notes receivable from participants are party-in-interest transactions.

7. TAX STATUS

The Plan adopted a pre-approved plan offered by USI Consulting Group. The pre-approved volume submitter 403(b) plan received an IRS Opinion Letter dated March 31, 2017, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the IRS Opinion Letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event that the Plan terminates, all participants will become fully vested in their accounts.

9. RECONCILIATION TO FORM 5500

Certain items have been classified differently between the financial statements and Form 5500. However, net assets available for benefits and changes in net assets available for benefits per the financial statements agree to Form 5500 in total as of and for the years ended December 31, 2024 and 2023.

10. SUBSEQUENT EVENTS

Effective January 1, 2025, the Plan was amended to eliminate the minimum age requirement of 18 years from the eligibility conditions for discretionary employer matching contributions and nonelective contributions. The amendment also allows for participants to receive the discretionary employer matching contributions and nonelective contributions immediately upon hire.

Subsequent events have been evaluated through October 15, 2025, which is the date the financial statements were available to be issued.
