Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Electrolux Home Products, Inc. Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. 1. Description of the Plan

General

The following brief description of the Electrolux Home Products, Inc. Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description and Plan Agreement for a more complete description of the Plan's provisions.

The Plan is a defined contribution benefit plan established to provide retirement benefits and a means of capital accumulation to all eligible employees of Electrolux Home Products, Inc. (the Company) and its affiliated companies in the United States. The Plan primarily covers eligible employees who are compensated on a salaried basis. Employees are immediately eligible to participate in the Plan upon their date of hire, as defined in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participants may make before-tax and after-tax contributions of up to 25% of their base salary or wages, as defined by the Plan. The Company matches 100% of the first 3% and 50% of the next 2% of a participant's contribution. The Plan includes a non-elective Company contribution of 4% of compensation for covered employees (as defined in the Plan document) who were employed on the last day of the Plan year.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan with respect to voluntary employee contributions unless they affirmatively elect not to make any such contributions. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated target date fund until changed by the participant.

The Company has determined that the Plan is considered to be a Qualified Replacement Plan (QRP) for purposes of contributing a portion of the surplus assets held in its terminated defined benefit plan. The Company contributed \$25,175,000 of such surplus assets to the Plan in 2023, and the amounts used to fund nonelective employer contributions were \$8,288,989 and \$9,230,519 during the years ended December 31, 2024 and 2023, respectively. At December 31, 2024 and 2023, the unallocated QRP contributions, including earnings thereon, were \$8,688,689 and \$16,560,178, which amount is expected to fund nonelective employer contributions over the next five years or less.

Participant Accounts

Each participant's account is credited with the participant's contributions and rollovers, the Company's contributions, and earnings or losses attributable to the respective investment elections and balances. Accounts for inactive participants receive a charge for administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeited Accounts

Forfeited balances of terminated participants' non-vested accounts are used to reduce future Company contributions and pay administrative expenses of the Plan. The balance of forfeitures of non-vested Company contributions was \$137,128 and \$160,324 at December 31, 2024 and 2023,

respectively. Forfeitures used to reduce Company contributions for the year ended December 31, 2024 were \$588,999. Forfeitures used to pay administrative expenses of the Plan for the year ended December 31, 2024 were \$46,255.

Vesting

Participants are automatically 100% vested in Company matching contributions and become 50% vested in Company non-elective contributions after two years of service and reach 100% vesting after three years of service.

Payment of Benefits

Participants may withdraw at any time all or a portion of their contributions, as defined (except before-tax contributions), subject to certain restrictions as provided in the Plan. Before-tax contributions may be withdrawn at age 59 ½, upon termination or disability, or in certain hardship cases, as defined in the Plan. Company contributions that are vested can only be withdrawn upon termination, disability, death, or retirement.

Investment Options

Each participant may elect from various investment funds in which the participant's and the Company's matching contributions are to be invested.

Plan Expenses

The Company, at its discretion, pays for certain administrative expenses of the Plan.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

Plan Transfers

Employees within the Company have the ability to transfer between the Plan and Electrolux Home Products, Inc. Thrift Plan based on the employee's status. The amounts so transferred shall be subject to all terms and conditions of the recipient plan. In addition, the amounts transferred shall be allocated to such sub-accounts as determined by the Plan administrator, in its sole and absolute discretion.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements, accompanying notes, and supplemental schedule. Accordingly, actual results could differ from those estimates.

Subsequent Events

The Plan has evaluated subsequent events through the date of the Independent Auditor's Report, the date the financial statements were available to be issued, for possible recognition or disclosure in the financial statements, and has determined that no events have occurred through that date which require adjustment to or disclosure in the financial statements.

3. Information Certified by the Trustee

The Plan has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate.

- Investments, as reflected in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, interest and dividend income, and other investment income as reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments, as reflected in the Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024.

The Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to this certified information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

4. Income Tax Status

The Plan has obtained its latest determination letter dated May 23, 2012, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan sponsor is responsible for reviewing the annual Required Amendments List issued by the IRS for individually designed plans to retain qualified tax status. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, qualifies as tax exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. Transactions with Parties-in-Interest

Transactions that qualify as parties-in-interest consist of purchases and sales of Fidelity funds managed by the Plan's trustee. These party-in-interest transactions are exempt from the prohibited rules under ERISA. The Plan made direct payments to parties in interest for the year ended December 31, 2024 in the amount of \$274,707.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. Fair Value Measurements

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobserved inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 inputs must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market Funds - These are valued at the daily closing price as reported by the fund.

Self-Directed Brokerage Accounts - These accounts comprise common stock, mutual funds, and cash and cash equivalents. The individual investments in the self-directed brokerage accounts are valued on the basis of readily determinable market prices.

Shares of Registered Investment Companies - These are valued at the net asset value (NAV) of shares held by the Plan at year-end. The Shares of Registered Investment Companies held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission.

Common/Collective Trusts (CCTs) - CCTs are valued at the NAV of units held. The NAV, as provided by the trustee of the CCTs, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the CCT less its liabilities. This practical expedient is not used when it is determined to be probable that the CCTs will sell for an amount different than the reported NAV. The CCTs provide for daily redemptions by the Plan at reported NAV with no advance notice. There are no unfunded commitments related to these investments. These are direct filing entities.

Shares of Common Stock - This is valued at the closing price reported on the active market on which the individual securities are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
