Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Roadteam Staffing, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Roadteam Staffing, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS

Note 1. Plan Description

The following description of the Roadteam Staffing, Inc. (“Company”) 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan document and Summary Plan Description for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

General: The Plan is a participant-directed defined contribution plan covering eligible full-time employees of the Company who have completed 90 days of service. If an employee is covered under a collective bargaining agreement (i.e. union employee), they may be excluded from participating in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's investment committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

Contributions: The Plan provides for the following types of payments to be made to the Plan:

Salary deferral contributions: Employees who are eligible to participate in this plan may elect to contribute a share of their compensation as defined in the Plan, up to the maximum amount allowed by ERISA and the Internal Revenue Code. Employees who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions as allowed by the Internal Revenue Code. Participants may also designate all or a portion of their elective deferral as a Roth elective deferral. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Employer matching contributions: The Plan provides that the employer will make a matching contribution equal to 50% of the first 3% of eligible compensation that a participant contributed to the Plan up to a maximum of \$1,000.

Participant accounts: Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions and the Company's contributions. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Employer contributions vest over six years of service; 20% after two years, 40% after three years, 60% after four years, 80% after five years, and 100% after six years. Upon death, permanent disability, or normal retirement at the age of 65, a participant's account becomes fully vested.

Payment of benefits: On termination of service due to death, disability, retirement or separation, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested account balance or installments over a period of time specified in the plan agreement. If a participant's account balance is between \$1,000 and \$5,000 and a distribution election is not made, their vested account balance will be automatically deposited in a rollover IRA. If a participant's account balance is less than \$1,000 and a distribution election is not made, the participant will receive their benefits in a lump-sum cash payment. Participants with a vested balance over \$5,000 may elect to receive a distribution of their vested account balance as a single lump-sum payment in cash, installments over a period of time, or ad hoc distributions.

Benefits are recorded when paid.

NOTES TO FINANCIAL STATEMENTS

Note 1. Plan Description (Continued)

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of 50% of their account balance, not to exceed \$50,000. Only two outstanding notes receivable are permitted at any time and the note receivable repayment schedule can be no longer than 60 months unless it is used for the purchase of a principal residence. Principal and interest is paid ratably through payroll deductions. The loan interest rate is determined by the Plan Sponsor's management and shall be charged based on rates currently being used by financial institutions lending money under similar circumstances. The notes receivable are secured by the balance in the participant's account.

Forfeited accounts: Forfeited nonvested accounts can be used to pay administrative expenses and reduce future Company contributions. Forfeited nonvested accounts as of December 31, 2024 and 2023, totaled \$52,224 and \$31,202, respectively. There were no forfeitures used to pay Plan administrative expenses or reduce employer matching contributions for the year ended December 31, 2024.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The accompanying financial statements are prepared in accordance with accounting principles generally accepted in the United States of America.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

NOTES TO FINANCIAL STATEMENTS

Note 2. Summary of Significant Accounting Policies (Continued)

Administrative expenses: Plan fees and expenses, including fees and expenses connected with the providing of administrative services by external service providers are paid by either the Plan or the Company, as provided by the Plan document. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's accounts. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent events: Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued. Events occurring after that date have not been evaluated to determine whether a change in the financial statements would be required.

Note 3. Certification of Investment Information

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Equitable Life Insurance Company, a qualified institution, has certified the following information in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate.

- ▲ Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- ▲ Investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- ▲ Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Codification Topic 820, Fair Value Measurement, are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

NOTES TO FINANCIAL STATEMENTS

Note 4. Fair Value Measurements (Continued)

Level 2 – Inputs to the valuation methodology included within Level 2 that are observable for the asset or liability, either directly or indirectly, such as:

- a) Quoted prices for similar assets or liabilities in active markets;
- b) Quoted prices for identical or similar assets or liabilities in inactive markets;
- c) Inputs other than quoted prices that are observable for the asset or liability;
- d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies and assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

NOTES TO FINANCIAL STATEMENTS

Note 6. Tax Status

The Plan operates under an adoption agreement in connection with a non-standardized form of a prototype plan sponsored by Equitable Life Insurance Company. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 7. Party-in-Interest Transactions

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, and any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, loans to participants and the management of investments held by the trustee are considered party-in-interest transactions, which are exempt from the prohibited transaction rules.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

As of December 31, 2024 and 2023, the Plan had investments of \$1,412,558 and \$1,307,710, respectively, which were concentrated in three funds.
