## Notes to Financial Statements December 31, 2024

### 1. Plan Description

The following description of the Latitude 36 Foods LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document, as amended, for a more complete description of the Plan’s provisions.

#### *General*

The Plan, as amended, is a defined contribution plan established for the benefit of Latitude 36 Foods LLC (the “Company”) employees, other than union employees and non-resident aliens. The Plan became effective on January 1, 2018. The Company is the Plan sponsor, serves as the Plan administrator and is responsible for the day-to-day administration and operation of the Plan. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (“IRC”) and similar state tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Minnesota Life Insurance Company, and its affiliated and successor entities, is the asset custodian of the Plan. Effective January 22, 2024, Standard Retirement Services, Inc. (“The Standard”), and its affiliated entities, become the record keeper and provide administrative services to the Plan.

#### *Eligibility*

Employees of the Company who have reached 21 years of age and have completed six months of service are eligible to participate in the Plan. Entry date is the first day of the month coinciding with or next following the date employees satisfy the eligibility requirements. The service period requirement is considered fulfilled if the employee was previously hired by an acquired entity.

#### *Contributions*

Each year, participants may make pre-tax or Roth contributions of eligible compensation, as defined in the Plan document, up to the maximum amount allowed by the statutory limit. For the year ended December 31, 2024, the annual contribution limit was \$23,000. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions up to \$7,500 for the year ended December 31, 2024. The Company makes safe harbor matching contributions equal to 100% of participants’ elective deferrals up to 3% of eligible compensation, and 50% of participants’ elective deferrals between 3% and 5% of eligible compensation. All employer contributions are invested in the same manner that the participant directs his or her investments. Participants may also rollover amounts representing distributions from other qualified defined benefit or contribution plans.

#### 1. Plan Description (continued)

##### *Participant Accounts*

Each participant's account is credited with the participant's contributions, and allocations of (a) the employer's matching contributions, (b) investment earnings or losses, and (c) administrative expenses. Allocations are based on participant earnings, account balance, or specific participant transactions, as defined in the Plan document. A participant is entitled to the benefit provided from the participant's vested account.

##### *Vesting*

Participants are immediately 100% vested in their contributions, employer safe harbor match, and actual earnings thereon.

##### *Notes Receivable from Participants*

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The notes receivable from participants are secured by the balance in the participant's account and bear fixed, reasonable rates of interest, as determined by the Plan administrator. Notes receivable from participants must be repaid within a five-year period, unless it is used to purchase a principal residence, in which case the Plan administrator may permit a longer repayment term. Principal and interest are paid directly by the participants. Participants may have no more than one loan outstanding at a time.

##### *Benefit Payments*

Upon termination of service due to death, permanent disability, or retirement, the participant or the participant's beneficiary will receive the vested account balance. If the vested account balance exceeds \$7,000, the participant (or beneficiary) may elect to receive either a single lump-sum payment, installments over a period of not more than the participant's (or beneficiary's) assumed life expectancy, or partial withdrawals. If a terminated participant's vested account balance is less than \$7,000, the Plan will make a distribution of the vested account balance to an Individual Retirement Account ("IRA") if the participant did not make an affirmative election to either receive or rollover the distribution.

#### 2. Summary of Significant Accounting Policies

##### *Basis of Accounting*

The financial statements are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

##### *Use of Estimates*

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

##### *Contributions*

Participant contributions are recorded by the Plan in the year withheld from participant earnings. Contributions to the Plan by the Company are recorded in the year which they become obligations of the Company.

##### *Investment Valuation and Income Recognition*

Investments in pooled separate accounts (“PSAs”) are valued on a net asset value (“NAV”) per share basis. The PSAs are credited with earnings on the underlying investments and charged for Plan benefits paid and deductions for investment expenses and annual management fees. Redemptions may occur on a daily basis.

The Plan invests in a guaranteed interest account, which is a group annuity contract valued at contract value. Contract value reflects the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan and is the relevant measure for the portion of assets attributable to the fully benefit-responsive guaranteed interest account.

The Plan administrator determines the Plan’s valuation policies utilizing information provided by the Plan’s asset custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation of investments consists of both the realized and unrealized gains and losses.

##### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowances for expected credit losses were required as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the participant loan is deemed to be in default, the participant loan balance is reduced and a distribution (referred to as deemed distributions) is recorded pursuant to the provisions of the Plan document. During the year ended December 31, 2024, there were \$10,168 of delinquent participant loans that were reclassified as deemed distributions.

##### *Payment of Benefits*

Benefits are recorded when paid.

##### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are not included on the accompanying statement of changes in net assets available for benefits. Investment advisory fees and fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Other investment related expenses are included in net appreciation/depreciation of investments.

#### 3. Certified Investment Information

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, The Standard Insurance Company (as of and for the year ended December 31, 2024) and Minnesota Life Insurance Company (as of December 31, 2023), qualified institutions, have certified that the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Interest income from investments, and net appreciation of investments reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment information included in Schedule H, Part IV, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to the certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

#### 4. Investments and Fair Value Measurements

GAAP establishes a framework for measuring investments at fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under GAAP are described as follows:

Level 1: Inputs to the valuation methodology are based on unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Investments in PSAs are valued using the NAV as of the reporting date. The NAV is used as a practical expedient to estimate fair value. PSAs are valued based on the underlying investments (i.e., common stock, mutual funds, and short-term securities) in the separate account as reported by Minnesota Life Insurance Company based on recent transaction prices. While the majority of the underlying asset values are based on quoted prices, NAV of the PSAs are not publicly quoted. The PSAs held by the Plan provide for daily redemptions by the Plan at reported NAV with no advance notice requirement. Investments that are measured at fair value using the NAV per share (or its equivalent) practical expedient have not been categorized in the fair value hierarchy.

The Plan is party to a fully benefit-responsive guaranteed interest account with Minnesota Life Insurance Company. The guaranteed interest account issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Because the guaranteed interest account is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for plan benefits. The guaranteed interest account is presented on the accompanying statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by the issuer, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Company or other Company events that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants. In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

Although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the value of certain financial instruments could result in a different value measurement at the reporting date. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

#### 5. Risk and Uncertainties

The Plan invests in various investment securities (Note 4). Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the accompanying financial statements.

#### 6. Tax Status

The Plan adopted a Non-Standardized Defined Contribution Pre-Approved Plan provided by Minnesota Life Insurance Company. The Pre-Approved Plan provider received an opinion letter from the Internal Revenue Service ("IRS"), dated June 30, 2020, which stated that the Pre-Approved Plan, as then designed, was in compliance with the applicable sections of the IRC. The Plan has not received a determination letter specific to the Plan. Although the Plan has been amended since the issuance of the opinion letter, the Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable provisions of the IRC. Therefore, the Plan administrator believes that the Plan and the related trust continue to be tax-exempt.

GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any periods in progress.

#### 7. **Related Party and Party-In-Interest Transactions**

Plan investments are managed by Minnesota Life Insurance Company and The Standard provides recordkeeping and administrative services to the Plan. The Company pays for other fees related to the Plan's operations directly and its employees provide uncompensated services to the Plan. The Plan issues notes receivable to participants, which are secured by the vested balances in the participants' accounts. Management believes these transactions qualify as permitted party-in-interest transactions for which a statutory exemption exists.

#### 8. **Operational Error and Contingencies**

Plan management identified an operational error related to a failure to withhold contributions for certain participants from differential pay rate types and a failure to provide the Company's matching contributions to those participants. In October 2023, the Plan administrator corrected this matter prospectively and began to properly withhold contributions and provide the Company's matching contributions for the differential pay rate types. The Plan and/or the Plan sponsor may be subject to various fines, penalties and interest. The accompanying financial statements do not include any accruals or provisions related to the outcome of this uncertainty.

#### 9. **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

#### 10. **Subsequent Events**

The Plan administrator has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued. In September 2025, the Company made a corrective contribution, on behalf of the affected participants, of \$20,424 to remedy the operational error described in Note 8 for periods prior to October 2023. Except for this matter, no other material subsequent events were identified that the Plan administrator believes require financial statement recognition or disclosure.
