Notes to Financial Statements

December 31, 2024 and 2023

Note 1 - Plan Description

The following description of 401(k) Profit-Sharing Plan for Employees of Northwestern University Settlement Association (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Northwestern University Settlement Association (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan provides for employee salary elective deferral contributions, on pretax and Roth bases, up to a maximum of 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan includes an auto-enrollment provision where all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set to 3 percent of eligible compensation and their contributions invested in their respective retirement funds until changed by the participant.

There were no employer matching contributions for the year ended December 31, 2024. Instead, the Company makes nonelective contributions at a fixed rate of 5 percent of a participant's eligible compensation for participants who are at least 21 years of age and have completed at least six months of service. Enrollment in the employer contribution begins on the first day of January or July of each year after eligibility is met. Certain employees, including certified Northwestern University Settlement Association Rowe Staff, AmeriCorps Temp, Camp Seasonal, Rowe Temp, and NUSA Temp employees, are excluded from an employer contribution. Effective July 1, 2025, the Company no longer makes nonelective contributions at a fixed rate; rather, discretionary contributions are made as determined by the Company.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon.

Note 1 - Plan Description (Continued)

Vesting in the Company's nonelective employer contribution portion of their accounts, plus actual earnings thereon, is based on years of service. The Company's nonelective contributions vest according to the following schedule:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 2	- %
At least 2 but less than 3	20
At least 3 but less than 4	40
At least 4 but less than 5	60
At least 5 but less than 6	80
6 or more	100

Upon death or disability, a participant's account balance becomes fully vested.

Benefit Payments

Distributions are payable upon termination of employment, death, disability, or normal retirement age of 65, and a participant (or the participant's beneficiary in the case of death) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities. In-service distributions from a participant's account are available to employees over age 59½.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeiture will occur on the last day of the plan year in which a former participant incurs five consecutive one-year breaks in service or upon the distribution of the entire vested portion of the participant's account, whichever is earlier. The Company allocates forfeitures to participants based on the participant's share of total plan assets. At December 31, 2024 and 2023, forfeited account balances totaled \$33,473 and \$120,796, respectively.

Participant Notes Receivable

Effective February 6, 2024, the Plan was amended to permit loans to be made to participants and their beneficiaries. Participants may borrow from their accounts subject to certain maximum and minimum amounts prescribed in the Plan and in the Internal Revenue Code. Notes receivable bear interest at a market rate.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Mutual of America Life Insurance Company or its affiliates. Mutual of America Life Insurance Company is the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

During 2023, the plan sponsor received a payment from the Plan in the amount of \$1,993 related to contributions erroneously made to the Plan in 2022. During 2024, the plan sponsor received a payment from the Plan in the amount of \$31,555 related to contributions erroneously made to the Plan in 2023. Such payments constituted nonexempt transactions. For both nonexempt transactions, corrective action consisting of a contribution to refund the Plan and related lost earnings have not yet been made as of the report date.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation

The Plan's investments are stated at fair value. The unallocated contract is not considered benefit responsive and is presented at fair value. The unallocated contract invests in the general assets of Mutual of America Life Insurance Company; however, since there are no specific securities in Mutual of America Life Insurance Company's general account related to this contract and due to the contract terms, including the frequency of the interest rate reset intervals, contract value approximates fair value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. See Note 4 for additional information.

The pooled separate accounts are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. See Note 4 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 14, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Mutual of America Life Insurance Company (the "Custodian") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Custodian.

Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
