### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

NOTE 1--DESCRIPTION OF PLAN

The following brief description of Northeast Georgia Health System, Inc. 401(k) Retirement Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

*General:* The Plan is a defined contribution plan established by Northeast Georgia Health System, Inc., (the Plan sponsor) under the provisions of Section 401(a) of the United States Internal Revenue Code (the IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Plan sponsor and any adopting participating employers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as well as certain provisions of the federal income tax laws.

All employees of the Plan sponsor are subject to the following eligibility requirements:

- Age: None
- Service: 1 month
- Status Exclusions:
  - Leased employees
  - Non-resident aliens with no U.S.-earned income
  - Members of collective bargaining agreement
  - Independent contractors or non-employees

Upon satisfying the eligibility requirements, employees may participate in the Plan on the first day of the next month.

*Contributions:* Participants may elect to contribute to the Plan, through salary reduction, a percentage of their eligible compensation for the Plan year up to the Internal Revenue Service (IRS) limit. At the discretion of the Plan administrator, participants may be permitted to deposit or "rollover" into the Plan distributions they have received from other plans and certain Individual Retirement Accounts (IRAs). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The following contribution types are allowed by the Plan:

- Rollover contributions
- Employer safe harbor
- Roth deferrals
- Elective deferrals
- Employer matching

The Plan has an automatic enrollment provision whereby employees must elect out of the Plan if they do not wish to participate. These provisions call for the Plan sponsor to automatically withhold 3% from a participant's compensation for contribution to the Plan with automatic 1% deferral increases, starting after the first full year of Plan participation, each year until a 6% deferral level is attained, unless the participant elects a lesser percentage (including zero).

The Plan sponsor has elected to operate the Plan as a safe harbor 401(k) plan, which makes the Plan exempt from certain compliance testing requirements. The Plan sponsor makes a safe harbor contribution of 100% of the first 2% deferred and 50% of all deferrals greater than 2% but less than or equal to 6%. Subsequent to year end, the Plan was amended to increase the Plan sponsor's safe harbor contribution. Effective January 1, 2025, the Plan sponsor will contribute 100% of the first 3% deferred and 50% of all deferrals greater than 3% but less than or equal to 6%. Participants direct the investment of all contributions to the Plan into various investment options offered by the Plan.

The Plan sponsor may make safe harbor matching contributions, which will be allocated in accordance with the Plan provisions.

*Participant Accounts:* Each participant's account is credited with the participant's contributions, the Plan sponsor's matching contributions, and an allocation of Plan earnings or losses; it is also charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the vested benefit of their account balance.

*Vesting:* Participants are immediately vested in their salary reduction contributions, including catch-up contributions, rollover contributions from other plans, plus actual earnings thereon. The method for crediting vesting service for safe harbor contributions and matching contributions is based on vesting periods of service. Participants are credited with a period of service for 1,000 hours worked. If participants are employed on or after their Normal Retirement Age or if they terminate employment on account of death or disability, they are 100% vested in their matching contributions.

Participants are vested in safe harbor and matching contributions based on years of credited employment and employment date as follows:

*Forfeitures:* Forfeitures represent unvested portions of terminated participants' accounts. The Plan allows forfeitures of non-vested Plan sponsor contributions to be used as follows:

- Reduce Company contributions
- Pay administrative expenses
- Restore eligible rehire forfeiture account balance

As of December 31, 2024 and 2023, forfeiture balances totaled \$2,336,926 and \$1,319,971, respectively. During the year ended December 31, 2024, forfeited non-vested accounts of \$427,906 were used.

*Investment Options:* Upon enrollment in the Plan, a participant may direct the contributions made to the Plan, for or on behalf of the participant, to any one or more of the investment funds determined at the discretion of the Plan administrator and Plan sponsor and in such multiples as the participant prescribes. A participant may change his or her investment direction with respect to future contributions or redirect the investment of his or her account balances.

*Notes Receivable from Participants:* Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum balance or percent subject to IRS limits. The loans are secured by the balance in the participant's account and bear interest at rates between 4.25% and 9.50%. Principal and interest are paid through payroll deductions and generally repaid within 5 years.

*Payment of Benefits:* Upon termination of service due to death, disability, or retirement, a participant is entitled to receive a distribution equal to the value of the participant's vested interest in his or her account. Distribution of a deceased participant's account will be made to the designated beneficiary.

The following types of distributions are also allowed by the Plan:

- Hardship
- In service
- Involuntary cash-outs

- Rollover source withdrawal at any time
- Termination partial withdrawal

*Administrative Expense:* Administrative expenses related to maintaining participant accounts and third-party administration are paid by the Plan and deducted from participant funds. Other Plan expenses may be paid by either the Plan or the Plan sponsor, as provided by the Plan document. Expenses paid directly by the Plan sponsor are excluded from these financial statements.

*Plan Termination:* Although it has not expressed any intent to do so, the Plan sponsor has the right under Plan provisions to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, all participants become immediately vested in their account balance.

NOTE 2--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

*Basis of Accounting:* The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

*Use of Estimates:* The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition:* Investments in shares of registered investment companies are reported at fair value (except for any fully benefit-responsive investment contracts, which are reported at contract value) based on the quoted market values of the shares held by the Plan as determined by the trustee. Money market funds are stated at cost, which equals fair value.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Notes Receivable from Participants:* Notes receivable from participants are stated at their unpaid principal balance plus any accrued interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are recognized as benefits paid to participants based upon the terms of the Plan document.

- *Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- *Level 2:* Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- *Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The investment valuation methods described in Note 2 may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan administrator believes the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Following is a description of the valuation methodologies used for assets measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Cash and Cash Equivalents:* Stated at cost, which equals fair value.

*Registered Investment Companies:* Valued at the daily closing price as reported by the fund. Shares of registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The shares of registered investment companies held by the Plan are deemed to be actively traded.

**NOTE 5--RELATED PARTY TRANSACTIONS AND TRANSACTIONS WITH PARTIES-IN-INTEREST**

Parties-in-interest, as defined by DOL regulations, include service providers to the Plan. Service providers may include, but are not limited to, the custodian, trustee, third-party administrator (TPA), investment managers, investment advisors, legal counsel, and Plan auditor.

During the year ended December 31, 2024, the Plan made direct payments of \$601,789 to parties in interest for certain fees.

**NOTE 6--RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 7--INCOME TAX STATUS**

The Plan sponsor adopted a plan which received a favorable opinion letter, issued to the document provider, from the Internal Revenue Service dated June 30, 2020, which states that the Plan is designed in accordance with the applicable sections of the IRC. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan administrator has evaluated the tax positions taken by the Plan and determined there are no uncertain tax positions as of December 31, 2024, that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
