INDEPENDENT AUDITORS' REPORT

To the Plan Administrator

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Edwards 401K Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE A - DESCRIPTION OF PLAN

The following description of the Edwards 401k Plan (“the Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution safe harbor plan which was adopted on December 7, 2020 and provides retirement benefits for employees of Southern Rigging Co, LLC (the “Plan Sponsor”) and employees of other related entities under common control that elect to participate in the Plan. The Plan covers employees who are age eighteen or older and have completed 6 months of consecutive service except for union and leased employees (“participants”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan’s investments are through participant directed mutual funds.

Contributions

Participants may voluntarily make qualified retirement contributions to the Plan which are deductible by the participants for federal income tax purposes under Section 401(k) of the Internal Revenue Code (“IRC”). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants may make a minimum contribution of 1% to a maximum of 100% of their total annual compensation, as defined in the plan agreement, subject to certain IRC limits. Participants may designate all or a portion of their contributions as Roth deferral contributions at the time their deferral election is made. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Plan Sponsor is required to make matching ADP safe harbor contributions based on ADP safe harbor matching formulas. During 2024 and 2023, the ADP safe harbor matching formula used to determine the Plan Sponsor contribution was 100% of the first 3% of a participant’s compensation plus 50% of participant contributions between 3% to 5% of compensation.

The Plan also provides that the Plan Sponsor may contribute an additional annual discretionary contribution as authorized by the Plan’s Sponsor’s management. To share in an allocation of the employer discretionary contributions, the employee must complete at least 1,000 hours of service during the plan year and be employed on the last day of the plan year except in the event of a participant’s death, permanent disability, or normal retirement. During 2024 and 2023, no additional annual discretionary contributions were made.

Plan Sponsor and participant contributions may not exceed the maximum amount allowable for federal income tax purposes.

NOTE A - DESCRIPTION OF PLAN (CONTINUED)

Participant Accounts

Each participant's account is credited or charged with the participant's contributions, allocations of Plan Sponsor contributions, investment earnings or losses, participant withdrawals, forfeitures, and administrative expenses. Allocations are based on participant compensation or account balances, as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their elective salary deferral contributions and employer safe harbor matching contributions plus actual earnings or losses thereon. Vesting in the Plan Sponsor's discretionary profit sharing contributions plus earnings or losses thereon are based on years of continuous service. Participants vest ratably at 20% after the second year of service and each year thereafter until fully vested after 6 years of service.

Payment of Benefits

On termination of service due to death, permanent disability, or retirement, a participant with an account balance that exceeds \$1,000 may receive a lump-sum payment equal to his or her entire account. For termination of service due to other reasons, a participant with an account balance that exceeds \$1,000 will be entitled to receive only the vested interest in his or her account. If the vested value of a participant's account is less than \$1,000, the total vested balance is distributed as an automatic lump-sum payment in cash.

Hardship Withdrawals

The Plan permits distributions in the event of a financial hardship, as defined in the plan document. These distributions are taxable and may be subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59 ½ and does not meet a qualified exception to the penalty. Hardship withdrawals are limited to the participant's elective account balance including earnings, and QNECs and QMACs and earnings thereon.

Administrative expenses

Certain expenses for maintaining the Plan are paid by the Plan or the Plan Sponsor. Fees incurred for investment management services are netted within the net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than as a direct payment.

Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the plan agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Refer to Note D for additional information about fair value.

Dividend income is recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America which requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE D – FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023.

- (i) *Money market and Mutual funds:* Valued at the net asset value of shares held by the Plan at year end based on a quoted price in an active market.

NOTE E - TAX STATUS

The Plan Sponsor adopted an IDP-Formatted nonstandardized pre-approved plan, which received a favorable determination letter from the Internal Revenue Service (“IRS”) on June 30, 2020, which stated that the IDP-Formatted nonstandardized pre-approved plan was designed in accordance with applicable sections of the IRC. The Plan itself has not received a determination letter from the IRS stating that the Plan is qualified under Section 401(a) of the IRC. The plan administrator believes that the IDP-Formatted nonstandardized pre-approved plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and is therefore, qualified and exempt from taxation.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

NOTE F - RELATED PARTY TRANSACTIONS

Certain expenses for maintaining the Plan are paid by the Plan or the Plan Sponsor. Fees incurred for investment management services are netted within the net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than as a direct payment. During 2024 and 2023, administrative fees of \$25,240 and \$18,706, respectively, were paid by the Plan to parties-in-interest.

NOTE G – RISKS AND UNCERTAINTIES

The Plan invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan’s investments are through participant directed mutual funds.

Contributions

Participants may voluntarily make qualified retirement contributions to the Plan which are deductible by the participants for federal income tax purposes under Section 401(k) of the Internal Revenue Code (“IRC”). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants may make a minimum contribution of 1% to a maximum of 100% of their total annual compensation, as defined in the plan agreement, subject to certain IRC limits. Participants may designate all or a portion of their contributions as Roth deferral contributions at the time their deferral election is made. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Plan Sponsor is required to make matching ADP safe harbor contributions based on ADP safe harbor matching formulas. During 2024 and 2023, the ADP safe harbor matching formula used to determine the Plan Sponsor contribution was 100% of the first 3% of a participant’s compensation plus 50% of participant contributions between 3% to 5% of compensation.

The Plan also provides that the Plan Sponsor may contribute an additional annual discretionary contribution as authorized by the Plan’s Sponsor’s management. To share in an allocation of the employer discretionary contributions, the employee must complete at least 1,000 hours of service during the plan year and be employed on the last day of the plan year except in the event of a participant’s death, permanent disability, or normal retirement. During 2024 and 2023, no additional annual discretionary contributions were made.

Plan Sponsor and participant contributions may not exceed the maximum amount allowable for federal income tax purposes.

NOTE A - DESCRIPTION OF PLAN (CONTINUED)

Participant Accounts

Each participant's account is credited or charged with the participant's contributions, allocations of Plan Sponsor contributions, investment earnings or losses, participant withdrawals, forfeitures, and administrative expenses. Allocations are based on participant compensation or account balances, as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their elective salary deferral contributions and employer safe harbor matching contributions plus actual earnings or losses thereon. Vesting in the Plan Sponsor's discretionary profit sharing contributions plus earnings or losses thereon are based on years of continuous service. Participants vest ratably at 20% after the second year of service and each year thereafter until fully vested after 6 years of service.

Payment of Benefits

On termination of service due to death, permanent disability, or retirement, a participant with an account balance that exceeds \$1,000 may receive a lump-sum payment equal to his or her entire account. For termination of service due to other reasons, a participant with an account balance that exceeds \$1,000 will be entitled to receive only the vested interest in his or her account. If the vested value of a participant's account is less than \$1,000, the total vested balance is distributed as an automatic lump-sum payment in cash.

Hardship Withdrawals

The Plan permits distributions in the event of a financial hardship, as defined in the plan document. These distributions are taxable and may be subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59 ½ and does not meet a qualified exception to the penalty. Hardship withdrawals are limited to the participant's elective account balance including earnings, and QNECs and QMACs and earnings thereon.

Administrative expenses

Certain expenses for maintaining the Plan are paid by the Plan or the Plan Sponsor. Fees incurred for investment management services are netted within the net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than as a direct payment.

Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the plan agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Refer to Note D for additional information about fair value.

Dividend income is recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America which requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE D – FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023.

- (i) *Money market and Mutual funds:* Valued at the net asset value of shares held by the Plan at year end based on a quoted price in an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - TAX STATUS

The Plan Sponsor adopted an IDP-Formatted nonstandardized pre-approved plan, which received a favorable determination letter from the Internal Revenue Service (“IRS”) on June 30, 2020, which stated that the IDP-Formatted nonstandardized pre-approved plan was designed in accordance with applicable sections of the IRC. The Plan itself has not received a determination letter from the IRS stating that the Plan is qualified under Section 401(a) of the IRC. The plan administrator believes that the IDP-Formatted nonstandardized pre-approved plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and is therefore, qualified and exempt from taxation.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

NOTE F - RELATED PARTY TRANSACTIONS

Certain expenses for maintaining the Plan are paid by the Plan or the Plan Sponsor. Fees incurred for investment management services are netted within the net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than as a direct payment. During 2024 and 2023, administrative fees of \$25,240 and \$18,706, respectively, were paid by the Plan to parties-in-interest.

NOTE G – RISKS AND UNCERTAINTIES

The Plan invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
