We have performed audits of the accompanying financial statements of Cayuga Medical Associates 403(b) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

YEARS ENDED DECEMBER 31, 2024 AND 2023

A. DESCRIPTION OF PLAN

The following description of the Cayuga Medical Associates 403(b) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a 403(b) defined contribution plan covering substantially all employees of Cayuga Medical Associates (the Organization). An employee is eligible to participate in the elective deferral feature of the Plan immediately upon employment. In order to be eligible for the qualified non-elective contribution (QNEC), a participant must be at least 21 and have completed 1 year of service with the Organization. The Organization may, in its sole discretion, also make a non-elective contribution to the Plan on behalf of a participant who has completed at least 1,000 hours of service during the Plan year and is employed as of the last day of the year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors is responsible for the governance of the Plan.

Contributions: Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan (elective deferral contributions). Contributions are subject to limitations determined by the Internal Revenue Service. The Organization, at the discretion of the board of directors, may contribute to the Plan discretionary matching contributions for all eligible participants and may also contribute to the Plan additional discretionary amounts for all eligible participants. Participants who have met the eligibility requirements are eligible to participate in the Organization's QNEC equal to 3% of the participant's eligible compensation. The Organization made QNEC contributions of \$1,517,398 and \$1,178,597 to the Plan in 2024 and 2023, respectively. The Organization also made additional discretionary contributions of up to 4.5% of the first \$345,000 and \$330,000 of compensation for certain providers in the amounts of \$1,503,201 and \$1,289,574 to the Plan in 2024 and 2023, respectively.

Participant Accounts: Each participant's account is credited with the participant's elective deferral contributions and/or additional discretionary contributions, Plan earnings (losses), administrative expenses, and loan activity. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in all elective deferral and QNEC contributions plus actual earnings thereon. Vesting in the Organization's discretionary contributions plus earnings thereon is based on years of service. A participant becomes fully vested after 3 years of credited service. The following presents the vesting schedule:

Forfeited Accounts: Forfeited non-vested accounts are retained by the Plan and used to reduce Organization contribution amounts. Forfeited non-vested accounts and related earnings into the Plan totaled \$35,656 and \$42 as of December 31, 2024 and 2023, respectively.

Notes Receivable from Participants: Participants may borrow a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of his or her nonforfeitable accrued benefit. Loan terms range from one to five years. The loan interest rate for these Plan loans may be fixed or variable and the initial rate is determined by the terms of the controlling contract as are the rate adjustment details and frequency. Loans are secured by the balances in the participant's account. Principal and interest is paid ratably by participants using an online service.

Payment of Benefits: On termination of service, disability, or attainment of age 59^{1/2} a participant may request that the vested portion of their account be paid to them in one or multiple distributions. Hardship withdrawals are also permitted under the Plan.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded. If a participant stops making payments as required under the terms of the Plan loan agreement, the loan will go into default foreclosure on the loan and attachment of security shall not occur until a distributable event occurs in the Plan. The default generates a taxable event and is reported to the Internal Revenue Service.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions Payable: Amounts totaling \$16,669 and \$10,607 as of December 31, 2024 and 2023, respectively, for employer contributions in excess of amounts allowed by the IRS are recorded as excess contributions payable, with corresponding reductions to employer contributions.

Benefit Payments: Benefits are recorded when paid.

Administrative Expenses: During 2024 and 2023, certain administrative expenses of the Plan were paid directly by the Organization and are excluded from these financial statements.

C. INVESTMENTS (UNAUDITED)

Unaudited Information Certified by the Plan Recordkeeper

The investment activities and balances included on the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the Statements of Changes in Net Assets Available for Benefits for the years then ended, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by the trustee, Hand Benefits & Trust Company in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes total investments of \$50,714,238 and \$42,997,386 and notes receivable from participants of \$304,155 and \$212,207 at December 31, 2024 and 2023, and related investment income of \$6,225,453 and \$6,709,488 and interest on notes receivable from participants of \$14,984 and \$10,849 for the years ended December 31, 2024 and 2023, respectively.

D. FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair values may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodologies are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2

Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

E. PARTY-IN-INTEREST TRANSACTIONS

Total administrative fees paid by the Plan to Hand Benefits & Trust Company, the Plan trustee, amounted to \$148,383 and \$117,481 for the Plan years ended December 31, 2024 and 2023, respectively.

All of these transactions qualify as exempt party-in-interest transactions under ERISA.

F. PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would be 100% vested in their accounts.

G. TAX STATUS

The Plan obtained its latest advisory letter dated March 31, 2017, in which the Internal Revenue Service stated that the form of the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the advisory letter. However, the Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

H. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the value of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of the net assets available for benefits.

The Plan's assets have not been merged into the new plan.
