## Independent Auditors' Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Talen Energy Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

## **Basis for Opinion**

## **Emphasis of Matter - Transfer Into the Plan**

As disclosed in Note 1 to the financial statements, the Talen Montana Legacy Savings Plan and the Talen Montana Savings Plan merged into the Plan, effective December 31, 2024, and all assets were transferred into the Plan. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Talen Energy Retirement Savings Plan's ability to continue as a going concern for at least one year following the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## 1. Description of Plan

The following description of the Talen Energy Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

### General

The Plan, established June 1, 2015, as amended and restated December 31, 2024, is a defined contribution plan sponsored by Talen Energy Supply, LLC (Talen Energy or Company or Plan Sponsor) and designed to comply with the requirements of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, as amended (ERISA) and with the requirements for qualification under Section 401(a) of the Internal Revenue Code (IRC) and includes a cash or deferral arrangement that is intended to comply with the requirements for qualification under Section 401(k) of the IRC, allowing for pre-tax contributions. The Plan is administered by the Talen Energy Retirement Plan Committee (the Plan Administrator).

The Talen Montana Legacy Savings Plan and the Talen Montana Savings Plan merged into the Plan, effective December 31, 2024, and the Plan succeeded to their plan assets.

### Eligibility

Eligibility is open to full-time employees of the following participating companies:

- Talen Energy Marketing, LLC
- Talen Generation, LLC
- Talen Montana, LLC
- Brunner Island, LLC
- Montour, LLC
- Susquehanna Nuclear, LLC
- MC Project Company, LLC
- LMBE Project Company LLC
- Lower Mount Bethel Energy, LLC
- Raven Power Group, LLC
- Morris Energy Operations Company, LLC
- Talen Texas Group, LLC
- MC OpCo, LLC

Participation for bargaining unit employees is controlled by the collective bargaining agreements with the respective unions.

### Contributions

Under the before-tax and/or Roth 401(k) options, participants may elect a percentage reduction in their base earnings and have this salary reduction remitted by Talen Energy to the Plan through payroll deductions. Salaried participants and bargaining unit participants can elect a payroll percentage deduction from 2% to 50%. The sum of the before-tax rate and the Roth 401(k) rate elected by participants may not exceed 50% of participants' compensation. In addition, the Internal Revenue Service (IRS) limits the amount that can be contributed on a before-tax and designated Roth 401(k) basis for any calendar year. The maximum contribution amount under the before-tax option for 2024 was the lesser of 75% of eligible compensation or \$23. Plan participants that are age 50 or older by the end of the year, can make an additional catch-up contribution, the maximum amount of which was \$7.5 for 2024.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Effective January 1, 2024, the Plan amended automatic enrollment to enroll newly eligible participants at 4% for Local 1600 Employees and 6% for all other participants. Contributions of auto-enrolled participants are invested in a default target retirement date fund until changed by the participant. Automatically enrolled participants will have their deferral rate increased annually on April 1 by 1% per year, up to a maximum deferral rate of 10%. The Plan's default investment funds are target date funds based on a participant's date of birth assuming a retirement age of 65. Participants can change the amount they contribute and their investment options at any time.

Effective January 1, 2024, the Plan provides a fixed contribution of 3% of eligible compensation for Local 1600 employees and 2% for all other participant's eligible compensation for each pay period, regardless of any before-tax and/or Roth 401(k) contributions employees elected to make. Additionally, Talen Energy makes a safe harbor matching contribution of 100% of the participant's before tax and/or Roth 401(k) contributions up to 4% of eligible compensation for Local 1600 employees and 6% for all other participant's eligible compensation. Annually, Talen Energy may elect a discretionary matching contribution limited to 4% of eligible compensation contributed to the Plan and a discretionary nonelective contribution for all participants who are not Local 1600 Employees employed on the last day of the plan year. For the year ended December 31, 2024, Talen Energy contributed \$4,548 in discretionary contributions.

Effective December 31, 2024, the Company authorized a one-time additional Company contribution of 2% of eligible compensation on behalf of participants in the Plan, the Talen Montana Savings Plan, and the Talen Montana Legacy Savings Plan. Such Company contributions were deposited into the Plan on March 31, 2025.

## Participant Accounts

Separate accounts are maintained for each participant. Each participant's account is credited with the participant's contributions, Talen Energy's contributions on behalf of the participant and earnings on the participant's investment option. Each participant's account is charged with a quarterly administration fee for recordkeeping and other participant based administration fees. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Participants direct Fidelity Management Trust Company (Fidelity or the Trustee) to invest their contributions and accumulated balances in their accounts into various investment options provided through the Plan's trust (see Note 3).

## Vesting

Participants are vested immediately in all contributions to their account and any earnings thereon.

## Notes Receivable From Participants

The Plan provides for loans to participants, which are secured by the balance in the participant's account. Outstanding loans to a participant are limited to no more than one at any time and are evidenced by a note. The minimum note is limited to \$1 and the maximum available is the lesser of 50% of the participant's vested account balance or \$50 reduced by the highest outstanding loan balance in the prior twelve months. Loans bear interest at a rate established by the Plan Administrator in accordance with applicable law. New loans are generally repaid through payroll deductions within five years from the date of the loan unless for the purchase of a principal residence for which the loan period may not exceed 15 years. Loans may be repaid in full at any time.

## Payment of Benefits

A participant who has retired or whose employment has terminated for any reason may elect to receive a lump sum payment or defer the distribution provided that the participant's account balance exceeds, or exceeded at the time of any prior distribution, \$7. If the participant's account balance is \$7 or less, the participant will receive a single-sum cash payment of the participant's account balance.

In-service withdrawals of all or a portion of a participant's account balance may be made by a participant after reaching age 59½. In-service withdrawals of all or a portion of a participant's rollover account balance may be made at any time.

Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with the provisions specified in the Plan. Hardship withdrawals are strictly regulated by the IRS.

Distributions to participants who terminate service for reasons other than retirement, disability or death are recorded in the period during which service is terminated unless such participants defer the distributions. Single sum distributions for active, retired, deceased, disabled and deferred terminated participants are recorded as paid.

## Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$14 and \$18, respectively, and can be used to reduce future Talen Energy contributions and then to pay plan expenses. For the year ended December 31, 2024, employer contributions were reduced by \$14.

## Revenue Sharing Account

Revenue sharing accounts are used to pay plan expenses or are reallocated to participant's accounts. At December 31, 2024 and 2023, there were \$264 and \$254 of revenue sharing account balances available, respectively. For the year ended December 31, 2024, \$325 of revenue sharing was used to pay plan expenses.

## 2. Summary of Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. ## Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

## Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make note repayments and the Plan Administrator deems the note to be in default, the notes receivable from participant is reduced and a benefit payment is recorded.

## Contributions

Contributions from Plan participants and Employer contributions are recorded in the year in which the employee contributions are withheld from compensation.

## Payment of Benefits

Benefits are recorded when paid.

## Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

## Recent Accounting Standards

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

## Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued, except as follows:

Effective January 1, 2025, participants age 60-63 are eligible to make additional catch-up contributions, up to \$11,250.

## 3. Information Certified by Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the Trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(j) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

## 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market fund is valued at the quoted net asset value (NAV) of shares held by the Plan at year-end.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The common collective trusts are valued at the NAV of units of various bank collective trusts. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of a collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business fashion.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different value measurement at the reporting date.

## 5. Related-Party and Party in Interest Transactions

Certain investments held by the Plan are in mutual funds and a money market fund managed by entities affiliated with Fidelity. Fidelity is the Trustee as defined by the Plan and, therefore, qualifies as a party in interest. The Trustee holds the investments and invests the cash received, interest and dividend income and makes distributions to participants. The participants pay investment and administrative expenses directly in the Plan. No fees were paid by the Plan to the Trustee for the daily operational services of the Plan for the year ended December 31, 2024.

The Plan issues loans to its participants which are secured by the participants' account balance. These transactions qualify as party in interest transactions which are exempt from the prohibited transaction rules.

Certain administrative functions of the Plan are performed by officers or employees of Talen Energy. No such employee receives compensation from the Plan.

## 6. Tax Status

The trust established under the Plan to hold the Plan's assets is qualified pursuant to Section 501(c)(9) of the IRC, and accordingly, the trust's net investment income is exempt from income taxes. Effective January 1, 2022, the Plan was amended and restated to an individually designed plan which mirrored provisions of the previous volume submitter plan. Previously, the Plan adopted a volume submitter plan (VSP) sponsored by Fidelity. Fidelity received a favorable advisory letter from the IRS dated March 31, 2014, in which the IRS stated that plans, such as the Plan, utilizing such VSP form would be deemed in compliance with the applicable requirements of the IRC. Therefore, no provisions for income taxes have been included in the Plan's financial statements. The Plan Administrator, and the Plan's tax counsel believe that the Plan is currently designed in compliance with the applicable requirements of the IRC, and the Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statements date.

U.S. GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

## 7. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, all amounts credited to participants' accounts be distributed to participants, subject to payment of liquidation costs and expenses.

## 8. Risks and Uncertainties

The Plan provides for various investment options that are exposed to various risks, such as interest rate, concentration, market and credit risks. Market risks include global events, such as a pandemic or international conflict, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

## 9. Concentrations

As of December 31, 2024 and 2023, the Plan had investments of \$173,099 and \$174,791, respectively, that were concentrated in two and three different investments, respectively.
