## INDEPENDENT AUDITOR'S REPORT

**NOTE A – SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Presentation:* The Kaspar Companies Employee Benefit Plan Trust (Plan) prepares its financial statements on the modified cash basis of accounting, which differs from U. S. generally accepted accounting principles. Under U. S. generally accepted accounting principles, revenue and the related assets are recognized when earned, and expenses are recognized when obligations are incurred. Under the modified cash basis of accounting, additions to the Plan and the related assets are recognized when collected, and deductions from the Plan are recognized when disbursed, or in certain cases, as the Plan Sponsor becomes aware of the claim.

*Cash:* Cash includes all readily available cash including those accounts with maturities of three months or less.

*Concentrations of Credit Risk:* Financial instruments that potentially subject the Plan to concentrations of credit risk consist principally of temporary cash investments. The Plan maintains cash deposits with banks, which, from time-to-time, may exceed federally insured limits.

*Subsequent Events:* Subsequent events have been evaluated by management through the date the financial statements were available to be issued. Material subsequent events, if any, are disclosed in a separate footnote to these financial statements.

*Use of Estimates:* The preparation of financial statements in conformity with the modified cash basis of accounting principles requires estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

**NOTE B – PLAN DESCRIPTION**

The following description of the Kaspar Companies Employee Benefit Plan Trust provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

*General:* The Plan provides benefits covering substantially all employees of the following: Kaspar Companies, Inc. (the Plan Sponsor), Kaspar Die and Tool, Inc.; Kaspar Electroplating Corporation; Kaspar Properties, Inc.; Sho-Rack Service Center, Inc.; Kaspar Texas Traditions, Kaspar Land Traditions, LP; Texas Precious Metals LLC; PM Web Assets LLC; Trailboss Equipment, LLC; Espresso LLC; Kaspar Wire Works, Inc; Truckfitters LLC; Ratliff Traditions, LLC; Texas Ammunition LLC, Kaspar Trucking LLC, and Welhausen Legacy LLC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Contributions:* The Plan agreement provides that the Plan Sponsor and the participants make contributions to the Plan from time to time and in such amounts as to provide benefits under the Plan determined by the application of accepted actuarial methods and assumptions. The method of funding shall be consistent with the Plan objectives.

**NOTE B – PLAN DESCRIPTION – continued**

*Benefits:* The Plan provides health benefits (major medical, short-term disability, and death) covering substantially all full-time employees of the Plan Sponsor with one month of service. Benefit obligations in excess of the net assets available for benefits are absorbed by the Plan Sponsor. The Sponsor has in place a specific stop loss policy for any medical claim over \$125,000 per policy year in 2024 and 2023. The Plan had recoveries under the stop loss agreement of \$246,459 in 2024 and \$125,053 in 2023.

*Termination:* Although it has not expressed intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

**NOTE C – FEDERAL TAX STATUS**

The trust established under the Plan to hold the Plan's net assets is qualified pursuant to Section 501(c)9, and accordingly, the trust's net income is exempt from income taxes. The Plan Sponsor has not obtained a tax determination letter from the Internal Revenue Service. However, the Plan Sponsor believes that the trust qualifies for tax exemption as designed. The Plan did not complete non-discrimination testing for the year ended December 31, 2024, although it did complete it for the year ended December 31, 2023; however, the Trustees believe the Plan was in full compliance with such laws and regulations in 2024. Management is not aware of any tax positions that would have a significant impact on its financial position. Its federal tax returns for the last four years remain subject to examination. The Plan is not subject to the Texas margin tax.

**NOTE D – TRANSACTIONS WITH PARTIES-IN-INTEREST**

The Plan's administrative expenses are paid either by the Plan or the Plan Sponsor as allowed by the Plan document. Expenses paid directly by the Plan Sponsor are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits – modified cash basis.

**NOTE E – RETIREMENT BENEFIT OBLIGATIONS**

The Plan presents its financial statements on the modified cash basis of accounting. Accordingly, claims payable (claims in-house), as well as claims incurred but not reported (IBNR) are not included in the statement of net assets available for benefits – modified cash basis.
