Note 1. Description of the Plan

The following description of the Prisma Health 401(a) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a 401(a) defined contribution plan covering substantially all employees of Prisma Health - Upstate (the "Employer") who are not considered independent contractors and are not employed by Greenville Health Authority or Richland Memorial Hospital. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan administrator has obtained certifications from Empower Retirement, LLC (Empower, the "trustee"), as well as Empower Annuity Insurance Company of America (EAICA) and The Variable Annuity Life Insurance Company (VALIC) (collectively, the custodians"). The trustee and custodians meet the definition of qualified institutions as defined in 29 CFR 2520.103-5 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA.

Contributions:

Each year, participants are eligible to receive a nonelective contribution from the Employer based on a participant's hours worked during the Plan year. Participants direct the investment of these contributions into various investment options offered by the Plan. The nonelective Employer contribution is calculated as a percentage of a participant's eligible compensation, set at 3 percent for participants regardless of their age and years of service. During the year ended December 31, 2024, the Employer made \$62,109,637 in contributions to the Plan. The Employer may elect to make matching contributions to the Plan based on participants' contributions to a 403(b) Plan sponsored by the Employer. During the year ended December 31, 2024 the Employer did not elect to make any matching contributions. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant accounts:

Each participant's account is credited with the Employer's nonelective and matching contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Fees are charged on a per account basis, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Vesting in the Employer's nonelective contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested in their nonelective contributions after 3 years of credited service. A participant is 100 percent vested in their matching contributions immediately if they participate in the 403(b) Plan mentioned above.

Note 1. Description of the Plan, Continued

Notes receivable from participants:

The Plan was amended October 1, 2010, to no longer allow participants to apply for loans from their account. Any plan loan as of October 1, 2010 shall remain outstanding and repayable in accordance with its promissory note. The Plan was amended again, effective January 1, 2019, stating that any plan loan as of February 1, 2019 that originated from the Baptist Easley Hospital Matching Savings 401(k) Plan (the "Baptist Easley 401(k) Plan") and Greenville Health System 401(k) Savings Plan (the "Greenville Health 401(k) Plan") shall remain outstanding and repayable in accordance with its promissory note, except that upon termination of service on or after February 1, 2019 for former Baptist Easley 401(k) Plan participants and March 1, 2019 for former Greenville Health 401(k) Plan participants, the Employer can continue to accept loan repayments via coupon payments.

Payment of benefits:

On termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or the installment options as provided by the Plan. All fully vested balances are available for distribution after the participant reaches the age of 59½.

Forfeited accounts:

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,354,139 and \$8,831,824, respectively. These accounts will be used to reduce future Employer contributions or to reduce administrative expenses. During 2024, Employer contributions were reduced by \$7,834,787 from forfeited nonvested accounts.

Note 2. Summary of Significant Accounting Policies

Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein. Actual results could differ from those estimates.

Contributions:

Contributions from the Employer are recorded in the year in which they are earned.

Note 2. Summary of Significant Accounting Policies, Continued

Investment valuation and income recognition:

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Defined Contribution Retirement Plans Administrative Committee of Prisma Health and Affiliate Organizations determines the Plan's valuation policies utilizing information provided by the investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of benefits:

Benefits are recorded when paid.

Expenses:

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and other distributions to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Revenue sharing:

Revenue sharing provides a way to use a portion of a plan's investment fees to pay for plan services, such as recordkeeping or administrative costs. The revenue sharing amounts have been recorded in the statement of changes in net assets available for benefits as other income.

Subsequent events:

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

Recently issued accounting pronouncements:

Accounting standards that have been issued or proposed by the Financial Accounting Standards Board (FASB) or other standards-setting bodies are not expected to have a material impact on the Plan's financial statements.

Note 3. Certifications

The trustee and custodians also certified to the completeness and accuracy of \$97,908,306 of net appreciation in fair value of investments and \$18,442,709 of interest and dividends, as well as \$42,874 of interest on notes receivable from participants for the year ended December 31, 2024.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust funds and pooled separate account: Valued at NAV. The NAV, as provided by the investment managers, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of a fund, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidation will be carried out in an orderly business manner.

Note 5. Fully Benefit-Responsive Investment Contracts

The Plan invests in the Prisma Stable Value Fund and group annuity contracts which are types of guaranteed investment contract, with EAICA of \$110,430,830 and \$120,185,566 at December 31, 2024 and 2023, respectively, and with VALIC of \$10,456 and \$9,340 at December 31, 2024 and 2023, respectively. EAICA and VALIC maintain the contributions in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rates are based on a formula established by the contract issuers but may not be less than one percent. The crediting rates are reviewed on a semi-annual basis for resetting at EAICA and reviewed on a quarterly basis for resetting at VALIC. The guaranteed investment contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity dates.

Note 5. Fully Benefit-Responsive Investment Contracts, Continued

These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by EAICA and VALIC, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents including complete or partial plan termination or merger with another plan, (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Such events include the following: (a) an uncured violation of the Plan's investment guidelines, (b) a breach of material obligation under the contract, (c) a material misinterpretation, or (d) a material amendment to the agreements without the consent of the issuer.

Note 6. Related-Party and Party in Interest Transactions

Certain Plan investments are managed by EAICA and VALIC, the custodians as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments to the third-party administrator totaling \$300,697 which were not covered by revenue sharing. The Employer pays directly any other fees related to the Plan's operations.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their nonelective Employer contributions.

Note 8. Tax Status

The Employer has adopted a pre-approved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although, the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax provisions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.

Note 11. Subsequent Events

Effective January 1, 2025, the Plan was amended for the following changes: exclude PRN employees whose regularly schedule service is less than 1,000 hours of service in the relevant eligibility computation period for nonelective contributions; require 1 year of service (defined as 1,000 hours of service) to be eligible to receive nonelective contributions; change the entry date for eligibility to receive nonelective contribution from immediate to semi-annually; and to modify nonelective contribution allocation conditions.
