The Financial Statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the Financial Statements (2024 Financial Statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 Financial Statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of December 31, 2024 and for the year then ended, stating that the certified investment information, as described in Note 3 to the Financial Statements, is complete and accurate.

Their report dated September 27, 2024, indicated that (a) the amounts and disclosures in the 2023 Financial Statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with U.S. GAAP,

and (b) the information in the 2023 Financial Statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedules other than the information in the 2023 supplemental schedules that agreed to or are derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or are derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

### Note 1 - Description of plan:

The following description of the GreenSky Trade Credit, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan sponsor is GreenSky Trade Credit, LLC (Plan Sponsor and Plan Administrator). The Plan is a defined contribution plan covering substantially all employees of participating subsidiaries of GreenSky, LLC, (collectively referred to as the Company), who are age 21 or older. Upon attaining the eligibility requirements of the Plan, full-time or part time employees are immediately eligible to enter and make contributions to the Plan when they join the Company or its affiliates as eligible employees. In addition, participants become eligible to receive employer contributions as of the first day of the month following hire date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Board of Directors (the Board) is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

On March 15, 2024, Goldman Sachs Group, Inc. finalized the sale of GreenSky Holdings, LLC and its subsidiaries, including GreenSky LLC, to a consortium of institutional investors led by Sixth Street, a global investment firm with over \$74 billion in assets under management. The consortium also consists of funds and accounts managed by KKR, Bayview Asset Management, and CardWorks. As a result of this transaction, certain employees of GreenSky, LLC became eligible to roll over their balances into the Plan. Investment and loan balances related to these participants who elected to participate in the Plan are recorded in rollovers for the Plan year ended December 31, 2024.

#### Contributions

Participants can contribute pre-tax and after-tax contributions up to 100% of their eligible compensation, as defined in the Plan document, limited by the amount allowed under the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Upon becoming eligible to participate in the Plan, participants are automatically enrolled in the plan. The Company automatically withholds 6% of a participant's eligible compensation enrollment in the Plan, unless the participant elects to not participate in the plan or elects to withhold a different percentage. Participants may change their investment options at any time.

#### Contributions - continued

The Company may make discretionary matching contributions and in prior years has contributed an amount to participant accounts annually, in the first quarter of the following year, generally 100% of a participant's payroll deferral contribution up to 6% of compensation, capped at a maximum match of \$12,500. If an eligible participant's compensation is less than \$125,000, the Company will also allocate to that eligible participant's account an additional contribution equal to 2% of compensation. Effective March 15, 2024, the Company began contributing discretionary matching contributions each pay period in an amount equal to 100% of participant's payroll deferral contributions up to 4.5% of eligible compensation.

#### Participant accounts

Each participant's account is credited with the participant's contributions and Company discretionary matching contributions and Plan earnings based on the participant's specific investments and account balances. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances or specific participant requested transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

#### Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Company discretionary matching contributions vest 100% after the completion of two years of continued service, as defined by the Plan document. Participants become 100% vested in Company discretionary matching contributions, regardless of the length of vesting service, upon retirement, disability or death.

#### Forfeited accounts

Forfeitures of terminated participants' non-vested accounts are used to reduce the Company's contributions and/or pay Plan expenses for the Plan year. The Plan used forfeitures of \$115,288 to reduce employer contributions during the year ended December 31, 2024. The Plan also used \$36,015 during the year ended December 31, 2024 to reduce administrative expenses. The unallocated forfeited non-vested account balances were \$422,465 and \$285,064 as of December 31, 2024 and 2023, respectively.

#### Payment of benefits

A participant is entitled to receive a lump-sum amount equal to the vested value and net earnings thereon of his or her account upon attainment of age 59½, retirement, death, disability, or termination of service at the Company. A participant may request a withdrawal from the Plan while still under employment of the Company for reasons of financial hardship. Financial hardship distributions may only be taken from a participants' deferral contribution account.

If a participant's vested account balance exceeds \$5,000, a participant may elect to receive a lump-sum distribution or to remain in the Plan. If the vested account balance is less than \$5,000 but more than \$1,000, the plan administrator will distribute the participant's entire vested account balance, either as a lump-sum distribution, or as a direct rollover to an individual retirement account or another employer's tax-qualified plan. If the vested account balance is less than \$1,000, the Plan administrator will distribute the participant's entire vested balance as a lump-sum distribution as soon as administratively feasible.

#### Notes receivable from participants

Participants may borrow from the Plan in any amount greater than \$1,000 up to 50% of the participant's vested account balance, not to exceed \$50,000. Note terms are for a period not exceeding five years unless for the purchase of a principal residence, in which case the note repayment period may be extended by the Plan Administrator. Notes are secured by the vested balance in the participant's account and bear interest at rates established by the Company, which are generally commensurate with the U.S. prime interest rate plus 1%. Principal and interest is paid ratably through payroll deductions.

### Note 2 - Summary of accounting policies:

#### Basis of accounting

The financial statements of the Plan are prepared under the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

#### Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) include the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Contributions

Contributions from Plan participants and Company discretionary matching contributions are recognized when received by the trustee, Fidelity Management Trust Company (Fidelity).

#### Payment of benefits

Benefits are recorded when paid.

#### Administrative expenses

All administrative expenses and recordkeeping fees are paid by the Plan and are either charged to the participants' accounts or paid out of the forfeitures account. Investment related expenses are included in net appreciation of fair value of investments.

#### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make note repayments and the Plan Administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded.

#### Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate risk, market risk, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value

of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

#### Recent accounting pronouncements

The AICPA Financial Reporting Executive Committee (FinREC) approved enhanceive accounting updates related to accounting for revenue sharing arrangements in accordance with Financial Accounting Standards Board (FASB) ASC No. 606, Revenue from Contracts with Customers. Revenue sharing amounts are not considered revenue under ASC No. 606 due to the fact that they are intended to reduce administrative costs for the plan and not paid to the plan for delivering or producing goods, rendering services or undertaking other activities for the investment manager. A plan should consider all relevant facts and circumstances, including the terms of the agreement to determine the appropriate presentation of revenue sharing amounts. The presentation should be applied on a consistent basis and the plan should consider whether the presentation of revenue sharing amounts is a significant accounting policy that should be disclosed in the notes to the financial statements. If significant, the notes to the financial statements include a description of revenue sharing arrangements including how such arrangements are presented in the financial statements. The adoption did not have a material impact to the Plan's financial statements.

#### Recent legislative developments

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the years ended December 31, 2024 and 2023. Plan management continues to evaluate the impact of the optional provisions of SECURE 2.0 and is awaiting additional regulatory guidance from the Internal Revenue Service (IRS) and Department of Labor. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements for the plan years ended December 31, 2024 and 2023.

The Plan Sponsor has operationally implemented and amended the Plan for various changes in accordance with IRS guidelines.

##### Subsequent events

The Plan has evaluated subsequent events through October 15, 2025, which is the date these financial statements were available to be issued. All subsequent events, if any, requiring recognition as of December 31, 2024, have been incorporated into these financial statements.

#### Note 3 - Information certified by the Fidelity:

As trustee, Fidelity holds the Plan's investment assets and executes transactions. Management has determined that Fidelity is a qualified institution and the information prepared and certified by Fidelity meets the requirements of ERISA Section 103(a)(3)(C). Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and was certified as complete and accurate by Fidelity.

#### Note 4 - Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB Accounting Standards Codification 820 are described as follows:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2      Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Mutual funds (or shares of registered investment companies) are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Money market funds are valued at the daily closing price as report by the fund. The money market fund is an open-end mutual fund that is registered with the SEC. This fund is required to publish its daily NAV and to transact at that price. The money market fund is deemed to be actively traded.

The methodologies described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Note 5 - Related party and party-in-interest transactions:

Certain Plan investments are shares of mutual funds and a money market fund managed by an affiliate of the trustee of the Plan. Fidelity is the trustee as defined by the Plan and; therefore, these transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of registered investment companies. Notes receivable from participants also qualify as party-in-interest transactions and are exempt from the prohibited transaction rules.

#### Note 6 - Plan termination:

The Company has the right under the Plan, although it has not expressed any intent to do so, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of discontinuance of the Plan, all participants' accounts become fully vested.

#### Note 7 - Tax status:

The Plan uses a pre-approved plan document sponsored by Fidelity Management and Research Company. Fidelity Management and Research Company received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved plan document satisfies the provisions, as then designed, under Section 401(a) of the IRC and; therefore, the related trust is tax-exempt. The Plan has been amended since the pre-approved plan document received the IRS opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 8 - Reconciliation of financial statements to Form 5500:

There are no reconciling items between the Plan's financial statements and the Form 5500 as of December 31, 2024 and 2023.
