For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE 1 - PLAN DESCRIPTION

The following description of The Beech-Nut Nutrition Company Employees' Savings Plan ("the Plan") is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General: The Plan is a contributory savings plan, which covers substantially all non-union and union employees of The Beech-Nut Nutrition Company ("the Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Employees are eligible to participate in the Plan after 3 months of service with the Company. Employees enter the Plan on the first day of each month following satisfaction of the eligibility requirements.

Contributions: Participants may defer up to 60% of eligible compensation, as defined in the Plan, subject to applicable Internal Revenue Code ("IRC") limitations. The Plan includes an automatic salary deferral percentage of 3% unless otherwise changed by participants for non-union employees. In addition, the Plan has an automatic increase feature in which those non-union participants' contribution rates are automatically increased by 1% annually on February 28, up to a maximum of 8%. Participants may opt out of this feature at any time. Participants who have attained the age of 50 before the close of the plan year are allowed an additional catch-up contribution. Participants may also roll over distributions from other qualified defined benefit or contribution plans. The Company matches 50% of the first 8% of eligible compensation contributed by participants other than those covered by a collective bargaining agreement. Additionally, the Plan allows for discretionary match and profit-sharing contributions by the Company. There were no discretionary contributions during 2024.

Participant Accounts: Each participant's account is credited with the participant's contributions, Company contributions, if eligible, and allocations of Plan earnings, and is charged with an allocation of certain trustee fees and other investment-related expenses. Allocations are based on participant deferrals and account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any investment option in the Plan and may change the mix of investments on a daily basis.

Vesting: Participants are immediately vested in their salary deferral contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contributions is based on years of service. Vesting occurs ratably over five years, beginning after one year of service, with full vesting after five years of service.

Forfeitures: Forfeitures of employer contributions and the earnings on those contributions resulting from participants who leave the Company prior to vesting are retained in an unallocated forfeiture account. The Company may use forfeitures to pay any administrative expenses and to offset any employer contributions. During 2024, approximately \$49,000 of forfeitures were used to reduce employer contributions. At December 31, 2024 and 2023, the forfeiture account totaled approximately \$48,000 and \$49,000, respectively.

Payment of Benefits: After attaining age 59½, participants may withdraw funds while still employed. Hardship withdrawals are allowed. Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum amount or installments under a systemic withdrawal plan equal to the value of the participant's vested interest in his or her account.

Notes Receivable from Participants: Participants may borrow from their fund accounts up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Note terms range from one year to five years or for a reasonable term exceeding five years where the note is used for the purchase of a primary residence. The notes are collateralized by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by the Plan sponsor. Principal and interest is paid ratably through monthly payroll deductions.

Administrative and Investment Management Expenses: The Plan's trustee fees are paid by the Plan and are reflected in the financial statements as administrative fees of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in interest and dividends in the accompanying financial statements. All other expenses of the Plan are paid by the Company.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The principles and policies that significantly affect the determination of net assets available for benefits and results of operations are summarized below.

Basis of Accounting: The accounting principles and procedures followed by the Plan conform to accounting principles generally accepted in the United States of America. The financial statements of the Plan are prepared under the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on an accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan provides for various investment options in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, liquidity and credit risks. Because of the level of risk associated with certain investment securities and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participants' individual account balances.

NOTE 3 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

NOTE 4 - INVESTMENTS

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Self-directed brokerage accounts: Accounts consist primarily of investments in common stock. Fair values are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - TAX STATUS

The Internal Revenue Service has determined by a letter dated June 30, 2020 that the non-standardized pre-approved plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since the adoption of the non-standardized pre-approved plan; however, plan management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of December 31, 2024 and 2023.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Certain Plan investments are shares in registered investment companies managed by Fidelity Investments, Inc., an affiliate of Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee of the Plan, and therefore, these investments qualify as party-in-interest investments. Notes receivables to the Plan's participants are also considered party-in-interest transactions. In addition, fees for the year ended December 31, 2024 were paid by the Plan for various administration services and are considered party-in-interest transactions.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and its related regulations. In the event of the Plan's termination, participants will become 100% vested in their accounts.

NOTE 8 - SUBSEQUENT EVENTS

Plan management has evaluated subsequent events for recognition and disclosure through October 15, 2025, which is the date the financial statements were available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE 1 - PLAN DESCRIPTION

The following description of The Beech-Nut Nutrition Company Employees' Savings Plan ("the Plan") is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General: The Plan is a contributory savings plan, which covers substantially all non-union and union employees of The Beech-Nut Nutrition Company ("the Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Employees are eligible to participate in the Plan after 3 months of service with the Company. Employees enter the Plan on the first day of each month following satisfaction of the eligibility requirements.

Contributions: Participants may defer up to 60% of eligible compensation, as defined in the Plan, subject to applicable Internal Revenue Code ("IRC") limitations. The Plan includes an automatic salary deferral percentage of 3% unless otherwise changed by participants for non-union employees. In addition, the Plan has an automatic increase feature in which those non-union participants' contribution rates are automatically increased by 1% annually on February 28, up to a maximum of 8%. Participants may opt out of this feature at any time. Participants who have attained the age of 50 before the close of the plan year are allowed an additional catch-up contribution. Participants may also roll over distributions from other qualified defined benefit or contribution plans. The Company matches 50% of the first 8% of eligible compensation contributed by participants other than those covered by a collective bargaining agreement. Additionally, the Plan allows for discretionary match and profit-sharing contributions by the Company. There were no discretionary contributions during 2024.

Participant Accounts: Each participant's account is credited with the participant's contributions, Company contributions, if eligible, and allocations of Plan earnings, and is charged with an allocation of certain trustee fees and other investment-related expenses. Allocations are based on participant deferrals and account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any investment option in the Plan and may change the mix of investments on a daily basis.

Vesting: Participants are immediately vested in their salary deferral contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contributions is based on years of service. Vesting occurs ratably over five years, beginning after one year of service, with full vesting after five years of service.

Forfeitures: Forfeitures of employer contributions and the earnings on those contributions resulting from participants who leave the Company prior to vesting are retained in an unallocated forfeiture account. The Company may use forfeitures to pay any administrative expenses and to offset any employer contributions. During 2024, approximately \$49,000 of forfeitures were used to reduce employer contributions. At December 31, 2024 and 2023, the forfeiture account totaled approximately \$48,000 and \$49,000, respectively.

Payment of Benefits: After attaining age 59½, participants may withdraw funds while still employed. Hardship withdrawals are allowed. Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum amount or installments under a systemic withdrawal plan equal to the value of the participant's vested interest in his or her account.

Notes Receivable from Participants: Participants may borrow from their fund accounts up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Note terms range from one year to five years or for a reasonable term exceeding five years where the note is used for the purchase of a primary residence. The notes are collateralized by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by the Plan sponsor. Principal and interest is paid ratably through monthly payroll deductions.

Administrative and Investment Management Expenses: The Plan's trustee fees are paid by the Plan and are reflected in the financial statements as administrative fees of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in interest and dividends in the accompanying financial statements. All other expenses of the Plan are paid by the Company.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The principles and policies that significantly affect the determination of net assets available for benefits and results of operations are summarized below.

Basis of Accounting: The accounting principles and procedures followed by the Plan conform to accounting principles generally accepted in the United States of America. The financial statements of the Plan are prepared under the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on an accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan provides for various investment options in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, liquidity and credit risks. Because of the level of risk associated with certain investment securities and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participants' individual account balances.

NOTE 3 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

NOTE 4 - INVESTMENTS

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Self-directed brokerage accounts: Accounts consist primarily of investments in common stock. Fair values are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - TAX STATUS

The Internal Revenue Service has determined by a letter dated June 30, 2020 that the non-standardized pre-approved plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since the adoption of the non-standardized pre-approved plan; however, plan management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of December 31, 2024 and 2023.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Certain Plan investments are shares in registered investment companies managed by Fidelity Investments, Inc., an affiliate of Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee of the Plan, and therefore, these investments qualify as party-in-interest investments. Notes receivables to the Plan's participants are also considered party-in-interest transactions. In addition, fees for the year ended December 31, 2024 were paid by the Plan for various administration services and are considered party-in-interest transactions.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and its related regulations. In the event of the Plan's termination, participants will become 100% vested in their accounts.

NOTE 8 - SUBSEQUENT EVENTS

Plan management has evaluated subsequent events for recognition and disclosure through October 15, 2025, which is the date the financial statements were available to be issued.
