

Notes to Financial Statements

1. **Description of the Plan** The following description of the P E Systems, Inc. 401(k) and Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of P E Systems, Inc. (the "Company"), except for employees covered by a collective bargaining agreement, leased employees, nonresident aliens, residents of Puerto Rico and interns. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

On November 4, 2024, the Plan changed custodians from Empower Trust Company, LLC to Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company ("Principal"). As part of this transition, all Plan investments were liquidated by Empower Trust Company, LLC and transferred to Principal. Notes receivable from participants were also transferred to Principal effective with the change in custodians.

Contributions: Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan. Roth contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Plan allows for automatic enrollment. Any newly eligible employee who has not affirmatively elected to contribute to the Plan or has not affirmatively declined to participate in the Plan will be automatically enrolled in the Plan with a one percent withholding of pretax annual compensation. The Plan allows for discretionary matching contributions. During 2024, the Company contributed 50 percent of the first six percent of compensation that a participant contributed to the Plan from January 1, 2024 through January 19, 2024. The Company contributed 100 percent of the first four percent of compensation that a participant contributed to the Plan from January 20, 2024 to December 31, 2024. Discretionary non-elective contributions may be contributed at the discretion of the Company. There were no such contributions for the Plan year ended December 31, 2024. Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

P E Systems, Inc. 401(k) and Profit Sharing Plan

Notes to Financial Statements

Participant accounts: Each participant's account is credited with the participant's contributions, the Company's discretionary matching contributions, if any, as well as allocations of the Company's discretionary non-elective contribution, if any, and Plan earnings. Participant accounts may also be charged with an allocation of certain administrative expenses. Investment earnings and losses are allocated based upon the investment performance of each investment in the participant's account. Any allocations of the Company's discretionary non-elective contributions are based on a grouping methodology whereby, each participant constitutes a separate group. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are vested immediately in all contributions plus actual earnings thereon.

Payment of benefits: Benefits are payable upon retirement at age 65, early retirement at age 59 1/2, disability, death, or termination of employment. Hardship withdrawals and in-service withdrawals at age 59 1/2 are also permitted, subject to provisions described in the Plan document. Withdrawals from rollover contributions are permitted at any time. Benefits are paid in lump sum payments only, except for participants who received installment payments prior to June 2017. These participants may continue to receive their benefits in installment payments.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or longer for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the Wall Street Journal prime rate in effect at inception of the loan plus one percent. Principal and interest are paid through payroll deductions.

Administrative expenses: Certain expenses of maintaining the Plan are paid by the Company. Transaction expenses, such as loan, distribution, and inactive account administration fees, are charged directly to the participant's account and are included in administrative expenses. Participants are also charged an asset based fee for recordkeeping and management services. These fees are included in administrative expenses.

2. Significant accounting policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Notes to Financial Statements

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment valuation and income recognition: Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are reclassified as distributions based upon the terms of the Plan document.

Contributions: Participant contributions and the related Company discretionary matching contributions, if any, are recognized in the period the participant contribution is withheld from compensation. Company discretionary non-elective contributions, if any, are recognized in the period the eligible compensation was paid to the participant.

Payment of benefits: Benefits are recorded when paid.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent events: The Plan has evaluated subsequent events for disclosure in these financial statements through October 15, 2025, which is the date the financial statements were available to be issued.

3. Certified information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income from notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, Empower Trust Company, LLC, and Empower Annuity Insurance Company of America, the trustees and insurance company of the Plan.

4. Fair value measurements

The Plan reports its assets at fair value based on a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The fair value of the shares of mutual funds owned by the Plan is based on quoted net asset values on the last business day of the Plan year.

The fair value of the units of pooled separate accounts is based on the net asset value ("NAV") on the last business day of the Plan year provided by the entity holding the accounts. The NAV is used as a practical expedient to estimate fair value and is determined by the insurance company based on the fair value of the underlying assets in the account, less the liabilities.

The fair value of the collective trust funds is based on the NAV on the last business day of the Plan year provided by the entity holding the trust funds. The NAV of the collective trust is used as a practical expedient to estimate fair value and is determined by the fund trustee based on the fair value of underlying assets in the trust, less its liabilities.

Bond accounts seek a consistent return through bond investments.

Investments in all collective trust funds (\$557,484 and \$0 at December 31, 2024 and 2023, respectively) can be redeemed immediately at the current net asset value based on the fair value of the underlying assets. There are no withdrawal limits, redemption frequency limits or redemption notice periods. Investments in all pooled separate accounts (\$7,960,274 and \$23,079,541 at December 31, 2024 and 2023, respectively) can be redeemed immediately at the current net asset value based on the fair value of the underlying assets. There are no withdrawal limits, redemption frequency limits or redemption notice periods for the pooled separate accounts. There were no unfunded commitments for these investments as of December 31, 2024 and 2023.

- 5. Guaranteed interest contract**
- The Plan participated in a traditional benefit responsive investment contract with Empower Annuity Insurance Company of America ("Empower"). Empower maintained the contributions in a separate account with a general investment account guarantee. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Empower was contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct withdrawals or transfer all or a portion of their investment at contract value. This contract was terminated effective with the change in custodians to Principal.
- The Plan participates in a traditional benefit responsive investment contract with Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company via an investment in a Guaranteed Investment Contract ("GIC"). Principal commingles the assets of the GIC with other assets in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Principal is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct withdrawals or transfer all or a portion of their investment at contract value.
- There are no reserves against contract value for credit risk of the contract issuer or otherwise. No events limit the ability of the Plan to transact at contract value.
- 6. Risks and uncertainties**
- The Plan provides for investments in various securities that are exposed to risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in future statements of net assets available for benefits.
- 7. Plan termination**
- Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

8. Party-in-interest transactions Certain Plan investments are managed by affiliates of Empower and Principal. Empower and Principal are the custodians and recordkeepers as defined by the Plan. During 2024, the Plan paid Empower, Principal, and other service providers for recordkeeping and other services. These transactions qualify as exempt party-in-interest transactions.

9. Tax status The Plan is a pre-approved plan of Retirement Planners and Administrators, Inc. which received an opinion letter on June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the form of the plan document was acceptable under the applicable requirements of the Internal Revenue Code ("IRC"). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

11. Subsequent events

Effective January 1, 2025, the Plan was amended and restated to adopt a pre-approved defined contribution plan of Principal Life Insurance Company (the "January Restatement"). Effective with the January Restatement, employees are required to attain an age 21 to become eligible to participate in the Plan. The January Restatement increased the deferral percentage that participants are autoenrolled into the Plan from one percent to three percent of pretax annual compensation. The discretionary matching contribution was eliminated and a safe harbor matching contribution of 100 percent of the first four percent of compensation that a participant contributed to the Plan was added effective with the January Restatement. Additionally, the Plan no longer permits early retirement withdrawal and the maximum loan term for the purchase of a primary residence became ten years. Lastly, the January Restatement provided for the merger of IDEAMATICS 401(k) Retirement Plan into the Plan. All net assets of the IDEAMATICS 401(k) Retirement Plan totaling approximately \$2.9 million were transferred into the Plan during January 2025.
